“Community Awareness: Canton Fire Department”

Recently I met with Nate Laubach and Devon Chauk, to talk with them about the fire department’s new sign they have outside of the fire station. The categories are based on the National Fire Danger Rating system: low fire danger, moderate fire danger, high fire danger, and extreme fire danger.

Low fire danger would indicate that fires would not start easily unless there is an added heat source such as lightning. Grass fires may burn for a few hours after rain, but wood fires will spread slowly. Most fires on low danger days are easily controlled. Moderate fire danger would indicate that accidental fires are more likely than on a low danger day. If there is a grassland fire and it is windy, it will spread very quickly, whereas wood fires would spread slowly. Moderate fires are usually easy to control. High fire danger would indicate that fires are able to start easily. If you are camping and have a fire, they could become uncontrollable. These fires can become difficult to contain unless put out while they are still small. Extreme fire danger fires start quickly and easily. These fires burn intensely and can spread very quickly. Small fires can turn into big fires rapidly on these days and can last for several days. If the sign indicates that it is an extreme fire danger, the fire department will hang up the “Fire Ban” flag and add the “Fire Ban-No Burning” addition to the bottom of the sign.

The fire department added this addition for community awareness in the area. Not only just for Canton residents, but anyone driving through town who may see the sign. There is the wildlands presence in the area with Newton Hills not far from town to protect. People camping at Newton Hills may drive through town, see the sign and think again about how big they will make their campfire. They want to protect Canton, the rural community, and help prevent fire danger. The Canton fire department covers 160 square miles of rural area.

Nate and Devon also talked with me about



spreading the word on a new app they would like people to download onto their phone or tablets. The “MyLS” app connects emergency service providers and their community members. Users can add as little or as much information as they want. This app is for homeowners as well as business owners. As a user you can add floorplans of your home or business, info on how many people or pets are in the home, or where gas turn offs may be. The app also will update if there are any things going on in the area and to keep the area safe so people are aware of their surroundings if there is a fire. It will also update users on things going on in the area, such as the hydrant party they recently had. It will help community members and also help the fireman know what they may be going into during a call. Most departments in the area have this app for responding. If users work out

of town or are out of town on vacation, this tool helps to give firemen a way to contact the owners of homes or businesses. The information added to accounts is private and only accessed by Fire Ground officers that are at the scene. This is something the fire department has paid for because they believe it will be a good tool for community awareness. If Canton gets enough users, the police department can also contribute to the app with information as well. The code to search for the Canton fire department on the app is 421742. The Canton Fire Department has had this app going for about 6 weeks, and would really like to see the number of users go up in the next few months.

Thank you to the Canton Fire Department and all they do to protect our community here in the Canton area!

FAMILY REUNION

He was born and baptized in Oppdal, but it was only when he left for the USA to study medicine that Tore Detlie (70) discovered how big his family was that had emigrated to America. More about that farther down in the case.

When OPP asks 88-year-old Helen Rowe what makes her pay for the barbecue party with food and drinks for the 60 or so people who have turned up for the family gathering, she says:

“Family means everything to me, and the Norwegian relatives have been very important to me. My grandmother, Marit H. Detlie, came over from Oppdal to America 20 years ago (year 1900) to visit her uncle Stein Detli. He ran a carriage business in Sioux Falls, South Dakota, and brought his two

brothers with him.”
Marit Detlie is the daughter of Marit Kristoffersdatter Klett who married Halvor Olsen Detlie in 1868. He had taken over the farm Detlia pa, Lønset after his parents in October 1873.

The couple had children, Ole (1869), Steingrim (1871), Sigrid (1873), Dorthea (1875), Sivert (1877), Gjertrud (1879), Marit (1881), Halvor and Christian (1883), Hanna and Margrethe (1884), Martin (1886) and Margrethe (1888).

Helen Rowe says that her grandmother, Marit, who had thus been given her mother’s name, married on 17 May in 1902, two years after she came to the USA with Hjalmar August Anderson. He was also Norwegian and came from Christiania. The couple had three children, Marcella (b.1903), Helen and Harvey.

Strong Ties

Helen Rowe is the daughter of Marcella, and already in her early years, Helen was made aware that



she belonged to a family with strong family ties. She tells OPP that she was not the only girl when her mother told her about her origins and her Norwegian ancestry in Norway and Oppdal.

“Mother loved the Detli family. Eight of them had survived, four remained in Norway, and four came to America. I’ve met someone from all eight families, so I have heard stories about Norway all my life.”

Rowe briefly tells how this familiarity gradually strengthened. It began in connection with the mother’s cousin, Oppdal-born Tore Detlie’s father, Harald S. Detlie (born in Sesaker in Oppdal in 1910) was coming over from Oppdal to the USA for a visit.

“Then I told my mother that I would arrange a dinner party if she would invite all the relatives who came from the Detli people. So, seven cousins were born in America, moved up with their families, Helen said, adding that

this was the beginning of a good relationship with the relatives and eventually also Tore Detlie, who had come with his father to the USA from Oppdal.

This was also a return visit after Helen and her husband had visited Oppdal, and at the same time Tore and his father made the trip as the son had wanted to study in the USA.

Helen Rowe says that she obviously thought this was funny, and tells OPP that she got involved in the case.

“I asked him what he wanted to do, and he said he wanted to study in the United States. We mentioned that Augustana University loved Norwegians, so he went there. And there it turned out that the man who was in charge of the studies turned out to be from Oppdal, and his name was Mellemseter!”

Tore Detlie, who is now a retired doctor, got a scholarship and a place on the studies.

Heather Zinns, 35, died peacefully Wednesday, July 5, 2023, at her home in rural Canton, South Dakota, after a courageous battle against brain cancer. Funeral services were held Monday, July 10, 2023 at Good News Church (1800 S Valley View Rd, Sioux Falls). In lieu of flowers, a fund has been established for Heather's children at Security Savings Bank in Canton, SD.

Heather Dragstra was born April 8, 1988, in Luverne, Minnesota, to Warren and Avis (Olson) Dragstra. She was baptized at Chandler Christian Reformed Church. Heather attended elementary school in Chandler before graduating in 2006 from Southwest Minnesota Christian High School in Edgerton. As a young girl, she shared the love of all things horses with her mom. Together they enjoyed horseback riding, camping and participating in new adventures. Heather participated in the 4-H program at the county and state levels with her mom's horse, Misty and her own horse, Simon.

In early 2011, Heather began experiencing painful headaches and suffered her first seizure. After brain surgery and radiation treatment, Heather resumed her college studies while finishing her chemotherapy treatment, graduating with a degree

in business in 2012.

Supporting her since her original diagnosis and through the loss of her mother, Avis, on Dec. 24, 2011, was Israel Zinns. The two married September 21, 2013, at the Chandler Christian Reformed Church. Together they had two children, Ava, in 2017 and Aidyn, in 2020. Heather loved her family deeply and often told her children she loves them "to the moon and back."

Heather was a selfless, strong and independent woman, who enjoyed the outdoors and dreamt of living on her own acreage with her horses, Simon and Stormy. She didn't let her cancer slow her down. She often showed kindness by helping others, giving an infectious smile or sharing her firm foundation in her faith. Heather will be deeply missed by her family, friends and all who knew her.

In 2021, after several years of remission, Heather had another seizure, which led to the discovery that her cancer had returned. During the past two years, Heather fought back the cancer, enduring more treatments, surgery and regaining her speech and mobility skills. On Father's Day, June 18, 2023, Heather suffered another seizure. Doctors reviewed her scans, and the aggressive growth of the tumor they found led her to choose to enter at-home hospice on June 23rd.

Heather is survived by her husband of nearly 10 years, Israel, of Canton, SD; daughter, Ava (6); son, Aidyn (3); her father, Warren Dragstra of Chandler, Minn.; brother, Joshua Dragstra of Hartford; sister, Susan (Kent) Sime of Milbank; niece, Cailey Sime; nephew, Brock Sime; grandmother, Betty Olson of Luverne, Minn.; along with aunts, uncles, cousins, numerous extended family members and friends. Southtown Commentary

We All Must Love Jesus

God's greatest command is found in Deuteronomy 6:5, "And you shall love the LORD your God with all your heart and with all your soul and with all your might." Jesus is God and he said, "If you love Me, you will keep My commandments." (John 14:15) It is important that Christians love Jesus.

Sadly there was a church that had lost their first love. We read about it in Revelation 2:1-4, "To the angel of the church in Ephesus write: The One who holds the seven stars in His right hand, the One who walks among the seven golden lampstands, says this: 'I know your deeds and your toil and perseverance, and that you cannot endure evil men, and you put to the test those who call themselves apostles, and they are not, and you found them to be false; and you have perseverance and have endured for My name's sake, and have not grown weary. 'But I have this against you, that you have left your first love.'"

The Ephesian church was commended for not putting up with evil men and those who claimed to be apostles but were not. The apostle Paul had warned in Acts 20:30 that even some of their pastors would end up teaching wrong things and that they needed to be on guard. Later he wrote to Timothy who was a Pastor in Ephesus and warned Timothy of false teachers (1 Timothy 1:3). Then in verse 5 he reminded Timothy to promote love. Thus, the church at Ephesus followed some of the instructions, but not all of them.

They had not always been know for messing up in the area of love though. As John writes about them in Revelation, he points out that they had left their first love- implying that they at one time had the love. The Apostle Paul had also written a letter to them where he commends them for their love of Jesus when he says, "Grace be with all those who love our Lord Jesus Christ with a love incorruptible." (Ephesians 6:24)

By the time that John is writing Revelation decades had passed, so it is likely that those whose love for Jesus could not be corrupted had already passed away. Thus we had a church that had lost its first and most important love.

John records Jesus' warning to the church at Ephesus, when he warns, "Remember therefore from where you have fallen, and repent and do the deeds you did at first; or else I am coming to you, and will remove your lampstand out of its place--unless you repent." (Revelation 2:5)

The lampstand was the place where the light of the lamp was set. Jesus

is the light. John 8:12 says, "Again therefore Jesus spoke to them, saying, "I am the light of the world; he who follows Me shall not walk in the darkness, but shall have the light of life."

When a church has lost it's love for Jesus they are no longer setting Jesus up on the lampstand to let his light shine brightly to all who enter the church. A candle on a lampstand gives a lot more light than a candle tipped over and laying burning on the ground. If a candle on the floor starts the floor on fire, then the building will likely be destroyed anyway. The point is that the light of Jesus without a lampstand is quite ineffective. That is why it is so important that the people of a church have a love for our Lord and Savior Jesus Christ.

If you find that you or your church has lost that love, then do like Jesus said and repent. Then let your love for him shine as you strive to obey him. Jesus loved us so much that he died for our sins. Knowing how much he loved us, it should be easy to love him. www.southtownchurch.com

A LOOK BACK AT THE STORIES AND HISTORY OF LINCOLN COUNTY

I hope you all had a nice 4th of July and the much needed rains we received didn't mess up your holiday plans too much. We were already in Lennox when they canceled their parade. We then headed back to Canton for a bite to eat and made it over to Inwood for their parade which had been delayed. The temperature was a little on the cool side but we enjoyed the parade and there appeared to be a good crowd over in our neighbor city to the east.

Depot Days will be taking place in Canton on Thursday and Friday this week. A great family bluegrass band from Sioux Falls, the Teels, will be the musical act for the Open Air Market at Jack Fox Park on Thursday and Windy City Bites will have their food truck there.

The following story comes from the 1985 History of Lincoln County South Dakota. Happy reading.

Hans and Johanna Loe Family

Hans P. Loe was born in Opdal, Norway, in 1879 and came to Canton at the age of two years with his parents, Mr. and Mrs. Paul Loe, and two sisters, Mary and Anna. He received his education in the Canton School. As a young man he worked for a produce company hauling loads of eggs to the depot.

Johanna Mikkelson Hangenholen - later changed to Gilbertson - and her twin sister were born in a dugout in Highland Township, Section 36, October 1878. Her twin sister died at the age of six months. They were the children of Mikkkel and Christine Gilbertson.

Johanna (known as Hannah) attended the Rice School. Later the school was moved across the section and then named Moe School, District #22.

As a young girl she was employed as a cook at the Harlan House, a hotel in Canton located on South Cedar in block 21. Later on she was employed as a cook at the Rudolph Hotel located on East 5th Street, a block east of the court house. A few years later she was employed as a cook at the Indian Insane Asylum, an United States Government Institution located east of town where the Canton-Inwood Hospital is now located. It was here that Johanna and Hans met. Hans worked as a farm hand.

In April 1909, Hans and Johanna were married. They moved to a farm northwest of Canton. In 1910 they moved to the Meinek Falde farm nine miles south of Canton in Fairview Township, Section 31. Martin, their only child, was born Oct. 5, 1910. Hans and Hannah bought the farm in 1918.

It was while the Falde's lived on this farm that the post office Odin was located here in the dining room. Neighbors would come to pick up their mail several times a week.

Hannah was much in demand to prepare and cook wedding dinners. She would sometimes spend four days at the bride's home preparing the food for the wedding. If it was a big wedding, a tent would be put up.

Hannah was known as the "coffee cooker" for all community and church affairs way up until her health failed.

Hans served several years on the Pleasant Valley School, District #74 school board. Johanna was very active in the Ladies Aid at Trinity Church, Moe Parish. She served as president for several years.

Hans died Feb. 20, 1937, and Johanna died Oct. 11, 1959. They are both buried in Forest Hill Cemetery.



Annual Meeting

This meant that Helen Rowe took the initiative for an annual cousin reunion in November on the occasion of Tore Detlie's birthday.

"So the family got to know Tore well," says Helen, and adds that there were regular family reunions also in South Dakota at Helen Rowe's, where Tore had managed to gather several of the people with origins in Detlislekta, from several of the family branches.

Helen Rowe tells OPP that this continuous maintenance of contact between the relatives, resulted in 20-something deciding to go to Oppdal to visit the place where the family has its roots.

"It's been 27 years, and two years ago we had planned another trip, which was postponed until now due to Covid," says Rowe.

Come to Oppdal

On June 10, 43 Americans from Detli set foot on Norwegian soil. After three days in Trondheim, they went to Oppdal, where Detlia on Lønset was the most obvious place to visit.

While the majority of the entourage had been there before, several of those who have married into the family were visiting the childhood home where the family comes from for the first time. Among these is Tanya Rowe, who is married to Helen Rowe's youngest son, Kevin Rowe.

"Kevin and I have been married for 18 years, so I have been to quite a few Detli meetings over the years," she tells OPP.

As she herself comes from a

relatively small family, Tanya thinks it's fun to have joined a big family.

What was it like for you to come to Oppdal and Detlia?

"It was great to experience, because I have heard so many stories. So coming here and seeing it was really nice." The entourage was also at the Sverresborg folk museum, where they were able to enter and see the living room that stands in the museum yard and originally came from the Detli farm.

"I didn't know you could walk into it. It was great to experience and see not only it, but also to visit the farmyard at Lønset and the cemetery at Lønset, and hear the history when we were there," says Tanya Rowe, and admits that she has gained a greater perspective and insight into history after the visit.

"It is also hard to think about what it was like traveling from the family to America at that time."

Gained Insight

Like Tanya, Nick Meyer is married into the family. More specifically with Helen Rowe's granddaughter, Kirsten. Nick says that he has been completely initiated into the Rowe family and says that he has attended several family reunions.

"I grew up outside Chicago and was mostly involved with my closest family," says Nick to OPP, and admits that through his wife, he has gained an insight into the importance of family.

Both Nick and Tanya admit that coming to Norway and Oppdal together with all the relatives from Oppdal is great. They say that they have also met many relatives who live here, including on Wednesday

last week, when Helen Rowe had invited them to a barbecue party at Bjerkeløkkja.

"And you will meet 30 more in Oslo when we arrive at Frognersteteren," Tore Detlie interjects.

He has lived in the United States since his studies, but has a cottage in Oppdal and visits Hjernbygd regularly.

"We are lucky to meet these people a couple of times a year," Nick continues, and it is clear that Helen Rowe is the one who holds the family together, well supported by her daughter, Leah Marcella, who clearly shows that she intends to carry on the tradition.

"My son will be the seventh generation after those who came from Oppdal, and my wife and I now live in the area where Helen lives," Nick continues, adding that one day they will take over Helen Rowe's house in Canton.

"More dinners have been served in that great white house than you can imagine," Tore Detlie chimes in.

Sesaker, Strand, Sliper, Ishoel and Storlie are families/kindreds with Detli connections. Tore Detlie tells OPP that there are several relatives in the US who would probably have liked to join the trip.

"There is a difference between family and friends. You can choose your friends, but not your family. There are some ties there," says Tore Detlie.

The journalist's parents-in-law, Henry and Pauline Ishoel with children, were the last owners to live on the farm, Detlia, which burned down in 1969 after a lightning strike.

THE EMIGRATION FROM OPDPAL

• Emigration from Oppdal took off in earnest after the American Civil War stopped in 1865. For five hectic ten years until 1915, every year there was a flood of people from Oppdal who sought their fortune in America.

• In total, probably around 2,000 Updalian immigrants immigrated to the United States. The reason was that the home village was unable to feed the ever-increasing population.

• Beyond the 19th century, the population in Oppdal rose dramatically. From 1801 to 1865, the number of farms in the village increased from 272 to 525 and in the middle of the 19th century Oppdal had over four thousand inhabitants. Both agriculture and forestry were pushed to the limit. The way out for many was to say goodbye to friends and family • and seek happiness in the USA • Many of them never returned. In 1865 there were 4,500 inhabitants in Oppdal, 50 years later it was down to 3,760.

The settlements settled mainly in two areas, in Snohomish county in the state of Washington, and on the prairie in the area between Sioux City, Sioux Falls and Yankton.

Harrisburg School District Updates

– Superintendent Tim Graf talks about new schools, new staff, new administration changes, and the Homecoming Parade

With 4th of July décor now on sale, notebooks, colored pencils and all forms of school supplies have taken over the aisles at Walmart. Parents and kids are thinking “back to school” even though the 2023-24 school year doesn’t start for another six more weeks.

The Harrisburg School District and Superintendent Tim Graf are no exception. They believe they are right on pace.

With an estimated enrollment of 6150 and school set to open August 23, the teachers, staff and administration are in place and the new East Middle School and the new Harrisburg Freshmen Academy are preparing for occupancy says Graf. “Even though July just started, people are thinking ahead. Not a day goes by when we don’t get some call or email about bus routes and boundaries. Right now, the school district is feeling prepared.”

Graf gives a basic overview of where everything stands so far in July:

Staffing

Sixty-five teachers were hired for the school year. “There is a lot of new staff,” says Graf. “In fact, 45% of our current staff has been hired after 2018.”

East Middle School

The newly built \$30M, 142,730 sq. ft. East Middle School will open with approximately 400 students. “The new school has few design changes from North Middle School. It will have a more open concept and some color changes. Micah Fesler and Amanda Olinger will serve as principal and assistant principal.”

Middle School administration

With a third middle school, some administrative changes took place at the middle school level. New to the district, is Brian Hartwig. Hartwig will serve as principal of North Middle School. Brad Hartzler will serve as assistant principal. Darren Ellwein will serve as principal at South Middle School. Levi Ludens will be assistant principal. Micah Fesler and Amanda Olinger will shift from North Middle School to East Middle School and serve as principal and assistant

principal, respectively.

Harrisburg Freshmen Academy

The \$30M building on a 71-acre campus just south of 85th and Cliff is preparing for occupancy. Twenty-two teachers moved from the high school and five new teachers were hired. Assistant high school principal Brad Seamer will continue his role at the new Freshmen Academy. An interesting fact, the Harrisburg Freshmen Academy is the only freshmen academy in South Dakota and the only free-standing building. The school is large. At 151,483 sq. ft, space will matter as over 480 freshmen start the year. It is the largest freshmen class in the history of the district.

Elementary #8

Ground-breaking has taken place and Harrisburg’s newest elementary building is under construction on South Cliff. Designated as Elementary #8, the building has yet to be named.

A new fine arts director

Amanda Berg is the new fine arts director for Harrisburg. Lucy Archer, an art teacher from Horizon, will be the assistant fine arts director. Berg replaced Shane Wuebben who became the fine arts coordinator with the Sioux Falls School District.

Road Construction and closures for the start of school

Completion of the Roundabout project is November 2. Though 272nd Street will open at the end of July, only portions of Willow will be open July 19, and Cliff will be closed from south of Foundation Drive to south of Dollar General. “The district is preparing for detours at the start of school, and planning for road construction running through October.”

Homecoming Parade - questionable

Harrisburg’s Homecoming, September 29, will go on as planned, still the Homecoming parade route has not yet been determined. The parade, a homecoming tradition and the longest parade in the state, is facing some logistical problems. “We hope to continue with the parade, although we have yet to come up with an alternative route.”

Half Done

Willow Street Paving Almost Complete as Cliff Avenue Prepares to Close July 19 and Move into Phase 2

Chad Huwe, Project Manager for Stockwell, provides five things the public should know about the Roundabout road project

The trying summer for Harrisburg drivers will continue as the second half of the \$5M roundabout project gets underway. The good news - even though Willow Street is still closed at Cliff Avenue, the public will now have access to businesses on Willow. The bad news - Cliff Ave will close. Roadwork on the intersection that handled 7000 cars a day won’t be completed until November 2. Drivers can continue to expect at least three and a half months of traffic backup, road closures and detours.

“Though Cliff Avenue has been seeing plenty of roadwork this summer, this quarter mile closure at the intersection will mean further disruption. It may be viewed as bad news for some, but we are now half done. It is a good sign that we are making progress,” said Chad Huwe, Stockwell project manager.

Huwe details aspects of the roundabout project and what the public should be know:



other road projects affecting Cliff right now. It goes without saying, there are headaches.”

Besides working with the roundabout contractors, Huwe also communicates with the contractors completing the 272nd Street road project, the contractor working on the sewer project and a private contractor doing shoulder work on Cliff Ave.

“Unplanned issues come up daily, and it means making decisions on the little things. The nuts and bolts of this project means ongoing

coordination and management of all that is going on along or near this stretch of Cliff Ave.”

Maintaining and staying on schedule is essential.

The completion date for Harrisburg’s first roundabout is set for November 2. It will be the first multi-lane roundabout in South Dakota. Huwe says to reach this completion date, it is all about keeping the project moving forward and daily troubleshooting.

Good communications are important he says.

“We believe it is essential to communicate not only with contractors but also with the public and the schools. We especially work hard to inform everyone of unexpected detours and road closures,” Huwe said, adding that the city will share information about closures and other traffic impacts on its website, social media and through an email blast as well as digital message boards.

Huwe notes a lot of things have gone right thus far. “We got through the private utility work and supply chain issues with utility poles. The communication with the property owners has been good and is ongoing. The weather has also cooperated.”

Kent Street will get some attention.

Throughout the summer, major detours have been directed through neighborhoods. These roads, which were made for much lighter traffic, are suffering. “The heavy traffic volume has taken a toll on neighborhood roads. The city will address these roads this fall.”

Drivers need to slow down!

“Slow down,” Huwe said. “Speeding is still a problem. Motorists on the detours have been traveling too fast. The speed limit is 20 mph.”



Phase 1 roadwork will be completed July 19.

Phase 1 of the Roundabout began with the closure of Willow in May. Though the original completion of Phase 1 was set for June 30 then moved to July 19, Huwe says the changes were more about shifting work from Phase 2 into Phase 1. “There was an overall benefit for the project to move work around. Initially, the timeframe for work in Phase 2 was four months. It means less work that needs to be completed in Phase 2.”

Phase 1 is now on track Huwe says.

“We remain on schedule to have all the Willow Street roadway paved. Though the back-of-curb work - the grass, sidewalks and landscape -won’t be complete everywhere.


Phase 2 is the next big thing, and it means managing Cliff Ave.

Cliff Avenue will close south of Foundation Drive to south of Dollar General July 19. “Though this is only a quarter mile closure, it is Cliff Avenue,” he says. “There are

ON PICKING WILD GRAPES WITH MY DAD

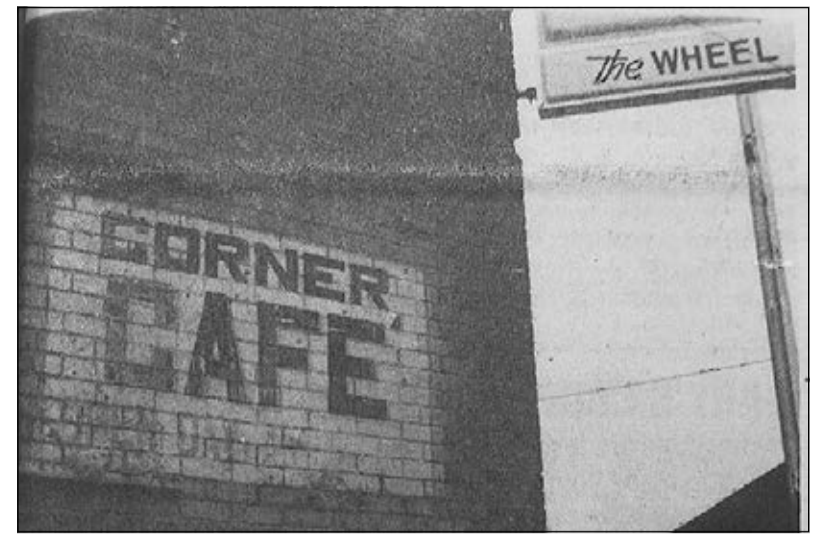
It was a hot summer day, the sky was clear and blue;

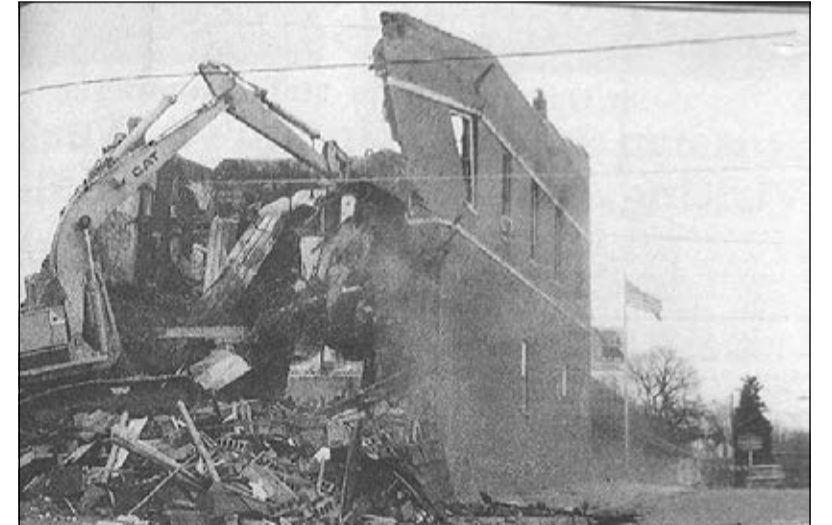

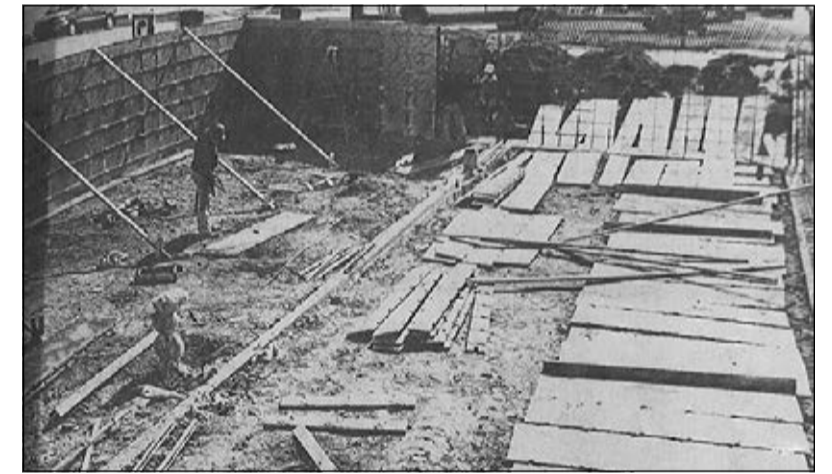

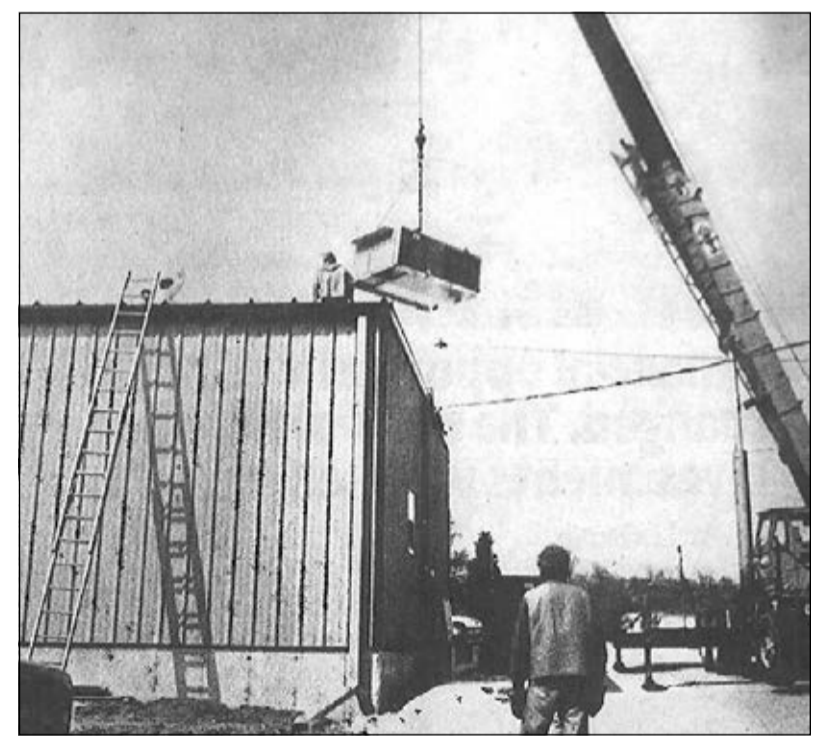

Bookish

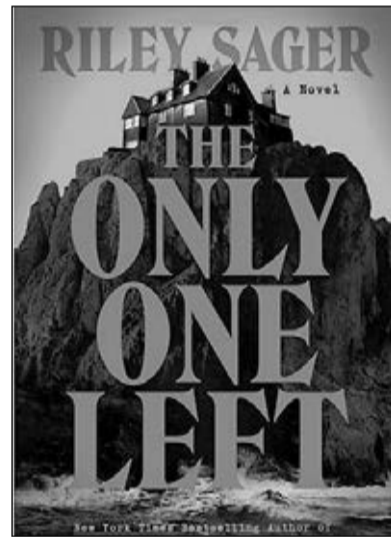

 My husband was recently told layoffs are about to happen at his company, and that it might be a good idea for him to start looking for another job. He has found a couple of good possibilities, but the

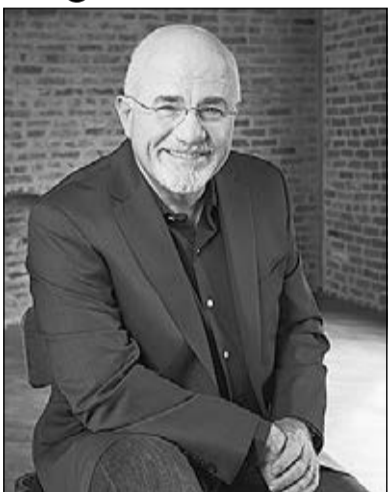

We noted the following deficiencies in internal controls in the cash and investment reconciliation process:
The County has not completed a reconciliation of recorded cash and investments to financial institution balances since December 2020. This reconciliation process serves to verify the County's deposits and withdrawals have been properly recorded at the County and is necessary to detect errors in the County's accounting system or errors made by financial institutions.
The county has not presented a monthly verification of the treasurer's accounts to the Board of County

Commissioners since January of 2021. SDCL 7-10-3 requires that a monthly verification of the treasurer's accounts be reported to the board of county commissioners at each regular meeting. This monthly verification serves as a check and balance of the Treasurer's Office by verifying all cash items and bank accounts in possession or controls of the Treasurer's Office.
Recommendations:
1. We recommend the County perform a reconciliation of the recorded cash and investments to the financial institution's balance on a monthly basis.
2. We recommend the County prepare and present a monthly verification of the Treasurer's accounts to the Board of County Commissioners as required by SDCL 7-10-3.
Views of responsible officials:
1. The reconciliation of the recorded cash and investments have been completed through April of 2023. The County Auditor and Treasurer have added additional steps in the month end process to verify that the reconciliation of the recorded cash and investments are completed and are in balance every month.
2. The County Auditor and Treasurer have added additional steps in the month end process to verify that the Treasurer's accounts to the Board are completed every month.

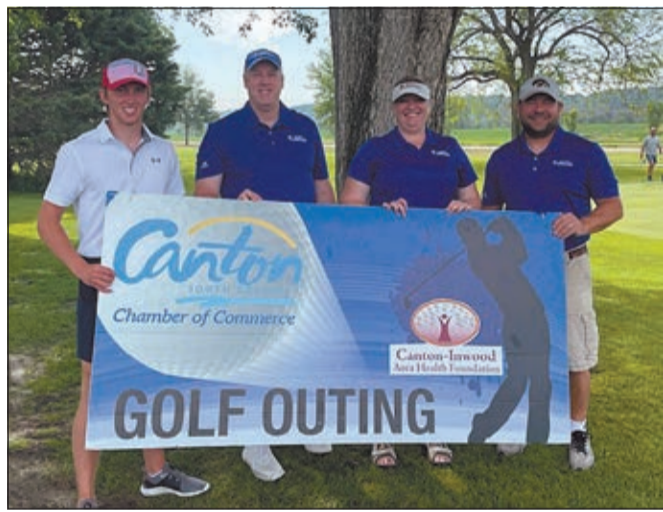
