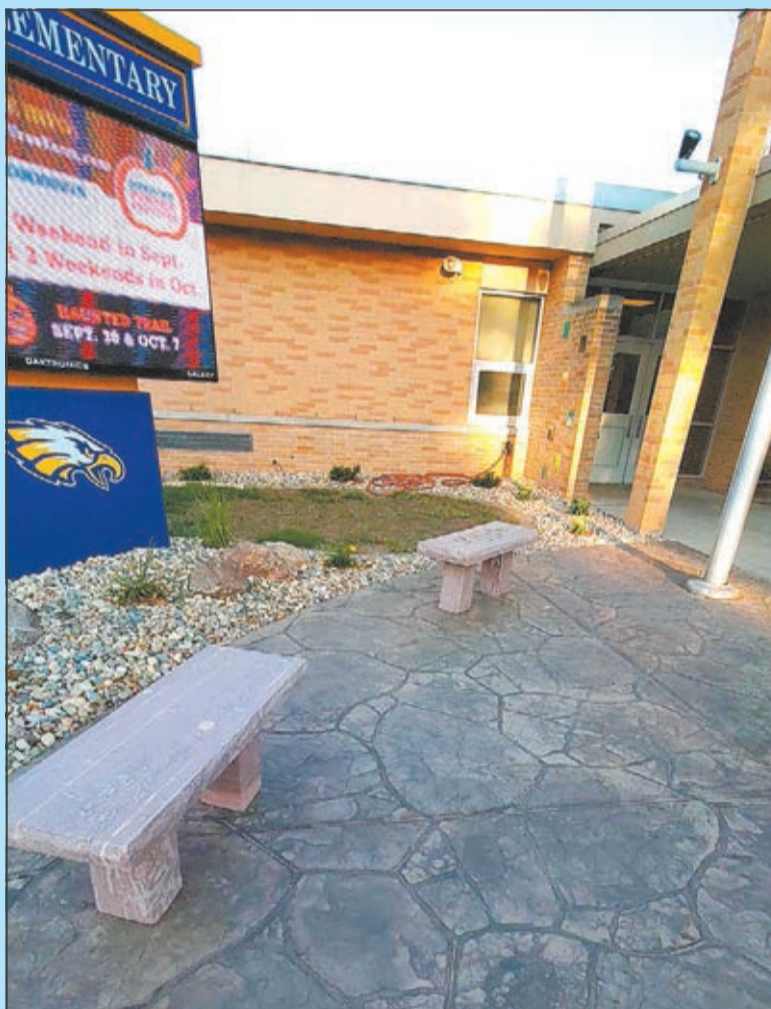
Bench Donated to Remember Becky Earl

When living in Vermillion, she earned her master's while

simultaneously teaching at the Gayville-Volin school. After that, Earll was able to accept a position for her dream job in the Canton School District. So, Earll came home to Canton. At Lawrence Elementary, she was a math specialist for many years. Her sister Courtney, said Earll was so thrilled to work where she grew up, for the Canton School District.

Earll was known to refer to her students as her "kiddos." Courtney said she had the best sense of humor, often sharing this humor with all whom she interacted with. She had a way for caring for each child she taught



and celebrated their individual successes. Earll was a proud supporter of both sports and the arts in Canton. It is evident to see that she loved her community.

To remember her spirit, the school district has added this memorial at the entrance of Lawrence Elementary.

Canton School District and the Class of 2000 went in together to honor Ms. Earll. We wanted something that would be around for a long time. It is great to walk by the benches every day and still think of the positive impact that Ms. Earll made on our students. It puts a smile on my face every time I see it. When asked about what this means to Earll's family, Courtney replied, "The bench is meaningful to our family because of how much Becky loved the kids she taught, and the people she felt blessed to work with. We're grateful for the memorial as she is forever in our hearts and this bench is a beautiful reminder for all who knew her."

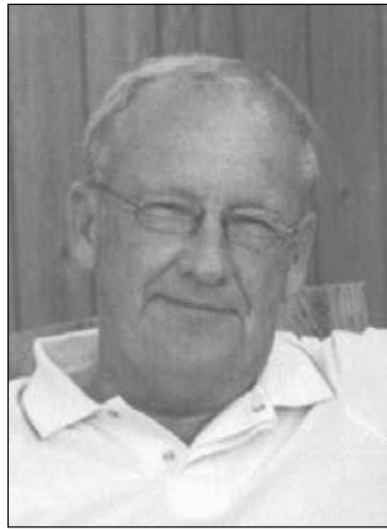

Leroy Dale Feekes was born in LeMars, Iowa on September 14, 1949, to Theodore J. and Grace (Lems) Feekes. He grew up in rural Iowa with 5 siblings, and attended grade school in Beloit and high school in Canton. He graduated from Canton High School in 1967. On February 24, 1966, while still in school, he went on the first date with the future love of his life, Nancy Joan Servold. A year later, on the same date, they were engaged. In April of the same year, Leroy enlisted in the South Dakota Air National Guard and after completing basic training, he honorably served as a cook for the remainder of his 6-year term. On October 11, 1968, Nancy became Mrs. Leroy Feekes as they were united in matrimony, and the story of their 54-year marriage began. They started to make their home together in a modest rental house in Beloit, which once served as a United States Post Office. Leroy was a baptized member of Bethany Reformed Church, growing to be a faithful follower of the Lord, actively serving in the offices of elder and deacon.

Initially, Leroy was employed at a local dairy farm owned by Burt Lems. In 1971 the couple was able to purchase a home of their own in Canton. From 1970 to 1979, Leroy and Nancy continued to grow their family with the addition of three children, while being employed at the Canton Tile Plant and Bid-well Corp. While out driving with his family, it was quite common for Leroy to excitedly point out to his children all the areas he delivered concrete tile pipe to. Under Twenty-five Years Ago - 1970 it stated Gov. Frank Farrar toured the Otis Radio plant in Canton Monday afternoon. Also the Canton High School Variety

squad members will receive their football equipment on Saturday, August 15. Coach Burdell Coplan said he expects 53 seniors, juniors and sophomores to report for pre-school practice on Thursday, August 20.

Down Memory Lane(Revisited) Fifty Years Ago - 1945

from the August 10, 1995 Sioux Valley News

The Russian nation declared war on Japan Wednesday, broadcasts over the radio stated. The news story related that one of the primary purposes of President Truman at the Potsdam Conference was to secure bases for American airfields in Russia or to get Russia to enter the war against Japan. The effects this notice coupled with the devastation caused on Hiroshima Sunday by the new atomic bomb, will have on the decision of the Japanese military authorities to continue the war or to accept the unconditional surrender terms laid down by representatives of the three powers meeting at Potsdam, should be known within a few days. The welcome announcement came over the radio just as the ENws was going to press and it was too soon at that time to learn the effects of the Russian decision on the Japanese people.

The Canton Board of Education at the yearly budget meeting Friday evening, set the estimated expense for running the Canton public school system in 1946 at \$67,250, an increase of approximately \$3,000 over that set for 1945.

The Lee Brothers All American Circus will visit Canton on Tuesday, August 14. The Circus, a three ring affair, will show at the west side ball park both afternoon and evening.

The use of the atomic bomb on Hiroshima Sunday was of particular interest to Canton people for Dr. Ernest O. Lawrence, whose cyclotron and research contributed much to the success of the new bomb was a former Canton boy.

Unity Through Humility

Jacob and Esau were twin brothers. Esau was only a little bit older than Jacob and when they were born, Jacob had a hold of Esau's heel. This was not the only time when there was a hint of tension between these two brothers. As the older of the two, Esau had the birthright. That meant when their father Isaac died, he would get the inheritance. But one day Esau was hungry and traded that birthright for some food that Jacob offered him.

Although the birthright now entitled Jacob to the future inheritance, their father had a right to give away gifts any time before his death. That meant that he could bless Esau with many possessions even before he died. This would have allowed Esau to get what amounted to an early inheritance that could have potentially left Jacob with little after Isaac died. Jacob thus figured out a way to trick his dad into giving him the blessing instead of Esau. Thus Esau was so upset that he had neither the birthright nor the blessing that he wanted to kill his twin brother.

Jacob is convinced that it is best if he just leave and give his brother a chance to calm down. But after 20 years, Jacob decides to come back home. By the time he returns he is married, has children, and has built up huge herds and flocks of animals. He had been quite successful even without his father's wealth. During that same time, his brother Esau had also seen a lot of success. Remember that Jacob had left 20 years earlier because his brother had wanted to kill him.

One of the reasons that Esau had been so upset was that the blessing that Jacob received said that Jacob's brothers had to bow down before him. Further, Esau was told that he would have to serve Jacob. So based on the traditions and rules of that time and within that family, Jacob had authority over Esau. Instead of flaunting that authority, Jacob does something very special. "But he himself passed on ahead of them

and bowed down to the ground seven times, until he came near to his brother." (Genesis 33:3) Instead of demanding that Esau bow to him, he bows to his brother.

The results of Jacob's humility are very touching. "Then Esau ran to meet him and embraced him, and fell on his neck and kissed him, and they wept." (Genesis 33:4)

As chapter 33 unfolds we see both Jacob and Esau showing love and humility toward each other in spite of past hurts. We see a family reunited and we even see Jacob wanting to come to visit his brother once they get settled (vs 14). Throughout the chapter, we see Jacob calling himself Esau's servant even though legally, it was the other way around.

Jacob is a wonderful example of a man who has been given authority, yet set aside that authority to serve someone else. Jesus did that in an even more dramatic way. He set aside so much of the power and authority he had in heaven to come to earth as a humble man. Once on earth, rather than demanding to be served he served others. He washed feet, healed the sick, fed the hungry, and died for the sins of the whole world.

When Jacob showed humility toward his brother Esau, it paved the way to them being reconciled and setting aside the animosity that had been between them. Jesus did the same thing. By showing humility and becoming a humble servant, he was able to bridge the severed relationship between God and man caused by man's sin.

For those who have a brother like Jacob, it is a huge blessing, but we can all have a Lord and Savior who is even better than Jacob. That Lord and Savior is Jesus Christ. All we have to do is to believe in Jesus as we fall before him in love like Esau did to Jacob. "For God so loved the world, that He gave His only begotten Son, that whoever believes in Him should not perish, but have eternal life." (John 3:16) www.southtownchurch.com

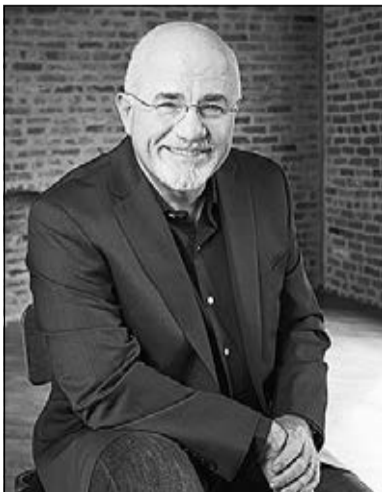

More Than Apples

Country Apple Orchard Fall Festival Creating Fun Without its Star Attraction

Drought and an insect blight destroy an apple crop

When you think of fall traditions, it is hard not to think of Country Apple Orchard and their weekend Fall Festivals in September and October. There are so many reasons to attend: a petting zoo, a giant haybale maze, tractor rides, a sandcastle tire mountain, South Dakota's largest jumping pillows, a 150-ft zipline course, a 120-foot POET corn pit, a country store, a candy store and apple cider donuts. But one of their biggest attractions won't happen this year - there will be no U-Pick Apples this season. Drought and an insect blight destroyed the apple crop.



What happened to the apples?

Since 1984 when Country Apple Orchard opened its 55 acres it has always served as a celebration of fall. And with 6000 apple trees and 13 varieties, the apples were plentiful. U-Pick Apples has always been their biggest attraction.

"Because of drought and the apple thrip pest, the trees were unable to produce this season. Though there will be plenty of apples, U-Pick Apples won't be available," explained Amber Halvorson, General Manager.

Though drought is easy to explain, the pest isn't. The culprit was small but mighty.

Western flower thrips are minute insects as wide as a needle and about .03 inches long. They are attracted to the blossoms of apples as well as orchard cover crops. Their primary damage is from egg-laying punctures in newly formed fruit and typically occur before petal fall.

"We want the public to know that we will have apples, they just aren't Country Orchard's apples. Management got creative and



brought in apples from nearby orchards. Our customers can expect at least four varieties to choose from. And lots and lots of apple products," said Halvorson. "In fact, 657 frozen apple pies are ready to go."

This week Halvorson says Country Apple Orchard will feature four varieties of bagged apples inside the store: First Kiss; Zestar; Honeycrisp; and Sweet Tango.

destination," said Halvorson. "We know people will be disappointed that they can't pick their own apples, but there are so many other things do. Our owner Greg Jones keeps coming up with new ideas. This year he added an Optimus Combine Slide and lots of local products in our country store. There are now over 20 different attractions."

Hot weather the first weekend of the Fall Festival kept the crowds



A fall destination

Though the apple picking is closed this season, Country Apple Orchard expects to be extremely busy the next two months. They are employing 60 people who will be selling caramel apples or pumpkins, working in the Country Store or outside concessions, giving tractor rides and making sure fun happens.

"Country Apple Orchard's Fall Festival has so much going on each weekend. We really feel it is a fall

away, but the second weekend has been a different matter.

"The large crowds are what we planned for. Last season, over a course of nine weeks, our attendance was 60,000 people," said Halvorson. "This place comes to life in the fall."

Country Apple Orchard is located at 27249SD Highway 115 in Harrisburg.

The Fall Festival runs every Friday, Saturday and Sunday in September and October.

The Last Big Requirement

The Capstone Experience Means Graduation Credit and Abundant Opportunities for HHS Seniors

Christian Aguilar isn't taking senior year for granted.

"So many seniors think senior year is easy. But I think there is a lot that is still expected of me. Right off the bat, I had to come up with a Senior Project idea. The biggest thing I worried about was finding a good idea and meeting all the requirements that are asked of me. I was frustrated when I got rejected from the Humane Society because they only take three students a year for senior projects."

Aguilar decided to look at another option and moved forward with a youth internship. After visiting with his counselor, his schedule is now readied for his second semester, and he will be placed at Outdoor Campus. His internship will count as a capstone course and fulfill his Senior Capstone requirement.

The Senior Capstone Experience is a graduation requirement. All seniors must complete a senior project or experience to showcase their connection with the community, show what they have learned, show that they gained hands-on experience or show they explored a career interest. Formerly called the Senior Project, the Senior Capstone Experience now provides many more options for the class of 2024.

Why the change?

High schools across the state have required student learning hours and senior projects. Their rationale: requiring community service allows schools to help students become more educated in how to help others and the impact they can have. However, there was really no alignment from school to school.

Changes for senior project requirements came for the top – the SD Department of Education.

"The SD Department of Education updated the Senior Capstone Experience, and seniors now can choose youth apprenticeship, youth internship, entrepreneurship or career exploration in addition to a traditional service project," said Breanne Lynch, CTE Coordinator for Harrisburg High School.

Lynch believes the new Dept of Education additions and name change are a good thing especially for Harrisburg. "The additions allow learners to explore careers or complete service projects; with our large student body population of varied interests or skills, these opportunities are more inclusive."

A time crunch

Time is of the essence. Seniors must submit their proposals by September 15. Once they get started, they will journal their experiences and for the next three months do what it takes to complete the project they choose. The visual presentation and summary are due before December 15.

Organizations like the Humane Society have become a popular choice offering specific senior project options, but opportunities fill up fast. The Humane Society only takes three applicants (though volunteers are always welcome). Feeding South Dakota has become another worthwhile idea. Students can pack boxes of food but must show up and commit to at least 15 hours of service time. Students have even committed to coaching or refereeing for a season of youth sports as their service project.

It starts with a good idea

Students are informed of their senior project throughout high school and provided the requirements in the spring of their junior year. Many begin their projects in the summer.

"The Senior Capstone Experience allows students a



choice in their learning," said Assistant Principal Kay Bass. "Most seniors will choose service learning and give back to their community. This is a win-win for our community organizations, youth sports/activities and non-profit groups. However, all the options under the senior capstone experience provide students with more options to shadow and learn their career interests, acquire an internship or build their own business as an entrepreneur."

Good ideas are out there says Bass.

"We like to see students get creative with their projects," she said. "We've had students form peer editing/reviewing support services, volunteer with Best Buddies, tutor/mentor elementary students, or raise money for non-profit groups that are important to them like the Juvenile Diabetes Foundation. Last year a student organized a group of fellow classmates to write stories for and publish a monthly Harrisburg High School Newspaper. That same senior project is taking shape again this year as the newspaper is looking for new members. When we let the seniors take the lead, they do amazing things."

Can't spell Community without y-o-u

Knowing some kids are still looking for a senior project, the City of Harrisburg has come up with its own list of senior project ideas. Last year, Harrisburg Community Programming worked in collaboration with the Harrisburg Food Pantry and the Roar Store in a Giveback Senior Project. The Career and Technical Student Organizations (CTSO) service project had a large impact raising \$2795.65; all the cash was donated to the Harrisburg Food Pantry. Community Programming also offered a Youth Internship at City Hall.

This year Larry Klipfel, director of Community Programming, looks to continue those community service projects for seniors that will directly benefit Harrisburg.

While the city has nearly a dozen volunteer projects available at a given time, Klipfel takes a tailored approach to senior project inquiries. He coordinates with teachers to understand how the city can offer an appropriate work experience and community service for students.

"Most people like to do things they have an interest in. And interested people make great volunteers," he said.

Civic leadership and responsible citizenship are what students learn

through projects with the city says Klipfel.

Klipfel also believes volunteering is important for high school students.

"Volunteering offers the opportunity to practice important skills used in the workplace, such as teamwork, communication, problem-solving, project planning task management and organization."

Community service projects also help students learn more about their city.

"Whether it is economic development, safety, healthy, environmental quality or other matters, students will gain knowledge of community issues," he said. "Those looking to connect with Harrisburg Community Programming should speak to their teacher. We have some good ideas for community service."

Mandatory but worthwhile

A senior capstone experience is mandatory and can be service learning hours or other options like internships, shadowing or entrepreneurship or doing both. Aguilar says putting together his Capstone Experience took some serious planning on his part. He signed up for not only an internship, but also a community service project.

"Through this whole process of figuring out the Capstone Experience, I discovered I was eligible for an internship. That looks so good for college, and I receive one full credit. I also decided to complete a senior project for an extra half credit. For my community service project, I am rebuilding a coffee bar table in the ROAR Store during school hours. I am currently in Introduction to Construction and will be working on this project with Mr. Wynia and seniors Colton Krog and Jon Dam. Before building, we first have to get measurements, we will create a blue print, make a list of materials and price everything out then give this information to the ROAR Store as they will be paying for everything."

Aguilar admits he wouldn't have moved forward with community service or an internship if there weren't the consequences of not graduating.

"If it wasn't for the graduation requirements, I wouldn't be doing any of this stuff," he says. "Right now my Capstone Experience, my senior project and my senior year are now all planned out. And it looks like it will be good overall – I just have to get through it."

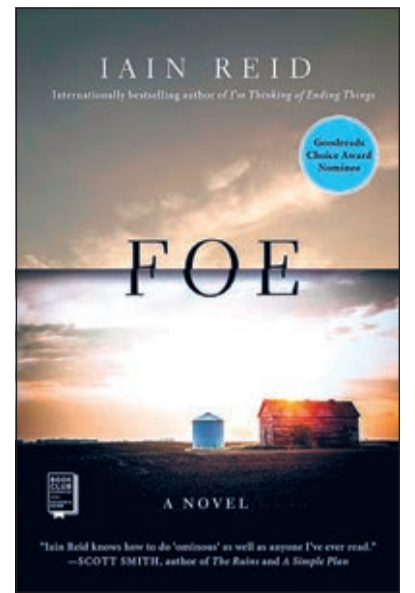
Bookish

The Canton C-Hawk football team traveled to Beresford on Friday, September 1st and came away with a 42-14 victory as they did all their scoring in the 1st half to win 42-14 then on the 8th the Hawks hosted Lennox for the Black and Blue Bowl and defeated the Orioles 28-20 to improve to 3-0 as they head to Dell Rapids to face the #1 ranked Quarrriers with a 7:00 pm kickoff. Commission to Allow Parades Again

The Canton City Commission met in regular session on Tuesday, September 5 at 7 p.m. at the Depot. Commissioner Paul Garbers was present via speaker phone.

With no Visitors to be Heard and no Old Business, the first item under New Business was an Emergency Siren Discussion. A concerned Citizen contacted the city regarding the sirens malfunctioning on August 22 and has suggested the topic of establishing a proactive siren schedule and public communication protocol. It has also been suggested that a monthly calendar of planned sirens from Lincoln County Dispatch should be established with a minimum of one per month and be communicated to City Governments to post on social media and to the public. If no known Tornado Warning, these preapproved posts would alert Citizens that the sirens are faulty but still remain weather aware. Lincoln County Emergency Manager Harold Timmermann took to the podium to provide additional information. Timmermann stated that the sirens are for Tornado Warnings only and are designed to alert if a Citizen is in the outdoors. He noted that the sirens were purchased and funded through FEMA and Homeland Security. He also mentioned that the sirens will no longer be funded due to social technology. However, they will keep using the sirens until they no longer work. Commissioner Kris York mentioned that this was just for discussion and no action is needed. The Commission thanked Timmermann. No action or motion was taken.

Next under New Business was the Pool Contract. Helm Mechanical has submitted the contract for Pool Construction and Pool Mechanical Construction for the amount of \$3,975,000. Motion to approve by Garbers. Seconded by Commissioner Tyler Larson. Unanimous approval.

The Hoogendoorn Agreements was next on the agenda. City Attorney Larry Nelson has put together the Hoogendoorn Construction for Sewer Line Ownership, Use and Maintenance Agreement and Pre-Annexation Agreement. Motion to approve by Commissioner Jerry Chaon. Seconded by York. Unanimous approval.

Next on the agenda was the SD DOT Utility Permit Paperwork. A permit is required to cross Highway 11 for the Hoogendoorn Sewer Line project. Motion to approve by Larson. Seconded by Chaon. Unanimous approval.

Next under New Business was the New Hire - Utility Billing Clerk. It is being recommended to hire Shari O'Connor for the Utility Billing Clerk position at \$17.28/hr (Grade 6, Step 2) dependent on completion of a cleared background check. She will have a six month probationary

period before she may be eligible for a step increase. Motion to approve by Larson. Seconded by Garbers. Unanimous approval.

An Employee Raise for Public Works Maintenance John Grubbs was next under New Business. Having received a favorable six month review on August 22 he is eligible to be paid \$21.41/hr (Grade 9, Step 2). Motion to approve by York. Seconded by Larson. Unanimous approval.

Declaration of Nuisance Trees & Order for Removal - Public Trees was next on the agenda. The Ash Trees in the City of Canton are infested with Emerald Ash Borer and are slowly dying. A Declaration is required by City Ordinance to require property owners to remove Ash Trees on Public Property/Right of Way. Motion to table until the Commission can meet with a consultant by York. Seconded by Chaon. Unanimous approval.

The First Reading - 2024 Appropriation Ordinance was next on the agenda. Finance Officer Kyle Cwach presented the 2024 Appropriations Ordinance for the City. Motion to give the First Reading by Larson. No Second and vote is required for a First Reading.

Next on the agenda was to discuss Parade Routes. At the January 4, 2023 City Commission meeting, the Commission decided to not allow parades on 5th Street due to costs and permits. Due to concerns about the tradition of the parades on 5th Street, the SD DOT will allow parades as long as the City follows the Manual of Uniform Traffic Control Devices and the City uses a required detour route and signage. Motion to allow parades as long as they follow the guidelines and acknowledge that the City is liable for the costs associated with it by Garbers. Seconded by Larson. Unanimous approval.

The final item under New Business was to Set Hearing Date for Proposed Resolution for Sidewalk Installation for the Beaver Creek Trunk Line Sewer Project. City Attorney Nelson has mentioned that State Law has changed and said that the City should hold this Hearing. Motion to set the Hearing Date for October 2, 2023 by York. Seconded by Chaon. Unanimous approval.

With no Commissioner Dialogue, motion to adjourn at 7:22 p.m. by Larson. Seconded by York. Unanimous approval.

“Movement as Medicine” Cross Country Sets New Personal Records

Tenacious Training is a fitness business, fitness group and more! TT offers many programs ranging from accountability coaching to advanced resistance training. All the programs can be completed at home, in a gym, or in person with trainer Natalie Minihan. TT offers private sessions, online coaching, and can also be accountable to check in with clients to keep them on track with their goals.

Minihan has a bachelor's degree in Exercise Science from Dakota State University. She built this business in college as part of her senior project and thought, “Wow this could go somewhere!” Her mom, Cami Van Wyhe, helped her



instead because it's quick and easy, rather than doing the hard work exercising for 60 minutes a day. Her favorite part of exercise is meeting goals. She works out as a way of self-care. When a set timed run goal or weight goal in the bench press is met, she can finish the session knowing her training has paid off. The same goes for her clients. She finds “non-scale” victories exciting. For example, when a client messages her and says, “I got a PB (personal best) in my squat today!” Minihan has a network of people and services to connect clients with if they have nutritional needs, chiropractic needs, supplements and more. She acknowledges that fitness may not be everyone's favorite thing but wants to be able to help clients in whatever way she can.

At the time she started the business Minihan was hoping to make a little extra money while using her degree. Her first program was a 4-week running program for beginners that could be compared to a “Couch to 5K.” Since then, TT has expanded to a business Facebook page that offers in-person sessions at Amber Van Dam's Pound studio in Canton. Heartland Spaces has made t-shirts for TT and Lydia Gerber made the logo.

Minihan is mostly a private session leader. This September she will be trying a yoga class after a few successful runs with Pound class (@POUNDbyAmber). Since this is just a part-time gig for Minihan, it will be working around her full-time schedule. She has two in-person classes for September - if these go well it will become weekly. The September dates are the 15th & 25th at 6am. These

classes will be at the Pound Studio behind Anytime Fitness. She asks people to please bring a yoga mat and water if they attend.

She offers mobility, yoga, strength, running, you name it. These classes come in 30, 45, and 60-minute intervals with 1-5 people in attendance. Drop-in yoga classes are \$10. She has plans for all people starting from \$20 up to \$70 per session. For now, Minihan asks you click “going” on the Facebook event if you plan to come to one of these sessions. This helps her get a better idea of how many people may be coming to a class session. Clients can also just show up, everyone is welcome. If you are interested, you may send a message to get put on her private session schedule.

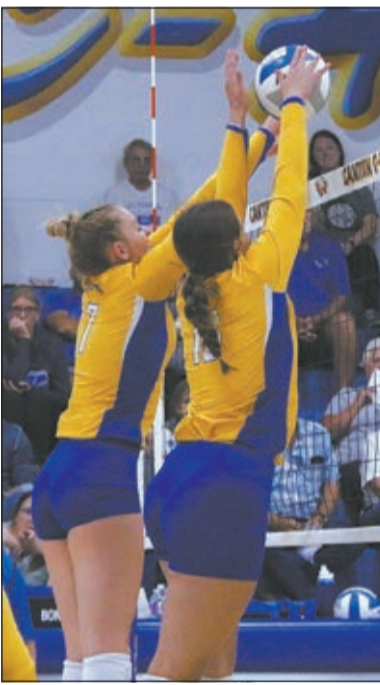
