Canton Alumni Serving Community by Providing New In-home Care Services

Katlin Johnson, formerly Katlin Limoges, grew up in Canton. She graduated Canton High School in 2007 and went on to college at SDSU, receiving a Bachelor of Science in Health and Human Sciences. In 2009, she met her husband Keith at college, and they were married in 2013. In 2015, she became a licensed nursing home administrator, serving in De Smet, SD. During December of 2020, her husband and two children Theo (now 7) and Odin (now 4) moved back to the area, and they now live in Sioux Falls. Johnson has served as an Executive Director of an Assisted/Independent living community as well as a Memory Care Director, which helps people living/affected by Alzheimer's and other dementias. She is a Certified Dementia Practitioner, board member of the "SD Parkinson's Foundation" and a Diplomat with the "Greater Sioux Falls Chamber of Commerce." Last year, she was nominated in the category of "Young Women of Achievement" award for the "EMBE Tribute to Women," which is an event that recognizes and celebrates contributions of women and men in the community. Johnson opened "Cornerstone Caregiving" last June, which serves people in Sioux Falls and the surrounding communities, including Canton, as well as areas in and around Brookings and Watertown.

Cornerstone provides non-medical care including assistance with bathing, dressing, grooming, meals/grocery ordering, medication reminders, light housekeeping, laundry, pet care, assistance with exercise, companionship, and transportation for appointments/outings. They are VA contracted and support Veterans in understanding their options to receive financial support for their care. They also provide Respite care (giving family caregivers a break) Hospital

Recovery Care, and being a certified dementia practitioner, Alzheimer's/Dementia Support. They partner with hospice to make sure the needs of the client are reached at times when hospice is available to be present. Caregivers work with therapy by assisting clients in following therapy driven exercises and work with skilled nursing and independent/assisted living communities to help meet the needs of those they serve. They also work with home health, which is the medical/nursing side of care in the home.

Johnson says what sets Cornerstone apart from other in-home care companies is her knowledge and background. From being involved with healthcare for 13 years, she is an expert when it comes to helping people understand their options, having served in every setting. It is more important to her that people understand their options to make the best decision for them/their loved ones, than it is getting them as a client. By being a certified dementia practitioner, Johnson can offer support and knowledge as clients and families meet the challenges that come with Alzheimer's and other dementias. This may be by helping them to come up with interventions or by being someone they can talk with about their disease and how it is affecting their lives. Unfortunately, it is not common to talk about Alzheimer's and other dementias, so people with these diagnoses often isolate and struggle silently.

What Cornerstone considers "normal customer service" surprises most people as clients have commented on the caregivers going "way above and beyond expectations." Hearing those comments makes Johnson proud, but also sad, knowing that so many businesses are okay with being mediocre. She believes people deserve their respect and reminds caregivers to always serve to the



best of their ability. Their top-notch customer service includes 24/7 support, same day start, no minimum hours, and flexible scheduling to meet customers' needs. Cornerstone also supports the community. Johnson even offers incentives to her staff for volunteering in the community. They support the community through Johnson's service as a diplomat on the Chamber, through fundraising for Alzheimer's,

Parkinson's, our Veterans, and by attending non-profit fundraising events. They support local businesses and help to lift up new businesses. As an example, Cornerstone supported Canton's very own "Crumb and Candy" operated by Mandy Grosky. Cornerstone purchased suckers from Grosky with their logo to hand out to healthcare partners as a thank you.

Babe was born on August 20, 1944, in Hudson, SD, at the family home just east of Hudson. She was the fifth child of Clay and Lucy (Duncan) McKee, and was named after her midwives Velma McVay and Marie DeBondt. She would eventually be known to many as Babe.

She attended Garfield country school until age 8, when the family moved into Hudson. She then attended school in Hudson, where she proudly received penmanship awards. She never had a television growing up, and instead she would play with dolls, collect rocks, go to movies, and roller skate. She also adored Elvis Presley and collected Elvis memorabilia. In addition to having four older siblings, Babe became an aunt at the age of six. Her siblings, nieces, and nephews always had a special place in her heart.

Babe married the love of her life, Ward Miller, on December 30, 1960, in Pipestone, MN. Becoming part of Ward's family then brought her nine more siblings, and dozens more nieces and nephews to love. Ward and Babe were blessed with five children: Rick, Bob, Rox, Ryan, and Weylin. They made their home in Hudson until they moved to Canton in 1984.

Her first job was setting pins at a bowling alley in Hudson making 10 cents a line. She also had jobs as a waitress, nurse aid, teachers' aid, and provided in-home daycare services in both Hudson and Canton. She sold Figuettes and Avon and worked at Hardware Hank, A&R

Grocery Store, and Canton Food Center. She also helped with Ward's businesses over the years when he was selling cars and houses. Her most favorite job of all, though, was the job that came with the title of Mom, which later came with the bonus title of Grandma Babe!

Babe had the most fun-loving personality and credited it to being Irish. She enjoyed playing cards, dancing, especially jitterbugging with Ward, organizing family gatherings, baking, and cooking. If someone unexpectedly stopped by the house, she could pull a meal together in no time. Her children's friends were always welcome and found a special place in her big heart, which was later carried on to the grandchildren's friends as well. Her children and grandchildren participated in several activities across the decades. Ward and Babe were always there to support. Sitting in the bleachers, she also made lifelong bonds with other parents and grandparents as they watched their children's and grandchildren's activities over the years. Neighborhood kids would always find her waiting with a treat for them as they passed by her house. Her heart was so full of love, and she shared it when teaching Bible school, volunteering to help others, and just loving all people. Her friends were also a treasured gift to her, and if you had time, she would love to have some ice cream with you.

Babe's faith was unwavering. She was confirmed at Hudson Congregational Church, and was a member of both the Hudson Lutheran Church and Canton Lutheran Church. She taught bible school and rarely ever missed a Sunday service. Babe faced many challenges in life, but through it all, she relied on her faith and leaned on God. It is a great gift to all of us to know that she never doubted God was with her through all of the hardships.

Babe was diagnosed with Alzheimer's in 2016. After Ward passed in 2017, Babe then lived in Hudson with her daughter and son-in-law. In 2019, she moved to Canton to live at the Canton Good Samaritan Society. She quickly gained the love of staff and residents as this became her home until her passing. Staff and residents would tell you she was always trying to find a ride back to Hudson, and never stopped loving Ward.

Blessed to have been loved by Babe are her five children Rick (Ruth) Miller of Sioux Falls SD, Robert (Renee) Miller of Boca Raton FL, Roxanne (Steve) Wickre of Hudson SD, Ryan (Gina) Miller of Lake in the Hills IL, and Weylin Miller of Harrisburg SD; sixteen grandchildren Josh (Jess), Tracy, Kate (Pat),

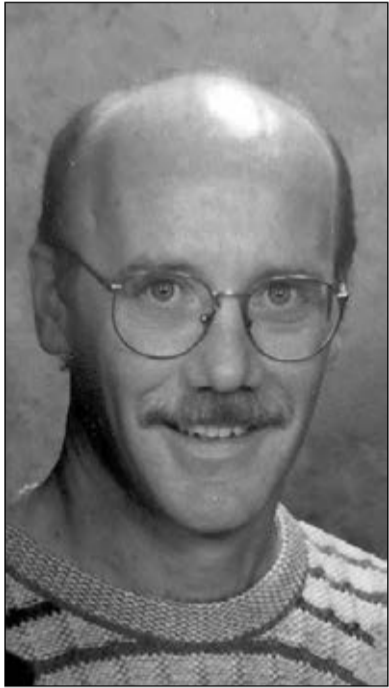

The Canton Rural Fire Association solicited donations over the past two years to cover the cost of a replacement pumper truck for the 1978 International the department purchased in the early 1990s.

In this past month, here in Canton, we have lost a wonderful and respected high school teacher, Scott Heisel. He had a B.S. in Chemistry with a minor in Philosophy at SDSU. Mr. Heisel taught Chemistry, Physical Science, Conceptual Chemistry, and Physics. These are some of the more challenging classes that are offered in Canton; they require lots of math and an understanding of all the elements and other factors that we cannot see, but are present, in the world today. But all wanted to raise money for his family so that they can pay off bills and help his children in the future for college. The Student Council was called to order and they started to throw out ideas. They thought about what kind of fundraisers they have done in the past. They have sold suckers, pop, and other types of candy. But really wanted to do something different and special, because we all lost a friend and a mentor to many students. They decided to do a fundraiser but add science to their

idea, because of all the classes that he taught. The idea chosen was the Diet Coke and Mentos experiment. A student or teacher could buy a bottle of diet coke for ten dollars and the person who bought it would be able to drop the Mentos himself or herself out on the football field, in the formation of an H for Heisel.

If a student comes to kindergarten and has been read to for 1800 hours, he/she will have a vocabulary of about 10,000 words. The Demise of the Canton Bed Spring Factory

(The following story was written by Wendel W. Waldo in 1893. Mr. Waldo was a local historian and founder of Canton's oldest business, Waldo's Brewery, that is still flourishing today. It tells the astonishing story of a bed spring factory that was once located here. It's owner became one of the wealthiest men in the history of Dakota Territory and there were people back in the late 1800's that thought Canton's name should be changed to Thorunsonville City. Enjoy)

Once a thriving business with a very promising future, the Canton Bed Spring Factory closed its doors on March 22, 1887. The news hit Canton hard and being it was by far the largest employer of mostly Scandinavians in the tri-state area. Five hundred plus families would now go without a paycheck and a Let's Help Our Good Friends Shall We Smorgasbord was quickly planned to raise funds for those affected by this horrific news.

When Thurgood T. Thorunson arrived in Canton in 1869 he immediately went to work making bed springs in his home which he claimed would be "the most promising invention of the century." Some folks just laughed when he rented a small building on the South Main Street and began making bed springs with his four sons, Thurgood Jr., Thondor, Thorollie and Thorville. Little did they know that Thurgood Sr. had a very lucrative contract with the largest bed manufacturer in North America, the Old Country Bed Works, located in Milwaukee, Wisconsin. Within six months Thurgood and his sons had outgrown their small shop and made plans to construct a real factory that would cover an entire block of downtown Canton.

By far the largest and most expensive building project ever undertaken in our Gate City it took over a year to complete. Once it was ready Thurgood hired 89 strong and husky Scandinavian men to start making bed springs. This factory operated 24 hours a day Monday through Saturday with Sunday off. Three eight hour shifts turned out 1200 bed springs every day. Most of them ended up in Milwaukee but Thurgood also had clients in Cleaveland, Toledo, Chicago and St. Paul.

Money poured into the Canton Bed Springs coffers and within three years two more blocks of downtown Canton had factories covering them. Thurgood and his wife Thelma had built a three story mansion close to the Standpipe that had a huge indoor swimming pool and an eight stall garage for all their expensive carriages and boats.

Things got even better when the Canadian Bed Company, located in Winnipeg, Manitoba, began using bed springs made in Canton. Over 500 employees were now working for Thurgood and our town was bursting at it's seams with new homes going up every direction from the courthouse square. Some residents thought Canton's population would soon surpass Sioux Falls and Sioux City but then things quickly ran amok.

It seems Thurgood and his employees were at odds over the hourly wage offered by the Canton Bed Spring Factory. Thurgood would not give in to the demands of his workers for a pay raise telling them, "Boys you have the best darn jobs in America." His workers then united, went on strike and surrounded the three blocks where Thurgood's factories stood. For over a week they wouldn't let him or his sons through to get to their offices.

It was a Tuesday morning when Thurgood Sr. and Jr. showed up and were again denied entrance. Thurgood Sr. then turned to his son and said, "Let's go for a stroll. It's a beautiful morning and I'm really tired of this nonsense." They calmly walked away and headed uptown. Stopping at all of the five banks in Canton. They withdrew an estimated \$17,000,000 from their accounts. Heading home, Thurgood Sr. told Thelma to start packing up their belongings.

The following day a special train arrived in Canton and it took three days to load up everything the Thorson's owned including three expensive pianos, an organ, and a very large collection of Norwegian art valued at \$9,000,000. As Thurgood boarded the train, he turned and proclaimed, "Adios my friends. It's quite an adventure here in Canton. My family and I are moving to Burma where I hope to establish the world's largest pillow factory. I gift my three large factory buildings and my mansion to the City of Canton. Do what you like with them. So long and we'll see yo in the funny pages."

At the next monthly meeting of the city council there were some that wanted to keep the bed spring factory going under new management. But the majority of the council thought there was a better way to utilize this incredible gift they had been given. They finally voted to turn the Thorunson Mansion into a hospital and convert the factories into reasonably priced apartments for retirees and the aged. Each of the three buildings would have a heated swimming pool, library, a small theater and in the very center would be an open space with trees and a flower garden.

So, how could the city afford to do all this with 500 men now out of work with families to feed? Well, the day after Thurgood and his family left Canton never to be seen again, our mayor at that time, Helmer Jurgunson, received a check in the mail for \$4,500,000. It was made out to the City of Canton and was signed by Thurgood T. Thorunson Sr. A note attached to it read "When you do something big, do it right or don't do it at all."

All those out of work bed spring makers now had new good paying jobs converting a mansion into a state of the art hospital and three very large buildings into apartments for Canton's elderly residents. And there was more good news. A report had just come out saying that area farmers now had more money in the bank than ever before thanks to a bumper crop last fall (1886). Also talks were going well with the makes of a new fangled steam powered horseless carriage to move their factory from Dearborn, Michigan to Canton sometime this summer. It seems that when things get really bad there's always something that comes along that brightens the skies over our fair city of Canton, South Dakota.

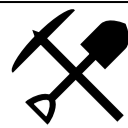

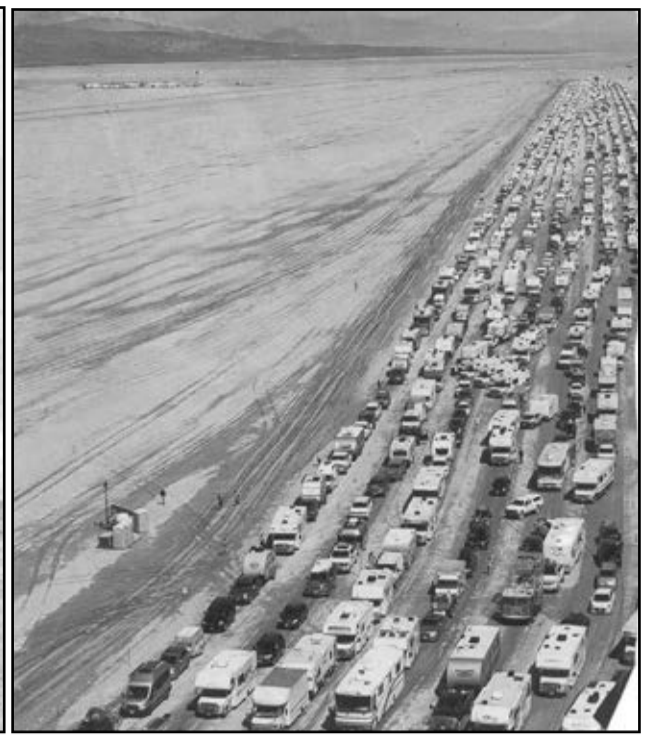

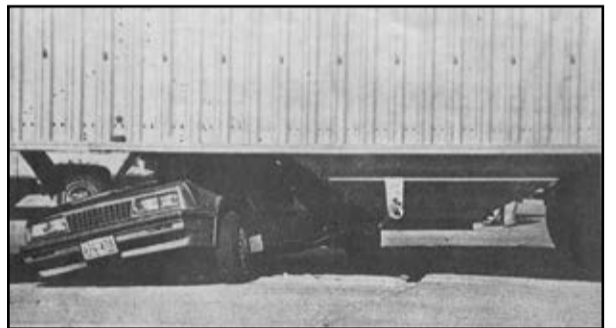
Foolin around OFF The Road With Jerry

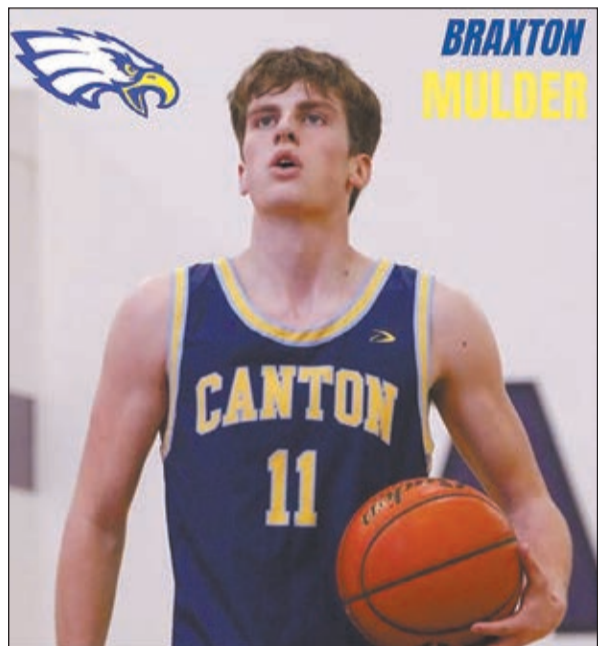
Sportstalk

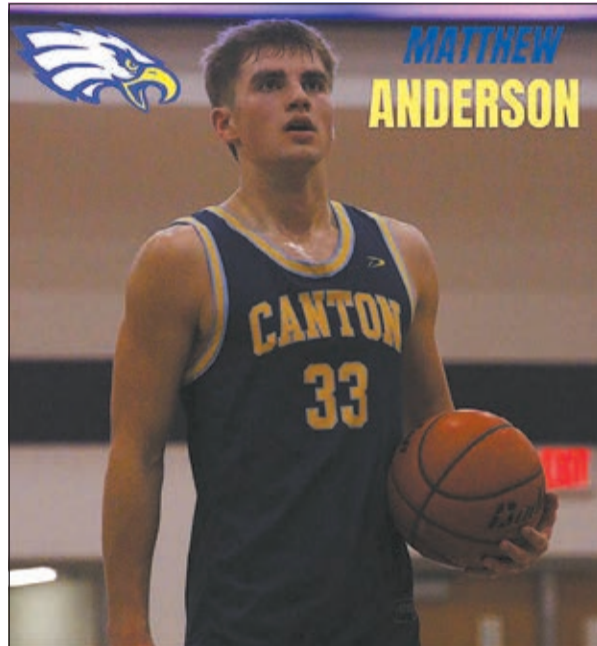

Commission Sets to Identify 8th Grade Quiz Bowl and Remove Ash Trees

The Canton City Commission met in regular session on Monday, March 18 at 7 p.m. at the Depot. All Commissioners were present at the time of roll call.

The first item on the agenda to Convene the Board of Equalization for the Special Meeting on Tuesday, March 19 at 6 p.m. Mayor Sandra Lundstrom called the Commission Meeting back to order.

Under Visitors to be Heard, Citizens Deb Esche came to the podium to speak about the current late fee of \$50 on the water bill and the fee of \$200 to turn the water back on. Commissioner Paul Garbers explained the shut off fee and noted that most of the time, the water is shut off during the Winter months and they have to send two of the City employees to turn the water back on for the citizens. Esche asked why the City is preying on those who are already behind on their bills. Garbers said that struggling Citizens can always contact City Hall to see if any extended deadline can be negotiated.

Esche also brought the issue of communication from the City. Finance Officer Kyle Cwach mentioned that they are required by State Law to publish in the City's official Newspaper(s). Mayor Sandra Lundstrom said a new app is coming out with the new City website and it will vastly improve the coverage of communications to the citizens of Canton.

With no other Visitors to be Heard, Mayor Lundstrom read two proclamations for the Boys and Girls Wrestling Squads for their achievements at the State Tournament. Applause occurred after each proclamation was read. Girls state wrestling, Boys State wrestling. Applause occurred from all those in attendance.

The first item under Old Business was a Declaration of Nuisance Trees & Order for Removal - Public Trees. This item was tabled at the March 8 Special City Commission meeting. The Ash Trees in the City of Canton are infested with the Emerald Ash Borer and are slowly dying. A declaration was issued with a March 1 deadline to remove Ash Trees on the Public Property/Right Away. Citizen Tanya Iverson wanted a time frame for trees on private land and the City should be cutting the boulevard trees. Citizen Jesse Vosika asked if the City applied for the DANR grant and Cwach said they are looking for ways to qualify for grants. Citizen Chris Lodes said that the boulevard trees need to be a priority because they are very dangerous. Lodes suggested that neighborhoods and neighbors work together to remove the trees. He also suggested that the City set a deadline sooner rather than later to avoid more dangerous situations. Citizen John Lems displayed a piece of a tree that he cut to show how dry and fragile that the Ash Trees have become. Esche mentioned that the City needs to have a firm plan with the dates of removal and

communicate to the Citizens.

Citizen Perry Fossum commented that cleanup days should be suspended in favor of tree cleanup. Citizen Jason Bryan concurred with Fossum. Citizen John Anderson commented that Citizens need to volunteer and the City needs to help with equipment. Anderson also mentioned that the City should not be purchasing things that are not needed at this time until the cleanup is completed. Citizen Rosalinda Kelmer said that there should be coordinated effort on cutting down trees to save on cost.

After much discussion amongst Citizens and the Commission, a motion was made. Motion to move the Declaration of Nuisance Trees & Order for Removal until November 1, 2024 and Citizens will have until April 18 to ask for help identifying the trees on their property and that the identification process will need to be done by April with volunteers to help with cleanup of cut down trees on June 7-9 and request that all cars be removed from the streets starting June 6-9 by Garbers. Seconded by Commissioner Tyler Larson. Commissioner Jerry Chaon aye. Garbers aye. Larson aye. Mayor Lundstrom aye. Commissioner Kris York abstained. Unanimous approval.

The final item under Old Business was the Declaration of Nuisance Trees & Order for Removal - Private Trees. This item was tabled at the March 8 Special City Commission meeting. Motion to table until the June 18 City Commission meeting by Garbers. Seconded by Larson. Chaon aye. Garbers aye. Larson aye. Mayor Lundstrom aye. York abstained. Unanimous approval.

The first item under New Business was the Rezone Hearing - Hope & Jason Bryant at 305 North Noid Road. Planning & Zoning conducted their hearing on February 27 for the proposed ordinance for Bryants for a rezone and recommended the approval of approval. Mayor Lundstrom opened the hearing. Mayor Lundstrom closed the meeting. Mayor Lundstrom opened the hearing. Bryant took to the podium to answer any questions. With no questions, Mayor Lundstrom closed the hearing. Motion to give the First Reading by Garbers. No second and vote is needed for a First Reading.

Canton Civil War Days - Bridge Street North to Lynn Street on August 16 - 18 from 12 p.m. to 5 p.m. and West Road to Lynn Street on August 16-18 from 8 a.m. to 5 p.m.

Motion to approve by Garbers. Seconded by Larson Unanimous approval.

Next on the agenda was to Advertise for Open Position - Public Works. It is being recommended to advertise for the Public Works Street Maintenance position. Motion to approve by Chaon. Seconded by Larson. Unanimous approval.

Next under New Business was the Appointment of Commissioners to the Union Negotiation Committee. It is being recommended to appoint two members of the Commission to the Union Negotiation Committee to act as liaisons to the City Commission. Motion to appoint Mayor Lundstrom and York to the Union Negotiation Committee by Garbers. Seconded by Larson. Unanimous approval.

Along with the appointment, the Wage for the Union Negotiation Committee was next agenda. It is being recommended that \$30/meeting be established for the appointees on the Union Negotiation Committee. Motion to set the rate of pay at \$30 per two hours of meeting time by Garbers. Seconded by Larson. Unanimous approval.

Next under New Business was the Slurry Seal Notice of Award. The Slurry Seal Project was bid by the City of Sioux Falls and they have awarded the bid to ASTECH out of St. Cloud, Minn. CITY OF HARRISBURG ORDINANCE# 2024-02, TO AMEND THE ZONING REGULATIONS BE IT ORDAINED by the City Council of the City of Harrisburg as follows: ARTICLE I - PURPOSE AND JURISDICTION SECTION 1- PURPOSE. Ordinance #2024-02 is an ordinance to amend the Keeping of Chickens Regulations section of the Zoning Regulations of the City of Harrisburg. The City Council of the City of Harrisburg has deemed these regulations and controls to be reasonable and reasonably related to the purpose of promoting the health, safety, and general welfare of the City of Harrisburg. SECTION 2 - JURISDICTION. This Ordinance shall govern all territory within the statutory jurisdiction of the City of Harrisburg, South Dakota. 5.12 Chickens. Any resident wishing to keep chickens shall first apply to the City and upon approval shall comply with the following use-specific standards and requirements. Definitions: Words, when used in this chapter, unless the context plainly refers, shall have the following meanings: Brooding: The period of chicken growth when supplemental heat must be provided due to the bird's inability to generate enough body heat. Chick: A baby chicken not more than six weeks old. Chicken: A domestic bird of the order of Galliformes in the genus of Gallus (chickens) that serves as a source of eggs. Cockrel: A young male chicken. Coop: The structure for the keeping or housing of chickens permitted by the ordinance. Exercise yard: A fully enclosed and escape proof area that provides space for exercise, foraging, and roaming for the birds. Hen: A female chicken. Officer: Any person designated by the City Council or the City administrator as an enforcement officer. Rooster: A male chicken. Revokable Permit: Upon approval of a permit, residents may keep and maintain brooding chicks and hens for egg(s) in a clean and sanitary manner that is not a nuisance to or detrimental to the public health, safety, and welfare of the community. The permit may be revoked if the permit holder refuses to or fails to comply with this chapter, or with any federal, state, or local laws governing cruelty to animals or the keeping of animals. Investigation and Enforcement: Officers designated by City Council, or the City Administrator shall have authority in the investigation and enforcement of this chapter, and no person shall interfere with or hinder any such officer in the exercise of such powers. Such officers shall make investigations as is necessary. General Regulations: A. Chickens may only be kept within areas of the city zoned to permit single-family dwellings. B. No more than six hens shall be housed or kept on any one residential lot. C. Roosters and chicken breeding are prohibited. Cockerels must be culled from broods when identified. D. A coop and a reasonably satisfactory exercise yard is required to house chickens. Chicken facilities must be constructed and maintained to meet the following minimum standards: 1) Located in the rear or side yard. 2) The setback required for the coop and exercise yard is three feet from the

rear and side property lines. 3) Coop construction and materials must be adequate to prevent access by rodents. 4) The coop and exercise yard must be maintained in good repair. 5) Coop and exercise yard areas may not occupy more than 30% of the rear yard. 6) Coop and exercise yard areas shall be enclosed with escape-proofencing and/or netting. 7) Chicken feces and waste shall be disposed of in a sanitary manner and be kept separate from other household waste or garbage. 8) Manure storage shall be kept a minimum of 20 feet from streams, tributaries, ditches, storm water management facilities, drop inlets, or other storm drainage areas that would allow fecal matter to enter any city storm drainage system or stream. Dumping animal waste into the city storm drainage system is prohibited. 9) Chickens must not be housed in a residential house or an attached or detached garage, except for brooding purposes only. 10) All premises on which chickens are kept or maintained shall be kept clean from filth, garbage, and any substances which attract rodents. The coop and its surrounding areas must be cleaned frequently enough to control odor. E. Chickens shall not be kept in such a manner as to constitute a nuisance to the occupants of adjacent properties. F. Dead chickens shall be disposed of within 48 hours after death. Legal forms of chicken carcass disposal include burial and off-site incineration or rendering. G. All grain and food stored for the use of the chickens shall be kept in rodent proof containers. H. Chickens shall be kept so that visibility is substantially obstructed at a height of five feet above ground level to the traveling public or surrounding property owners. BE IT FURTHER ORDAINED by the City Council of the City of Harrisburg that this Ordinance shall become effective in accordance with law. 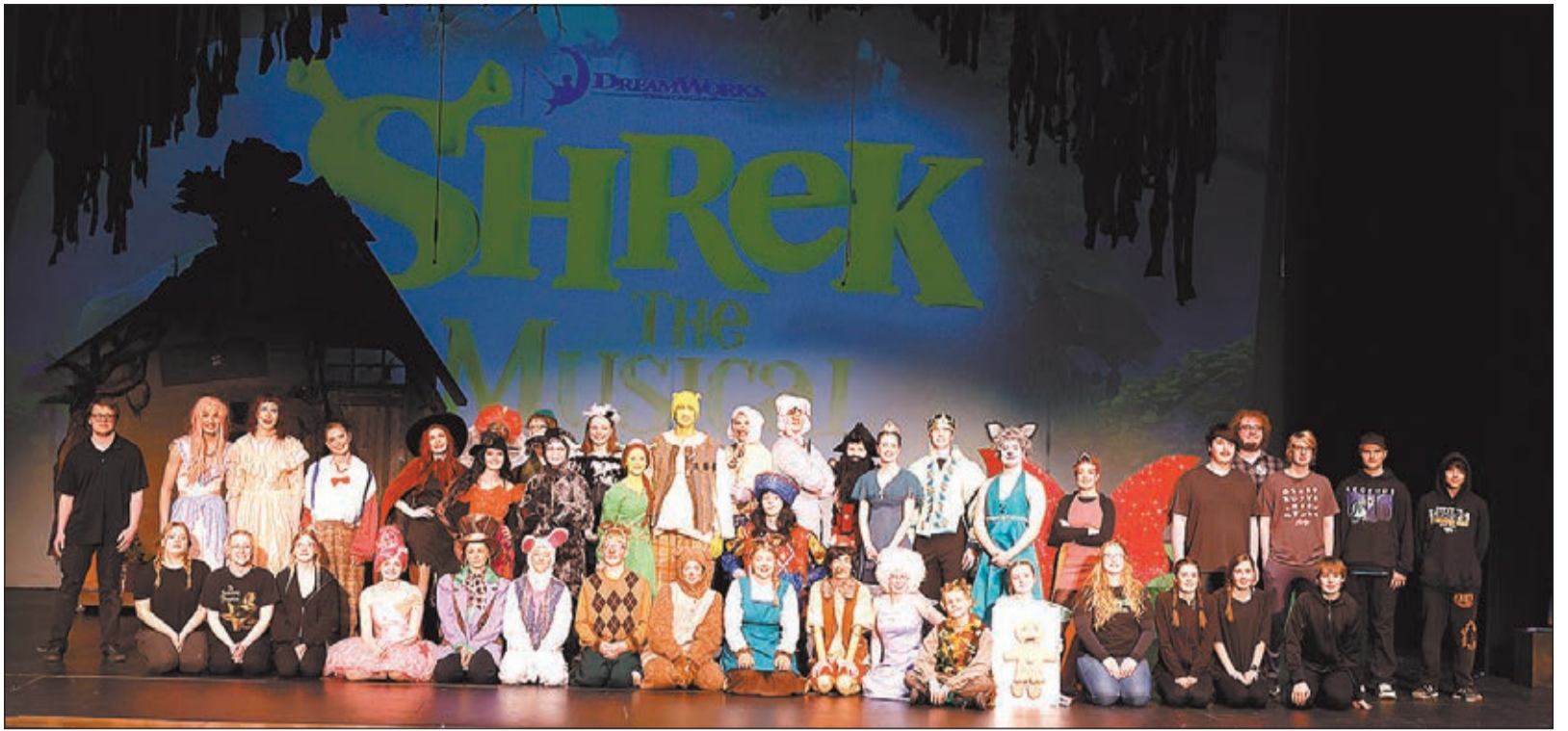
