## Ash Trees and Emerald Ash Borer

The outlook of Ash Trees in Canton has been the discussion in town for the last few months. There is no doubt the Emerald Ash Borer is here and has killed many trees. Now it is time to get those trees down before they cause harm or damage to Canton.

The first confirmed Emerald Ash Borer case was found in Sioux Falls in 2018. Since then it has spread to many other communities and there is no stopping this bug now in Canton. Lennox is now seeing many cases in their town and will soon be in the same position as Canton.

The city of Canton has an updated declaration of nuisance trees and order for removal of Ash trees was approved at the March 18, 2024 City commission meeting for all public (boulevard) ash trees to be removed by November 1, 2024.

If you would like to volunteer to help with ash tree clean up, call City Hall at 605-987-2881 to be added to the list.



### DECLARATION OF NUISANCE TREES AND ORDER FOR REMOVAL

To the owner of, occupant of, person in charge, or other persons responsible for the property. Pursuant to 97.09 of the City of Canton Ordinances, any tree, sapling, or growth of Genus Fraxinus, commonly known as ash, located within the city limits of Canton, is declared to be a dangerous tree and a nuisance unless treated with Emamectin Benzoate on or before September 15, 2023. Removal of all untreated Genus Fraxinus trees, saplings, or growth of Genus Fraxinus located within the parking strips and boulevard within the city limits by the adjoining property owner is ordered to occur on or before November 1, 2024.

Removal of untreated Genus Fraxinus is necessary to preserve public health and safety and to prevent the spread of disease or insects to public trees and places.



Arrow Tree Care took down nine ash trees that were dead in Canton last week. Kris York is extra careful taking these trees down because the structures of these trees are very weak.

The Emerald Ash Borer is an exotic borer responsible for the loss of hundreds of millions of ash trees across North America. It kills or will kill ALL of our native ash trees. It was first discovered in Detroit, Michigan in 2002 but was first confirmed in South Dakota in 2018. The insect is now found in Lincoln, Minnehaha and Union Counties so far.

It wasn't until 2020 that the Emerald Ash Borer was confirmed in Canton. The insect has now spread throughout the community and surrounding countryside. Every ash in Canton should be assumed to be infested by this insect.

### The Fine Glass Bowl

My wife has a fancy glass punch bowl that she uses for special occasions. She recently used it for serving drinks at a baby shower and then a week later she filled it with a desert for a family gathering.

My wife also has a large cast iron pot that is about the same size. I do not have to be nearly as careful with the cast iron. I can put it on the stove or into the oven. I can drop it and not worry about breaking it. I can bang a large serving spoon on the side of it to get some stuck on stew off of it. I cannot do those things with the glass punch bowl.

The contrast between the punch bowl and the cast iron pot reminds me of what Peter wrote about wives. "You husbands likewise, live with your wives in an understanding way, as with a weaker vessel, since she is a woman; and grant her honor as a fellow heir of the grace of life, so that your prayers may not be hindered." (1 Peter 3:7) Notice that the passage does not say that wives are weak, but that husbands are to treat her like a weaker vessel. In other words, I am to treat my wife like the beautiful punch bowl, not like the old cast iron pot. That means I need to treat her as someone valuable who I am very careful with.

Notice that the way to treat her carefully is to understand her. Just like I understand that glass can break and that the punch bowl should not be put on the stove or into the oven, I need to understand what could hurt my wife. I must be careful to avoid doing actions that would hurt her.

A few verses before this, the wives were told to be gentle and of a quiet spirit and the example of Abraham's wife Sarah was given. A quiet spirit is not the idea of never sharing her opinion, it is rather the idea of being easy to get along with.

In order for husbands to know how to avoid hurting their wives so that their wives are easy to get along with, they must be able have an understanding of what their wife is thinking and feeling. That means that a wife must have the freedom to share her opinions. We are able to read in the book of Genesis that Sarah did just that in Genesis 21 when she told Abraham her thoughts about Hagar.

Peter also says that Sarah called Abraham lord. That term is not used there to mean "God", but rather it means leader. In other words, Sarah was willing to let her husband lead,

but she was also able to express her opinions in how he should make leadership decisions. Any good leader will listen to advisors and for the husband, his advisor should be his wife.

As a husband gets advice from his wife he is better able to dwell with her in an understanding way and thus better able to treat her like the valuable glass bowl. This doesn't mean that the wife should always get her way, but it also shows that the husband should not just selfishly make all the decisions without regard for his wife. Sarah honored Abraham and let him lead, but notice that in 1 Peter 3:7, the husband is also to honor the wife and to treat her carefully.

In Ephesians 5, the Apostle Paul shows us how the husband wife relationship is to be a picture of Christ and the church. We as Christians are to follow the leadership of Christ, but he loved us so much that he understands us. He even became a human like us. Further, he cares about our needs and our comforts. Therefore, we as husbands should put ourselves in our wife's shoes to understand her.

If we refuse, our prayers will be hindered and that makes sense. Why should God listen to us if we refuse to listen to our wives? "To sum up, let all be harmonious, sympathetic, brotherly, kindhearted, and humble in spirit;" (1 Peter 3:8). www.southtownchurch.com

# HISTORY REVISITED

In the 1966 Centennial Edition of the Sioux Valley News, Jim Meachen wrote "The Farmers Leader, known as the Dakota Farmers Leader until 1918, was first printed in 1890. However, in the 1930's the paper claimed in its masthead that it originated in 1885, 13 years after the Sioux Valley News was founded."

The Leader was first owned and founded by the Farmers Publishing Company, an organization of farmers in the southern part of Dakota that fearlessly advocated for the rights of not only the farming community but mechanics, laborers and artisans alike. The paper supported the Farmer's Alliance, and independent political party formed at that time.

"In 1891, the Dakota Farmers Leader published a directory containing the names and addresses

of most people living in Canton. This book also contained an early history of Lincoln County and Canton." I will be using excerpts from this early history for this weeks column.

Happy reading as we enter the third week of April. With temps in the 70's (maybe 80's) being forecasted does that mean winter and all it has to offer is behind us? I hope so. ## What's in your Medicine Cabinet?

Spring cleaning this year? Don't forget to include your medicine cabinet! Many of us accumulate multiple medications over the course of a year, whether it's over the counter medication for a pesky cold or stronger medication prescribed to us by our doctor for a more serious medical condition. April 19, 2024 is National Clean out your Medicine Cabinet Day which occurs annually on the third Friday in April. This day is a great reminder to take a little bit of time to clean out your medicine cabinet of any expired, unused, or no longer needed medication.

Storing unneeded and unused medications in an easily accessible cabinet at home can put your loved ones, including children, adults, and pets, at risk for misusing medication or having an accidental overdose. 65.9% of opioids are obtained by people through a friend or relative (either for free, for a charge, or from theft), so it's important we take stock of our inventory and dispose of the medication we no longer need.

Keeping expired medication around in the case of needing it again is not advised. According to the U.S. Food and Drug Administration, expired medications become ineffective and dangerous due to a change in chemical composition that typically takes place over time and/or when the conditions in which the medications are stored changes.

Lastly, it's important to refrain from keeping leftover prescription

medication such as pain medication or antibiotics to give to others when they are ill or to self-medicate. Medications prescribed by a doctor are intended to be used with the instructions listed on the bottle, and they can only be deemed safe when used correctly by the person they were prescribed to.

What are the types of medication that should be removed from your medicine cabinet?

- Any expired medication (including vitamins, supplements, creams, over the counter medicine and prescription medication);
- Any medication that is unmarked, not in the original container, and that you are unsure of its expiration date and what type of medication it is;
- Any medication that has changed in color, smell or taste or if it has been exposed to too much light as the medicine may be altered and therefore risky to ingest; and
- Prescription medication that you are no longer taking (pain medication for an acute condition, antibiotics, etc.).

What should you do with the medication you have removed from your cabinet?

1. Drop it off at a drug take-back location as take-back sites will properly and safely dispose of the medication for you. Many pharmacies and police stations accept medication year-round, and there are several take-back sites in SD that can be found using this link <https://www.avoidopioidsd.com/take-action/safe-medication-disposal/>.
2. Dispose of your medication by using a Dispose RX packet. Once mixed into the medication bottle, the Dispose RX packet chemically and physically neutralizes the medication thereby making it ineffective as well as safe for the environment when thrown away. Dispose RX packets can be used

with pills, capsules, tablets, liquids, and powders. Dispose RX packets can be ordered for free through this link <https://helplinecenter.jotform.com/form/201986148733059>.

3. If you do not have access to a take-back site or a dispose RX packet, check to see if your medication falls within the FDA's Flush List found using this link <https://www.fda.gov/drugs/disposal-unused-medicines-what-you-should-know/drug-disposal-fdas-flush-list-certain-medicines>. Medications on this list are those that are sought after for their misuse potential and that can result in death from one dose if taken incorrectly. It is only advised to flush medications on this list if there are no other disposal methods accessible because of the greater harm these medications pose to human life if misused versus the environment if flushed.

4. If you do not have access to a take-back site, do not have a Dispose RX packet, and your medication is not on the FDA Flush List, dispose your medicine in the trash utilizing these steps.

1. Remove the drugs from the original container;
  2. Mix your medication with things such as used coffee grounds, cat litter, or dirt to make it unappealing to children and pets and unrecognizable to someone intentionally going through the trash looking for drugs;
  3. Place the mixture in something you can close (a zippered plastic bag or container with a lid) to prevent the mixture from leaking; and
  4. Throw the container in the trash.
- It is extremely important to dispose of medication properly so that we can keep our loved ones and our environment safe. This National Clean Out Your Medicine Cabinet Day, make it a priority to get rid of unused, unneeded, and expired medication from your home.

## HOMETOWN girl

For anyone close to me, they will corroborate the fact that in the past few weeks, I have been down a deep ancestry.com hole. I had only previously known that my ancestor James A. Carpenter, who helped find Beloit, IA, came from Beloit, WI. Where did his family come from? I was encouraged numerous times by my friend, Omar, to research this side of my family tree, seeing as it has so much local history with Beloit. What I have learned since tracing my family tree back, tells a story all on its own. I have traced the Carpenter name back to England and William Carpenter was the first Carpenter name to come to America. He sailed from England on the ship “Bevis” in 1638 along with his wife, father, and four children. His father sailed back to England on the same ship after getting his son’s family settled in Massachusetts.

I have been searching for my 4th great-grandfather, James Addison Carpenter’s obituary for a while now and today when I logged on to my profile, I had a “hint” with an obituary that read “Does this match the James A. Carpenter in your tree?” Indeed, it was the one I had been looking for. Below is a transcription of the obituary from the Lyon County Reporter of Rock Rapids, IA dated Friday, October 11, 1889.

“James A. Carpenter was born in the town of Tompkins, Delaware county New York, August 3, 1821, and died at Beloit, Iowa, October 5th, 1889, age 68 years, 2 months, and 2 days.

James Addison Carpenter was the youngest son of John Carpenter and grandson of Daniel Carpenter who was one of the first settlers of Rutland County, Vermont, who moved there from Massachusetts soon after the Revolutionary war. According to the township records about 100 years ago, John Carpenter moved west which at that time was in Delaware county, New York and where James. A Carpenter was born Aug. 3, 1821, his mother being formerly Dolly Blakeslee of Connecticut so that his parents on both sides were old colonial families of New England from whom he inherited those strong principles of right and justice which have ever characterized his life work. He was one in a family of eight children, four boys and four girls, of whom only one brother and sister survived him.

He attended the district school for a few months each year and assisted in clearing up the old homestead farm and lumbering to raft down

the Delaware river to Philadelphia.

In 1846 his father died and in June of that year he married Sally Tillotson and following in the footsteps of his father and his New England ancestors, he went west by canal and lake to Racine, Wisconsin, located in Boone County, Illinois, where he started to build for himself on a small farm and soon bought a farm of his own where his five children, three sons and two daughters, were born. All of whom are living and were with him in his last sickness.

In 1856, when the first railroad northwest of Chicago was built to Belvidier, Illinois, he went into the lumber business there and when the railroad was established in Beloit, Wisconsin, he moved his family and business there.

In 1857, his wife died leaving him with a family of five small children. He never married again, but with the aid of his wife’s sister, Auntie Tillotson, kept his family together until all were grown up and had homes of their own in the immediate vicinity, but he always kept the old home open and had frequent family reunions when he would gather his children and grandchildren together.

In 1870, in company with his two sons he again went west and came to the Big Sioux Valley where he was so well pleased that



he bought a large tract of land and the waterpower and improved it, calling the place Beloit after his old home and moved his family and has ever since resided.

As one of the pioneer settlers of Lyon County, he will long be remembered. During grasshopper time he was always willing to divide what he had with those in need and many there are that can testify that he would almost distress himself rather than a willing but unable creditor.

He has been a great sufferer for years and has visited several eastern hospitals to have cancer removed, but owing to the location, he was unable to have it done. His last sickness was only for a week with inflammation of the bowels causing him much suffering but retaining consciousness until the last when he passed away peacefully and happy in his faith.”

It is crazy (and fun) for me to follow the invisible strings within my family tree. Seeing where they started and why my family is located where they are today. I have even found some “famous” people within my family tree, but I will save that story to write another day.

# Rerouting

**BIG Update**  
The United States Postal Service (USPS) recently announced plans to move mail processing centers from Sioux Falls to Omaha, Nebraska, and from Huron to Fargo, North Dakota. Due to this change, South Dakota will be left with no regional mail processing facilities. This move will require any mail sent from Sioux Falls to Chamberlain, for example, to go all the way to Omaha then back over to Chamberlain, a 500-mile journey. This move is inefficient and will delay mail routes across South Dakota, not to mention dozens of South Dakota jobs being lost.

I sent a letter with Senators Thune and Rounds to USPS Postmaster General Louis DeJoy urging him to re-evaluate this adjustment in services to avoid mail delays and disruptions in South Dakota. Rural South Dakota relies on these mail processing centers to get their mail and news in a timely manner. I hope the Postal Service reconsiders this decision.

**BIG Idea**  
The South Dakota Trucking Association came to D.C. to talk about speed limiting devices in trucks. We are both opposed to a proposed rule from the Federal Motor Carrier Safety Administration (FMCSA) that would require these devices in trucks. This rule would add extra transportation costs to the private sector and slow down the supply chain. It may even make roads less safe due to speed differentials between trucks and

passenger vehicles, causing more accidents.

I am a cosponsor of the DRIVE Act to prevent FMCSA from implementing this regulation and others like it that would require these types of devices. The federal government should be working to make it easier for truckers to enter the industry, not dissuade them with more bureaucratic red tape.

**BIG News**  
On Monday, I hosted my Level Up Youth Conference in Sioux Falls. Nearly 275 high school students from ten area schools were there to participate and hear from Cardboard Confessional's Mitch Reed, SDCP's Lori Walsh, and Dakota Scout's Jonathan Ellis. We talked about how to be a better engaged and informed citizen and friend, and how to responsibly consume news and media in the age of deep fakes and AI.

As I told the students, too little salt can cause health problems. It's necessary in a good diet, but too much salt is bad for your health. It's similar with media and news consumption. Too little news consumption, and you don't know what is going on in our country or how to engage. Too much media consumption, and you're overwhelmed and don't know what is true.

The students had thoughtful questions for the speakers and are interested in a wide variety of policy issues that matter today. It was great to host them!

# Department of Health Secretary, Melissa Magstadt, Issues the Following Statement on H5N1 Avian Influenza

PIERRE, SD - In response to recent concerns surrounding H5N1 Avian Influenza, South Dakota Department of Health Secretary, Melissa Magstadt, underscores collaborative efforts with the Department of Agriculture and Natural Resources to safeguard the well-being of both the state's population and livestock.

"The Department of Health is working with the Department of Agriculture and Natural Resources to ensure the safety of the people and livestock in South Dakota. It's important to note that the risk of human infection is low," said Department of Health Secretary, Melissa Magstadt. "If you have had exposure to an H5N1-infected bird or animal and are showing signs and symptoms of infection, such as redness and swelling of the eye (conjunctivitis), cough, fever, or sore throat, visit your medical provider to be tested."

Currently, there is no concern about the safety of the commercial milk supply or risk to consumer

health. Dairies are required to ensure only milk from healthy animals enter the food supply chain. Additionally, the pasteurization process of heating milk to a high temperature ensures milk and dairy products can be safely consumed, as confirmed by the Centers for Disease Control (CDC). In line with long-standing policy, the CDC does not recommend consuming unpasteurized milk or raw milk. Pasteurization has continually proven to successfully inactivate bacteria and viruses, like influenza, in milk.

## What should you know about long-term care?

We all hope to remain healthy and independent throughout our lives – but life can be unpredictable. If you were ever to need some type of long-term care, would you be financially prepared?

Long-term care encompasses everything from the services of a home health aide to a stay in an assisted living facility to a long residence in a nursing home. And all types of long-term care can involve considerable financial expense. The median annual cost for a home health aide's services is more than \$60,000 per year, and it's more than \$100,000 per year for a private room in a nursing home, according to Genworth, an insurance company. Furthermore, contrary to many people's expectations, Medicare usually pays very little of these costs.

Of course, some people expect their family will be able to take care of their long-term care needs. But this may not be a viable strategy. For one thing, your family members simply may not have the skills needed to give you the type of care you may require. Also, by the time you might need help, your grown

children or other family members might not live in your area.

So, you may need to protect yourself and your loved ones from the potential costs of long-term care. Basically, you've got two main choices: You could self-insure or you could transfer the risk by purchasing some type of long-term care insurance.

If you have considerable financial resources, you might find self-insuring to be attractive, rather than choosing insurance and paying policy premiums. You may wish to keep an emergency savings or investment account that's earmarked exclusively for long-term care to help avoid relying on your other retirement accounts. But self-insuring has two main drawbacks. First, because long-term care can be costly, you might need to plan for a significant amount. And second, it will be quite hard to predict exactly how much money you'll need, because so many variables are involved – your age when you start needing care, interest rates or inflation, the cost of care in your area, the type of care you'll require, the length of time you'll need care, and so on.

As an alternative to self-insuring, you could purchase long-term care insurance, which can provide benefits for home health care, adult day care and assisted living and nursing home facilities. However, you will need to consider the issues attached to long-term care

insurance. For one thing, it can be expensive, though the younger you are when you buy your policy, the more affordable it may be. Also, long-term care policies typically require you to wait a certain amount of time before benefits are paid. But policies vary greatly in what they offer, so, if you are thinking of buying this insurance, you'll want to review options and compare benefits and costs.

In any case, by being aware of the potential need for long-term care, its cost and the ways of paying for it, you'll be able to make the appropriate decisions for your financial situation, your needs and your loved ones.

# Ash Trees Continued

## Can an infested tree still be treated and saved?

If the tree is exhibiting less than 20 percent canopy decline and there is little blanding- where woodpeckers have removed bark in their search for EAB larvae- the tree may still be successfully treated. The only effective treatments are those done by commercial applicator.

Remember treatments are not a one-time fix but must be repeated for at least ten years on an annual or biannual basis depending on the insecticide and delivery system. The treatments will need to be continued beyond then but at a less frequent interval. If treatments are stopped, the borer will infest the tree.

## Removing infested trees

If the tree has more than 20 percent canopy decline, it should be removed. Emerald ash borer causes structural weakness in the host tree. These trees may fail at the base or have large, dead limbs snap and fall. Homeowners in other states have suffered fatal injuries by ash trees that were killed by the borer.

The best means of removing an infested ash or one that died is contacting a professional tree company. These companies will have arborists with the training and equipment to safely remove these trees. A critical question to ask is their insurance coverage. Do they have liability insurance to cover damage done to your home or property. Another question is about their credentials to do these removals. Are they certified by the International Society of Arboriculture. What are their year of experience doing tree removals?

- Paddle-shaped seeds
- 1-2 inches long
- Some trees are seedless

# A Brief History of Earth Day



Earth Day is celebrated each April and draws attention to a range of issues affecting the environment. Earth Day aims to raise awareness in the hope of inspiring change.

Earth Day is observed on April 22. According to National Geographic, the first Earth Day was celebrated in 1970. Wisconsin senator Gaylord Nelson was inspired to begin a national celebration uniting the environmental movement after witnessing environmental activism in the 1960s. With the help of Denis Hayes, a graduate student at Harvard University, Nelson organized the first Earth Day. Twenty million people participated in events across the United States and strengthened support for environmental legislation like the Clean Air Act and the Endangered Species Act.

Earth Day was expanded to a global initiative in 1990 under guidance from Hayes. Nearly 200 million participants in more than 140 countries now join together in the name of protecting the planet. Awareness continues to be raised each year regarding renewable

energy and climate change.

One of the hallmarks of Earth Day celebrations is the planting of trees. Researchers estimate roughly 15 billion trees are cut down each year across the globe. By planting a tree every Earth Day, people can make a difference. Trees absorb carbon dioxide and release oxygen and bolster ecosystems for wildlife. Shade trees can reduce reliance on fans and air conditioning systems.

The main message of Earth Day 2024 is the need to commit to ending reliance on plastics, says EarthDay.org. The goal is a 60 percent reduction in the production of all plastics by 2040. Plastics are bad for the environment a growing body of research indicates they have an adverse effect on the major systems of the body, including immune, respiratory, digestive, and hormonal systems.

Everyone can do their part to promote the ideals behind Earth Day. For 54 years, millions of people have been advocating for change to benefit the planet and human and animal health, and that fight is ongoing.

National Work Zone Awareness Week (NWZAW) is an annual awareness campaign held at the start of construction season to remind drivers to be attentive through work zones during the busy summer travel months. The official theme for NWZAW 2024, is “Work zones are temporary. Actions behind the wheel can last forever.” NWZAW will be observed with awareness events and activities throughout the week of April 15-19, 2024.

“All drivers need to take personal responsibility to eliminate distractions and stay focused on the road,” said Joel Jundt, Secretary, South Dakota Department of Transportation (SDDOT). “The SDDOT, along with other state agencies, are asking South Dakotans to actively participate in the “Buckle Up! Phone Down!” driver challenge during NWZAW to assure that all roadway workers arrive home safely each and every day.”

As part of NWZAW, everyone is encouraged to participate in Go Orange Day on Wednesday, April 17, 2024. Demonstrate support for highway construction employees across the state by wearing orange apparel and posting “Buckle Up! Phone Down!” photos on social media using the hashtags #NWZAW, #Orange4Safety, #BuckleUpPhoneDown, or #SDDOT.

NWZAW has been observed for more than 20 years and was launched as a public awareness campaign to help all drivers understand their role in keeping fellow motorists and roadway workers safe.



“This is a concerted effort by many to raise critical public awareness,” said Craig Smith, SDDOT Director of Operations. “During NWZAW, our staff partners with area contractors and local, state, and federal agencies to provide safety tips and officially kick-off the 2024 construction season by highlighting key projects planned across South Dakota.” Smith will kick-off NWZAW on Monday, April 15, 2024 with a Facebook live-stream event.

SDDOT also created construction-themed coloring sheets, crossword puzzles, and word finds for young families and elementary classrooms

**Canton School District 41-1 Board of Education Proceedings April 8, 2024**

The Canton School District Board of Education met in regular session on Monday, April 8, 2024 at 7:00 pm in the agriculture classroom.

Board members present: Gannon, Iverson, Kappenman, Ockenga, Otkin and Skiles. Absent: Dibert. Administration present: Superintendent Townsend, Business Manager Andersen, Elementary Principal DeVitt, High School/Middle School Principal Knudson, Activities Director Versteeg and Special Education Coordinator Sutter. Absent: None.

The meeting was called to order at 7:00 p.m. and opened with the Pledge of Allegiance.

Skiles moved, second by Kappenman to approve the minutes of the March 11, 2024 Regular School Board meeting. Aye: all members.

Iverson moved, second by Skiles to amend the agenda to add offer contract to new business item C – Employment, to move item new business A – Legislative Commemoration for Wrestlers before the Administrator’s reports, and then to approve the agenda as amended. Aye: all members.

No conflicts of interest were identified.

Gannon moved, second by Iverson to move new business items B – Open enrollment to approve the open enrollments of two students; C – Employment – to offer contracts to Kiley Nielsen as Kindergarten Teacher for the 2024-2025 school year, Jacob Mahowald as 7-12 Band Teacher for the 2024-2025 school year, and Molly Lenz as English Teacher for the 2024-2025 school year with salaries to be published at a later date; D – Resignation – to accept the resignation of Suzanne Anderson as English Teacher; E – Teacher, Aide, Custodian, and Secretary Contracts – to offer new contracts to all Teachers, Aides, Custodians, and Secretaries with salaries to be negotiated at a later date; F – ASBSD Protective Trust Adoption and Renewal Motion – BE IT HEREBY MOVED AND RESOLVED by the Canton School District School Board of the Canton School District, acting in pursuant to SDCL ch. 1-24 and SDCL 13-10-3, 13-8-39, and the general authority of SDCL title 13, and hereby adopts, approves and ratifies the South Dakota School District Benefits Fund Participation Agreement as attached hereto as EXHIBIT A, effective as of the time of adoption of this Motion. BE IT FURTHER MOVED AND RESOLVED that the Protective Trust Joint Powers Agreement and Bylaws are hereby adopted, and further that actions taken under the ASB Protective Trust Joint Powers Agreement and Bylaws and the South Dakota School District Benefits Fund Participation Agreement since the time and date the District initially joined said Trust are hereby ratified and approved to the same extent and effect as if each amendment thereto had been separately submitted and to the Board for approval prior to execution by the Superintendent and Business Manager. BE IT FURTHER MOVED AND RESOLVED that the Superintendent and Business Manager are hereby authorized to execute, on behalf of the District, the present South Dakota School District Benefits Fund Participation Agreement as it presently exists and may from time to time be amended and approved pursuant to the Bylaws herein adopted. Each succeeding Participation Agreement changing in any manner the benefits, contributions, or obligations arising under the South Dakota School District Benefits Fund shall be submitted to the Board for approval prior execution by the Superintendent and Business Manager. IT IS FURTHER MOVED AND RESOLVED that coverage provided in the South Dakota School District Benefits Fund Participation Agreement shall extend from 12:01 a.m. CST, July 1, 2024 to 12 midnight CST, June 30, 2025. The contribution required for such coverage is as set forth in the attached EXHIBIT A renewal letter and by this reference incorporated herein. There is hereby delegated to the Superintendent the authority to carry out, or to further delegate subject to his supervision and responsibility, the obligations of the District identified in the Bylaws approved herein, the Participation Agreement, and the Master Contracts provided by the Trust Administrator. Finally, the Board hereby agrees to indemnify the Trust and its members, pursuant to the process established in the Bylaws approved herein, the full amount of any assessment levied by the Trust Fund Board, including termination contribution, pursuant to the Bylaws and the full amount of any contribution agreed to in the current or subsequent Participation Agreements approved by the Board as submitted upon proper vouchers. WHEREAS, the Canton School District (hereinafter “DISTRICT,” “MEMBER,” “PLAN SPONSOR,” or “EMPLOYER”) has, by resolution of its duly-elected governing body, adopted the ASB PROTECTIVE TRUST JOINT POWERS AGREEMENT AND BYLAWS; WHEREAS, the DISTRICT is desirous of receiving health benefit coverage as provided in this Agreement and the “SUMMARY PLAN DESCRIPTION” (hereinafter “SPD”), incorporated herein by this reference, for each named employee eligible for coverage and listed on the “Enrollment Form” provided by the EMPLOYER (hereinafter “COVERED EMPLOYEE”); WHEREAS, the SOUTH DAKOTA SCHOOL DISTRICT BENEFITS FUND (hereinafter “Benefit Fund”) exists for the purpose of providing health care coverage for MEMBER DISTRICT employees; and WHEREAS, the ASSOCIATED SCHOOL BOARDS OF SOUTH DAKOTA (hereinafter “ASBSD”) has been designated as the “Trust Administrator” herein; NOW THEREFORE BE IT AGREED AS FOLLOWS: SECTION I DEFINITIONS 1.1. ASBSD -- Associated School Boards of South Dakota. 1.2. ASB Protective Trust -- An unincorporated assessable association operating under the laws of the State of South Dakota to provide health, property, worker’s compensation, and liability coverage for school districts and public agencies

which have elected to participate in a pool arrangement and their employees in South Dakota (hereinafter referred to as “TRUST”). 1.3. Benefit Fund -- The South Dakota School District Benefits Fund, as well as its Claims Supervisor or other designated entity. 1.4. Claims Supervisor -- Wellmark BCBS of SD, 1601 W Madison Street, Sioux Falls, SD 57104, Phone 1-800-831-4818. 1.5. Covered Employee -- An eligible employee, defined as an “eligible member” in the “SUMMARY PLAN DESCRIPTION,” who has completed the enrollment form, whose name and social security number has been reported to the Trust Administrator, and for whom the contribution has been made. 1.6. Coverage Period -- The term of this Agreement is one year. Coverage shall be on a monthly basis. Coverage shall be deemed continuing unless terminated as provided herein or when the EMPLOYER fails to make timely monthly contributions. 1.7. Date of Termination -- A date not less than ninety (90) days from receipt of notice of termination by the Trust Administrator. ASB PROTECTIVE TRUST SOUTH DAKOTA SCHOOL DISTRICT BENEFITS FUND PARTICIPATION AGREEMENT Page 2 1.8. Earned Contribution -- Active Employee, Retiree and COBRA revenue received by the FUND from a MEMBER for a specific month. 1.9. Health Care Coverage or Plan -- Health care benefits, as elected by the Plan Sponsor, and employee, may include medical and life, as provided in the then current version of the applicable “SUMMARY PLAN DESCRIPTION” for the plan the employee is enrolled at the time of a claim, including amendments thereto, and as further defined and limited in this Agreement and the Trust Bylaws. 1.10. Total Earned Contribution -- Active Employee, Retiree and COBRA revenue received by the FUND from all MEMBERS in aggregate on an annual basis. 1.11. Trust Administrator -- Associated School Boards of South Dakota, 306 East Capitol, Pierre, South Dakota 57501, Telephone (605) 773-2500, FAX (605) 773-2501. SECTION II OBLIGATION OF PARTICIPATING EMPLOYER 2.1. Contribution. Each participating EMPLOYER shall be responsible for prompt and timely payment of the applicable contribution. The contribution, which includes the employer and employee portions, shall be paid monthly by the EMPLOYER. The amount of contribution required is as set forth in the Adoption and Renewal Motion, attached hereto, and incorporated herein by this reference, upon approval by the MEMBER’S governing board. Contribution amounts are calculated on an annual basis or such shorter period as may be agreed upon. The District’s contributions are due on the first of each month and is delinquent after the fifth day. Delinquent accounts will accrue interest and penalties. 2.2. Eligibility. The EMPLOYER shall track and maintain employee eligibility at all times in accordance to the ASSOCIATED SCHOOL BOARDS PROTECTIVE TRUST ADMINISTRATIVE PROCEDURES FOR ELIGIBILITY FOR GROUP HEALTH COVERAGE document contained within the SPD and adhere to the EMPLOYER’S own expressly stated hours of eligibility and effective date of coverage within the guide. The EMPLOYER shall notify the FUND through the EMPLOYEE enrollment or change in eligibility process of any employee change in eligibility at the end of each month. If it is discovered that any claims have been paid by the FUND or the FUND’S stop loss carrier on a non-eligible employee, such claims shall be the responsibility of the EMPLOYER, who shall reimburse the FUND and/or the FUND’S stop loss carrier, whichever is applicable, for all such paid claims. 2.3. Notice of Enrollment and Unenrollment. In addition to executing and returning this Agreement and its attachments and promptly complying with the requirements of the ASB Trust Bylaws, the EMPLOYER shall provide the Trust Administrator with a completed enrollment form for each eligible employee when hired or added and provide monthly notice of and date that each eligible employee is terminated, deleted, or removed from the group along with the payment of the contribution. ASB PROTECTIVE TRUST SOUTH DAKOTA SCHOOL DISTRICT BENEFITS FUND PARTICIPATION AGREEMENT Page 3 2.4. Confidentiality. The EMPLOYER will keep all medical information regarding a covered employee separate from the employee’s personnel file and will comply with the provisions of all applicable state and federal law with respect to confidential medical information. 2.5. COBRA. Each EMPLOYER shall provide timely notice of coverage under the Consolidated Omnibus Budget Reconciliation Act (COBRA) to each employee who loses health coverage under the Benefit Fund or whose eligible spouse or eligible dependents lose health coverage under the Benefit Fund and shall provide to the Trust Administrator a copy of the affected employee’s or qualified beneficiary’s written election to continue or decline coverage under COBRA. Failure of the EMPLOYER to give timely notice of COBRA coverage to an eligible employee or qualified beneficiary shall result in the EMPLOYER being responsible for providing COBRA continuation coverage for any affected employee or qualified beneficiary. The cost for continuing coverage under COBRA shall be no more than one hundred two percent (102%) of the rate for the affected employee’s or qualified beneficiary’s coverage. Payment of contributions for continuing coverage under COBRA is the affected employee’s responsibility or, if elected by the EMPLOYER, the EMPLOYER’S responsibility. Failure of the affected employee to make timely payment shall terminate COBRA coverage. Payment made by the affected employee must be received within the allowable timeframe according to COBRA regulations. 2.6. Providing Plan Information. The EMPLOYER shall at the time of enrollment and thereafter annually provide a copy of the current and applicable SUMMARY PLAN DESCRIPTION to each covered employee and may advise the

employees that this Participation Agreement together with the ASB Trust Bylaws apply to the employee’s coverage which are available for inspection without charge during business hours at the EMPLOYER’S business office. The EMPLOYER shall advise all covered employees that the provisions of this Participation Agreement and the ASB Trust Bylaws are binding requirements of coverage, and that the SPD is only a description of benefits. 2.7. Health and Safety Conditions. The EMPLOYER agrees to not knowingly allow any condition to exist in the workplace which is detrimental to the health and safety of the covered employees. The EMPLOYER agrees to allow the Benefit Fund, its Trust Administrator, Claims Supervisor, or the designee of any of them, to inspect the EMPLOYER’S premises in order to determine whether any condition detrimental to the health or safety of the covered employees exists. The EMPLOYER acknowledges that neither the Trust Administrator nor the Claims Supervisor is obligated to make any inspection or recommendation with regard to health and safety conditions. SECTION III OBLIGATIONS OF THE BENEFIT FUND 3.1. Coverage. The Benefit Fund agrees to provide coverage for eligible claims by covered employees timely submitted as described in the applicable SPD for the plan in which such covered employee is enrolled at the time of a claim. 3.2. Claims Forms. The Benefit Fund shall provide to the EMPLOYER an adequate number of claim forms for use by covered employees in submitting claims. ASB PROTECTIVE TRUST SOUTH DAKOTA SCHOOL DISTRICT BENEFITS FUND PARTICIPATION AGREEMENT Page 4 SECTION IV TRUST OBLIGATIONS 4.1 Management and Administration. The Trust shall manage and administer the TRUST. The management and administration of the Trust shall be performed by the Trust or its designee upon the direction and advice of the Trust Board 4.2 Authority and Obligations. Management and administration of the Trust shall include, but not be limited to, the following authority and obligations: (1) Evaluation and establishment of reserves for claims. (2) Investigation and adjusting of claims. (3) Making payment of compensable benefits as required under the Bylaws, this Participation Agreement, and the applicable Summary Plan Description. (4) Negotiating settlements of claims or suits against the MEMBER or TRUST as authorized or approved pursuant to policies of the Trust Board and securing appropriate releases upon settlement of claim. (5) Selecting and monitoring attorneys employed to defend claims or suits against the MEMBER or the TRUST. (6) Monitoring claims for subrogation and undertaking recovery efforts when economically feasible and advisable. (7) Maintaining reports identifying MEMBERS’ claims by category, payments made, and reserves of claims. Such reports shall be available to MEMBERS and each Trustee as required by policies adopted by the Trust Board. (8) Providing such reports and documentation as required by any applicable Summary Plan Description. (9) Preparing and filing reports required by the state or federal government or agencies thereof. (10) Providing or contracting for loss control and developing and disseminating loss control programs to reduce losses to the MEMBERS. (11) Monitoring frequency and severity of claims’ performance of MEMBERS. (12) Establishing rating structures to determine MEMBER contributions, providing billing to MEMBERS for contributions and providing notices to MEMBERS regarding contribution changes and assessments. ASB PROTECTIVE TRUST SOUTH DAKOTA SCHOOL DISTRICT BENEFITS FUND PARTICIPATION AGREEMENT Page 5 (13) Securing insurance coverage, excess insurance coverage, reinsurance, stop loss agreements, endorsements, and other indemnification agreements, both as to specific individual claims and aggregate claims as determined by the Trust Board, and determining the amount of retention for claims, if any, in each area of coverage by the TRUST. (14) Developing programs for TRUST expansion. (15) Determining proposed distributions to MEMBERS of excess reserves, proposed payment of assessments, if any, based upon the Fund’s performance or such criteria in accordance to the ASB Protective Trust By-Laws. (16) Providing billing, collection, and auditing of contributions to the TRUST by MEMBERS. (17) Retaining and authorizing outside legal and financial assistance. (18) Entering into an Administrative Services Agreement with a third party delegating the responsibilities and authorities of management of the Trust Obligations upon the approval and advice of the Trust Board (19) Performing an annual audit in accordance to the ASB Protective Trust By-Laws. SECTION V TERM OF AGREEMENT 5.1. Termination. This Agreement can be terminated by mutual agreement in writing at any time. Failure of the participating EMPLOYER, or an employee under continuing COBRA coverage, to timely pay the contribution terminates the coverage as of the last day for which the full premium was paid or voids the coverage ab initio (from the beginning) if the premium was never paid. 5.2. Coverage Commencement. Notwithstanding any other coverage or benefit year identified in any coverage plan document, coverage under this Participation Agreement will commence on the day indicated in the adoption and renewal motion as prepared by the Fund, contingent upon receipt by the Benefit Fund of the timely payment of each monthly contribution from the MEMBER. In the event the due date of any contribution falls on a weekend or holiday, the contribution must be received by the following business day. 5.3 Renewal and Notice of Termination. Coverage under this Participation Agreement shall continue for another year term unless a MEMBER provides board approved written notice of its intention not to renew coverage for a subsequent

coverage year no later than April 30th of any coverage year. Failure to notify the Trust Administrator as provided herein is a binding commitment on the part of the MEMBER to renew membership for another year at the contribution rate established by the Trust Administrator prior to the renewal date. 5.4 Non-Timely Notice of Termination. In the event that the participating MEMBER fails to provide notice in accordance with Section 5.3 herein of its intention not to renew coverage, payment of three (3) months Earned Contribution will be required. The three (3) months of ASB PROTECTIVE TRUST SOUTH DAKOTA SCHOOL DISTRICT BENEFITS FUND PARTICIPATION AGREEMENT Page 6 Earned Contribution will be calculated by using the highest one (1) month of Earned Contribution dating back to the preceding July 1 prior to when the absence of timely notice was received by the Trust Administrator. That highest monthly amount will be multiplied by three (3) to equal the amount due by the MEMBER prior to termination. Payment is due within sixty (60) days of receiving an invoice from the Trust Administrator and a ten percent (10%) monthly finance charge will be applied to the balance due if payment is not received in that timeframe. The finance charge will be compounded for each additional month the balance is outstanding past the 60 days. Non-timely notice of terminating coverage does not relieve the MEMBER of any outstanding assessments and other participation termination requirements outline in this participation agreement or by-laws. Non-timely notice of termination shall constitute abandonment of the MEMBER’S right to any future distribution of excess reserves. See Appendix A for example. 5.5. Early Termination. In the event a MEMBER seeks to withdraw prior to the end of the coverage year it shall provide a ninety (90) day board approved written notice of termination and payment of three (3) months Earned Contribution will be required. The three (3) months of Earned Contribution will be calculated by using the highest one (1) month of Earned Contribution dating back to the preceding July 1 prior to when the absence of timely notice was received by the Trust Administrator. That highest monthly amount will be multiplied by three (3) to equal the amount due by the MEMBER prior to termination. Payment is due within sixty (60) days of receiving an invoice from the Trust Administrator and a ten percent (10%) monthly finance charge will be applied to the balance due if payment is not received in that timeframe. The finance charge will be compounded for each additional month the balance is outstanding past the 60 days. Early termination of coverage does not relieve the MEMBER of any outstanding assessments and other participation termination requirements outline in this participation agreement or by-laws. Early termination shall constitute abandonment of the MEMBER’S right to any future distribution of excess reserves. See Appendix A for example. 5.6. Obligations Upon Termination. Termination of this Agreement shall not relieve the participating MEMBER of its obligation to ensure the MEMBER is leaving the FUND in sound financial position and at least one of the following provisions will be enforced upon termination: (1.) If the ending audited Net Position of the FUND at the conclusion of the fiscal year ending in this agreement is less than twelve percent (12%) of the FUND’S audited Total Earned Contribution for that fiscal year the MEMBER will be responsible for additional Earned Contribution before fully terminating from the FUND. The terminating MEMBER will be responsible for a pro-rated amount of the difference between the product of twelve percent (12%) of Total Earned Contribution less the actual audited ending Net Position for that fiscal year. The difference will be multiplied by the MEMBER’S percentage of overall Earned Contribution the terminating entity contributed to the FUND’S Total Earned Contribution for that fiscal year. In addition, the MEMBER will be responsible for one (1) month of Earned Contribution to be fully terminated from the fund. The one (1) month of Earned Contribution due will be calculated by using the highest one (1) month of Earned Contribution dating back to the preceding July 1 multiplied by one (1). See Appendix C for example. Payment, in accordance with the provisions in Sections 5.6.1. and 5.6.2, is due within sixty (60) days of receiving an invoice from the Trust Administrator and a ten percent (10%) monthly finance charge will be applied to the balance due if payment is not received in that timeframe. After sixty (60) days, the finance charge will be compounded for each additional month the balance is outstanding past the 60 days. 5.7. Contributions After Termination. Notice of termination of this Agreement shall not relieve the participating MEMBER of its obligation to pay contributions through the date of termination of the agreement and assessments made against MEMBERS, which occurred during the MEMBER’S participation, nor shall it relieve the participating MEMBER of any continuing obligation assumed through their adoption of the ASB Trust Bylaws. The fund reserves the right to require additional or supplemental contributions, in the form of a member assessment, from each participating MEMBER for any fund year in which the initial contributions are inadequate to pay benefits, costs of

operation or other expenses of the program subject unless limited to provisions of the Assessment Memorandum of Understanding entered into in Fiscal Year 2017. Such additional or supplemental contribution may be assessed within the immediate subsequent fund year upon any MEMBER who participated in the fund during the previous such fund year in which there are inadequate contributions, regardless of whether MEMBER is participating in the fund at the time of such member assessment. G - SDHSAA Membership – By resolution, the School Board of Canton School District #41-1 has authorized membership in the South Dakota High School Activities Association for the high school under its jurisdiction as hereinafter listed Canton High School. This is to be for the period which begins July 1, 2024 and ends on June, 30, 2025 with the supervision, control, and regulation of any and all high school interscholastic activities being delegated to said Association. BE IT FURTHER MOVED AND RESOLVED that actions taken under prior versions of the ASB Protective Trust Joint Powers Agreement and Bylaws and ASB Workers’ Compensation Trust Fund Participation Agreement since the time and date the District initially joined said Trust are hereby ratified and approved to the same extent and effect as if each amendment thereto had been separately submitted and approved at the time of its adoption. BE IT FURTHER MOVED AND RESOLVED that the Superintendent and Business Manager are hereby authorized to execute, on behalf of the District, the present ASB Workers’ Compensation Trust Fund Participation Agreement as it presently exists and may from time to time be amended and approved pursuant to the Bylaws herein adopted. Each succeeding Participation Agreement changing in any manner the benefits, contributions, or obligations arising under the Workers’ Compensation Fund shall be submitted to the Board for approval prior to execution by the Superintendent and Business Manager. IT IS FURTHER MOVED AND RESOLVED that coverage provided in the ASB Workers’ Compensation Trust Fund Participation Agreement shall extend from 12:01 a.m. CST, July 1, 2024, to 12 midnight CST, June 30, 2025. The projected contribution required for such coverage as provided in the ASB Workers’ Compensation Fund Participation Agreement is \$35,990. There is hereby delegated to the Superintendent the authority to carry out, or to further delegate subject to his supervision and responsibility, the obligations of the District identified in the Bylaws approved herein, the Participation Agreement, and the Master Contracts provided by the Trust Administrator. Finally, the Board hereby agrees to indemnify the Trust and its members, pursuant to the process established in the Bylaws approved herein, the full amount of any assessment levied by the Trust Board pursuant to the Bylaws and the full amount of any contribution agreed to in the current or subsequent Participation Agreements approved by the Board as submitted upon proper vouchers. Employee -- Any full-time, part-time, or temporary individual, whether compensated or not, who provides or provided services authorized by the DISTRICT at the direction and control of the DISTRICT or its authorized agent. The term does not include independent contractors or an independent contractor’s officers, employees, and agents. The term does include an enrolled student performing assigned duties without pay in an approved vocational education program away from the school premises as provided in SDCL 62-1-4.1. 1.5. The TRUST may make such investigation, negotiation, and settlement of any claim or action as it deems appropriate and expedient, subject to approval by the MEMBER. Should the MEMBERS governing board refuse to approve such settlement, such MEMBER will be solely and individually liable for any amount, ultimately awarded, including defense costs above the settlement amount, as a result of such claim, and such MEMBER shall indemnify and hold the TRUST harmless for any such amount in excess of the Settlement Amount. 2.3. The TRUST will pay all expenses incurred by the TRUST, all costs taxed against a MEMBER in an administrative proceeding, and all interest accruing after entry of judgment, until the TRUST has paid, tendered payment, or deposited in the court all or part of such judgment that does not exceed the limits of liability established herein. This obligation is subject to the limitations of Section 2.1 and 2.2. 2.4. Upon admission, a NEW MEMBER shall be required to maintain membership in the TRUST for a minimum period of three (3) consecutive years, unless the TRUST is terminated prior to the expiration of such period. Any NEW MEMBER that joins the TRUST after July 1, but before January 1 of the Fiscal Year, shall be allowed to apply that time in the TRUST toward the first year of their three (3) year initial commitment. Any NEW MEMBER that joins the TRUST between January 1 and June 30 of the Fiscal Year may not apply that time in the TRUST for the first year of the three (3) year initial commitment. A NEW MEMBER who fails to maintain membership in the TRUST for a minimum of three (3) consecutive years as set forth in this section shall

Failure of a MEMBER to provide board approved written notice to obtain bids/quotes by December 1 and of its decision not to renew coverage for a subsequent coverage year no later than April 1 of any coverage year shall constitute a binding commitment on the part of the MEMBER to renew membership for another year at the contribution rate established by the Trust Administrator prior to the renewal date. A MEMBER that provides written notice of its intention to seek bids/quotes and then stays with the TRUST is not allowed to submit notice for bids/quote for another 36 months. If a MEMBER provides written notice of its intention to seek bids/quotes and then stays with the TRUST, and then within the next 24 months submits notice for bids/quotes, the MEMBER's participation in the Trust shall terminate at the end of the coverage year then in effect and the MEMBER shall pay to the TRUST, as liquidated damages pursuant to SDCL 53-9-5, an amount equal to contribution applicable to the months of membership remaining in the TRUST. A MEMBER that provides written notice of its decision not to renew coverage and leaves the TRUST, or whose membership is terminated as set forth in this section, is not allowed to rejoin the TRUST for the consecutive 24 months. 5.2. A MEMBER may be terminated from membership as set forth in the Trust Bylaws. In addition, failure or refusal of a MEMBER to cooperate, participate, and assist in the defense of a claim or proceeding against the MEMBER shall constitute grounds for termination of membership, subject to review by the Trust Board. Failure to cooperate, participate, and assist in the defense of any claim shall also void coverage if such failure to cooperate is not rectified upon written notice. SECTION VI ENTIRE AGREEMENT 6.1. This Participation Agreement, together with the Trust Fund Bylaws, the applicable Master Contracts, if any, as limited by SDCL tit. 62, constitute the entire agreement between the parties and may not be changed or altered, except in writing approved by all signatories to this Participation Agreement. 6.2. This Participation Agreement shall be construed under the laws of the State of South Dakota, not including the conflict of law provisions as enunciated by the South Dakota Supreme Court or enacted by the Legislature. SECTION VII MEMBERS OBLIGATIONS Each MEMBER agrees to be bound by all of the terms of the Trust Bylaws, as amended from time to time, and to abide by the rules, regulations, and policies promulgated by the Trust Board for administration of the TRUST. The EMPLOYER shall notify all employees, in a manner calculated to come to their attention, of the requirement that the employee provide notice to the EMPLOYER of workrelated injury within three (3) business days after its occurrence. Failure of the employee to give the notice may result in no coverage under the workers' compensation laws of South Dakota. 7.3. Initiate and maintain a loss control program and follow recommendations of the TRUST, its Claims Administrator, Trust Administrator, and Risk Manager, if any, to promote the general welfare of its employees and the safety of their working environment. Each MEMBER remains solely and individually responsible for all decisions concerning its safety program and practices, and may not rely upon the evaluation of TRUST agents, if any, in making final decisions concerning the MEMBER'S safety programs and risk management practices. 7.4. If any notice of employee injury or claim is made or other proceeding is brought against the MEMBER under the workers' compensation laws of South Dakota, the MEMBER shall IMMEDIATELY transmit to the Claims Administrator and Trust Administrator any demand, notice of injury, summons, or other process received, and prepare such claim forms as may be required by the workers' compensation laws of South Dakota, the TRUST, or the Claims Administrator to process such proceeding, or claim. Failure of the MEMBER to provide a copy of any summons or complaint or a petition for or notice of hearing before the South Dakota Department of Labor received by the MEMBER within ten (10) days of service thereof, or within ten (10) days of admitting service thereto, shall void coverage under this Participation Agreement. 7.5. The MEMBERS shall cooperate with the TRUST and the assigned attorneys and, upon request, shall attend hearings and trials and shall assist in

effectuating and implementing settlements, securing and giving evidence, providing documents, gaining the attendance of witnesses, and otherwise fully cooperate in the conduct of hearings or proceedings. The MEMBER shall not, except at its own cost which shall not be reimbursed by the TRUST, voluntarily make any payment, assume any obligation, or incur any expense other than for immediate emergency medical services, unless such expenditure shall have been preapproved by the TRUST, the assigned attorney, or the Claims Administrator. 7.6. Each MEMBER shall make prompt payment of all contributions and assessments as required by this Participation Agreement and the Trust Bylaws. 7.7. The MEMBER does hereby appoint the Trust Administrator as agent to act on the MEMBERS behalf to file reports, confess judgment, or to arrange for payment of claims, ASB WORKER'S COMPENSATION FUND PARTICIPATION AGREEMENT Page 9 medical expenses, and other costs and to do all things required or necessary insofar as they affect the MEMBERS liability, subject to Section 2.2 herein. The MEMBER agrees that upon payment of any loss or the incurring of any expense or liability by the TRUST under this Participation Agreement, the TRUST is subrogated to the extent of such payment or liability to all rights of the MEMBER against any person or other entity legally responsible for such damages or losses. The MEMBER agrees to execute a specific subrogation agreement as necessary, and to render all reasonable assistance, other than pecuniary assistance, to affect recovery under the rights of subrogation transferred herein and shall refrain from any act or omission which will likely impair such right of subrogation. 7.9. The Trust Board, its designee, the Claims Administrator, or the Trust Administrator, and any of their agents, servants, employees, or attorneys are permitted at all reasonable times to inspect the MEMBERS workplaces, plants, works, machinery, buildings, records, and appliances relating in any manner to the subject of this Participation Agreement, and shall be permitted, within three (3) years following closure of any claim, to inspect any contract, document, or other record which shows or would tend to show or verify contributions which are payable or were paid to the TRUST. So long as a claim is pending against a MEMBER and being defended by the Trust, the obligation to cooperate and assist in the defense shall remain in force regardless of whether membership continues. 7.10. The MEMBER by adoption of this Participation Agreement; hereby elects to treat officials of the district, including school board members, as employees per SDCL 62-1-2 for the purposes of workers' compensation coverage while in the performance and scope of their duties. SECTION VIII MAXIMUM COVERAGE LIMITATIONS As to any COMPENSABLE INJURY under this Agreement as specified in the Master Contract, pursuant to the workers' compensation laws of South Dakota, the maximum liability undertaken by the TRUST for any single occurrence is based on required statutory South Dakota workers' compensation benefits. 8.1.
