# “Lettuce Sell Your Stuff” Comes to Canton

Brady Barr has brought his shop to a storefront in Canton. “Lettuce Sell Your Stuff” is located at 121 East 5th Street, which is on the corner of businesses south of the courthouse. The surplus and consignment store contains a wide array of furniture, but also includes a variety of items such as antiques, clothes, sporting goods, and electronics. Barr is hoping to have a new selection of items every month. The business started in August of 2023, as a service to help people sell things they no longer need. This is a perfect way for those preparing for a move or cleaning out their home to have an option for help in these matters, and to turn those unneeded items into cash.

“There is a ton of hassle when it comes to selling things on your own—listing, messaging, and scheduling, not to mention scammers, hackers and people who don’t show up. Garage sales are a massive task, and why would you pay to contribute to the landfill—especially when you can get paid to repurpose?! We take care of pictures, measuring, pricing, listings, messaging, and meetups—making selling your things ‘As crisp as a salad!’ I would go to someone’s house to take the initial photos, then return over and over to sell items as buyers wanted to meet. I realized that this was very inefficient, as I was driving all over town every day and knew it wouldn’t be sustainable,” Barr says.

When his next-door neighbor of twenty-four years came over one day in a panic, saying he just on



impulse bought a new house on auction and had three weeks to get out of his current home, the business was born. Barr offered to try and sell his neighbor’s furniture on Facebook marketplace, as he had done it briefly in high school, since his neighbor was overwhelmed. Barr ended up selling every piece of furniture in those three weeks, making his neighbor some money, and took a percentage of sales for his time, which turned into a wonderful experience.

“Ironically, I already had a name and logo for this business. It had been one of my many business ideas in the past, but never made the time to go for it until now. After this sale I created a Facebook page and group for anyone to buy and sell in, and door hangers to try to get the

word out. I quickly realized this is a service that is in extremely high demand— as there weren’t many convenient and effective solutions for people looking to sell their unwanted items. If you are reading this, Gregg, we miss you on the street but boy am I glad you needed your furniture gone!” -Barr

The business has also done some sales including selling items from a closing restaurant, an estate sale, auction, car sale, and now the new storefront. With the storefront, it enables Barr to let people bring items right to the store where he can sell them, without getting gas every day driving around collecting those items. Being from Sioux Falls, Barr also signed a shared lease for a warehouse in Tea, SD where he will store those items, sell some in Sioux

Falls, and then one weekend a month will load up a trailer to bring to the storefront in Canton for a four-day sale. The four-day sale will start on Thursdays, opening at 10am, and go through Sunday. The weekend for next month is September 12th-15th. The upcoming dates will be posted on their Facebook page and in the store’s window.

For customers wishing to drop off items at the store to be sold, they may text pictures and then a drop off time will be scheduled upon approval of item(s). They are also always receiving and selling items at their Tea warehouse and can contact them for an item drop off at that location, or if you are interested in seeing their inventory at that location. They also offer a moving service if items need to be picked up, for which they charge up front.

“We are excited to be part of the Canton community and look forward to helping you find great deals and sell your stuff! Although we have just been there for a short time, I’ve felt very welcomed and have enjoyed meeting everyone that was able to come to our grand opening. I look forward to becoming a part of this community and would love to help in any way I can, so feel free to reach out to me for anything!” -Barr

# FEMA Declared Lincoln County for Flood Assistance

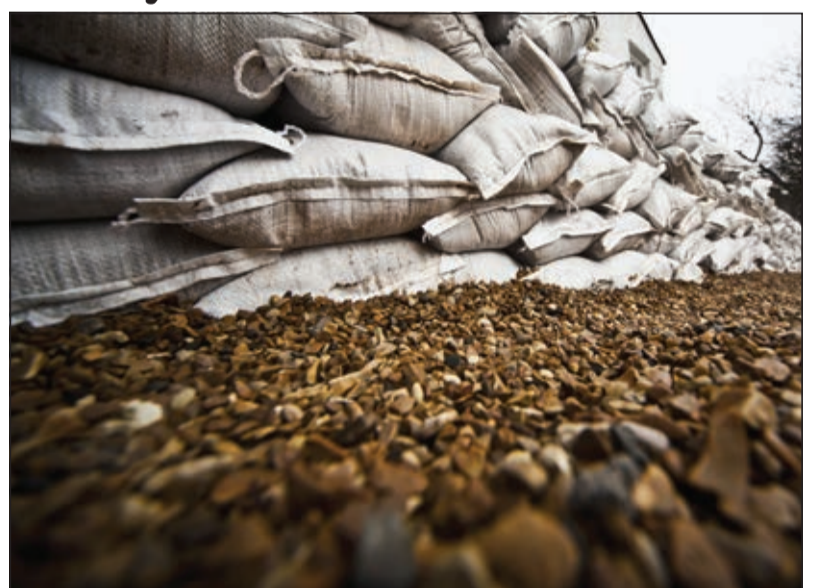
Canton, South Dakota: Davison, Lincoln, Turner, and Union Four Counties receive Individual Assistance:

Constituents in the declared Individual Assistance counties can apply for assistance with the methods listed below. Please note, submitting a self-report damage form via Crisis Track does not count as an application for assistance, affected individuals and businesses must fill out an application for assistance using one of the methods below.

Applicants have 60 days from the date of the declaration to apply for assistance. This disaster was declared on August 15th.

Disaster Recovery Centers will be stepped up and we are working to get those locations and times finalized. It is not necessary for constituents to wait until those are available to apply for assistance, though. I would encourage constituents to begin the application process as soon as possible.



# President Joseph R. Biden, Jr. Approves Major Disaster Declaration for South Dakota

FEMA announced that federal disaster assistance is available to the state of South Dakota to supplement recovery efforts in the areas affected by severe storms, straight-line winds and flooding

from June 16 to July 8, 2024.

The President’s action makes federal funding available to affected individuals in Davison, Lincoln, Turner and Union counties. Assistance can include grants for temporary housing and home repairs, low-cost loans to cover uninsured property losses and other programs to help individuals and business owners recover from the effects of the disaster.

Federal funding is also available to state, tribal and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe storms, straight-line winds and flooding in Aurora, Bennett, Bon Homme, Brule, Buffalo, Charles Mix, Clay, Davison, Douglas, Gregory, Hand, Hanson, Hutchinson, Jackson, Lake, Lincoln, McCook, Miner, Minnehaha, Moody, Sanborn, Tripp, Turner, Union and Yankton counties.

Federal funding is also available on a cost-sharing basis for hazard

mitigation measures statewide.

Edwin J. Martin has been named Federal Coordinating Officer for federal recovery operations in the affected areas. Additional designations may be made at a later date if warranted by the results of damage assessments.

Individuals and business owners who sustained losses in the designated areas can begin applying for assistance by registering online at [www.DisasterAssistance.gov](http://www.DisasterAssistance.gov), by calling 1-800-621-3362 or by using the FEMA App. If you use a relay service, such as video relay service (VRS), captioned telephone service or others, give FEMA the number for that service.

## Mental Health Memo



### 5 Steps for Success this School Year

As summer fades and the back-to-school season approaches, students everywhere are gearing up for the shift from relaxed summer days to the structured routines of school life. This transition often brings a whirlwind of emotions—from excited anticipation to nervous uncertainty. But don't worry—with a bit of preparation, you can help turn these mixed feelings into a smooth start. Here are five simple yet powerful strategies for parents and caregivers to help students navigate the new school year with confidence, turn stress into success, and lay the groundwork for a year full of growth and achievement.

**Reconnect and Reacquaint:** Kick off the school year by helping your child reconnect with old friends and meet new ones. Arrange playdates or casual get-togethers with classmates before school starts to ease any social anxieties. Visit the school together to familiarize your child with their new environment—locate the classroom, practice using their locker, attend back-to-school events, and explore the school's website for photos of new teachers. It's also important to have a conversation with your child's teacher about any necessary accommodations or interventions related to mental health, learning differences, or past experiences. Make sure the teacher is aware of your child's Individualized Education Plans (IEPs) or 504 plan, if applicable,

to ensure that any mandated services begin promptly.

**Establish Routine and Organization:** To ensure a smooth changeover, establish a consistent routine and keep things organized. Start adjusting your child's sleep schedule and mealtimes to align with the school routine before classes begin. Boost organizational skills by color-coding academic materials, posting visual reminders of daily routines, and preparing school items the night before. Make it a weekend habit to help your child check and organize their backpack to keep everything in order.

**Foster Open Communication:** Maintain open lines of communication with your child and offer support. Instead of bombarding them with rapid questions, ask open-ended ones like, "What was the best part of your day?" or "What are you looking forward to tomorrow?" and allow time for them to respond. Validate their emotions and provide a supportive listening ear, meeting them where they are academically, socially, and emotionally. Help ease their anxieties by finding small positives to look forward to, like a favorite first-day shirt or new pencils. Additionally, plan for quiet time after the first day or week to help them unwind through calming activities such as yoga, music, journaling, or coloring.

**Encourage Good Attendance:** Promote strong attendance habits from the start. Since the pandemic, chronic absenteeism is a growing concern, with rates nearly doubling since 2019 in South Dakota, according to the South Dakota Department of Education. Even occasional absences can add up, leading to lower grades and higher dropout rates. Set clear attendance

expectations and focus on developing positive habits rather than using punitive measures. If your child shows disinterest in school, discuss with teachers or counselors about engaging in Career and Technical Education classes or other activities that align with their interests.

**Seek Support and Collaborate.** Remember, you don't have to navigate this process alone. Reach out to the school for assistance with any challenges your child might face, whether related to adjusting to the new routine, making friends, understanding academic material, or transportation and childcare issues. Schools are eager to work with families to overcome these barriers and ensure student success. Work with educators to create a supportive learning environment that promotes a sense of belonging and encourages academic achievement.

# HISTORY REVISITED

Recently an old friend of mine gave me a copy of O.E. Rølvaag's *Giants In the Earth- A Saga of the Prairie*. It's a first edition copyrighted in 1927 by Harper and Brothers and printed in the USA having been translated from Norwegian.

Book one of *Giants In The Earth* was first published in Norway by Aschehoug & CO. as a separate volume in October of 1927 with book two following a year later.

I first read this book when I was quite young, maybe too young to really understand the scope and depth of what Rølvaag was describing. I had never read a novel like this before. It really made me understand what those early settlers of this region went through to make a new start in America.

I can still remember exactly

where this book was placed in the small bookcase my parents had in our home on E. 4th St. There were other books pertaining to the history of this area but *Giants In The Earth* is the only one I remember. Many years later I read this book again and it still had the same impact on me as it did when I first read it. I will be using excerpt from its introduction for this week's column.

Growing up in Canton just a block or so from Augustana Academy where Ole attended school (it was called a college back then). I often wondered what he thought of our little mostly Scandinavian populated town on the prairie named after a city in China. I guess I'll never know for sure but I hope he enjoyed his stay here. Happy reading.

## From the Introduction to O.E. Rølvaag's *Giants In The Earth- A Saga of the Prairie* written by Lincoln Colcord in Minneapolis, MN in January 1927

Ole Edvart Rølvaag was born April 22, 1876 in a small settlement on the island of Dønna, in the district of Helgeland, just south of where the Arctic Circle cuts the coast of Norway. The place is far up in Nordland. Strictly speaking, the settlement has no name. The cove where it lies is called Rølvaag on the map but it is merely an outskirt of one of the voting precincts on the island. Rølvaag took his place name after coming to America. His father's Christian name was Peder, and in Norway he would have been a Pedersen. His own sons, in turn, would have been Olsen.

All the people in this settlement were fishermen. His father, who is still alive, is the image of a New England sea captain. The family must have been a remarkable one. An uncle, his father's brother, had broken away from the fishing life and made himself a teacher of prominence in a neighboring locality. An older brother had the mind of a scholar but something happened and he went on with fishing and died long ago. There was also a brilliant sister who died young. These two evidently over shadowed Rølvaag while he was growing up. His case as a child seemed hopeless- he could not learn. His school lay seven miles away across rocks and moors that gave him a fourteen mile walk for his daily education. He went to school nice weeks a year for seven years. This ended at the age of fourteen when his family told him he was not worth educating. That was all the schooling he had in Norway.

Once during his childhood his mother asked what he wanted to be when he grew up. "I want to be a poet," he told her. This was the only time he ever revealed himself to a member of his family.

In place of education was the reading- for this week was a reading family. The precinct had a good library, furnished by the state. Rølvaag had learned to read after a long struggle and his head was always in a book. The first novel he ever read was Cooper's *The Last of the Mohicans* printed in Norwegian. All of Cooper's novel followed and the novels of Dickens, Captain Marryat and Bulwer-Lytton. For miscellaneous reading there were such things as the tales of Jules Verne and H. Rider Haggard and Alexandre Dumas. This list could be extended indefinitely and is little short of astonishing.

Ole went on his first fishing trip to the Lofoten fishing grounds at the age of fifteen. In all he fished for five years until he had just passed twenty. Every year he was growing more discounted. He even wrote an uncle in South Dakota asking for a ticket to the United States. But the uncle refused to help him and the fishing life went on. Two more years passed when suddenly the uncle in South Dakota changed his mind. One day a ticket for America arrived. The way of escape was at hand. He landed in New York in August of 1896. For three days and nights he lived on a single loaf of bread before reaching South Dakota.

## BIG Update

South Dakota received a presidential disaster declaration for the historic flooding in the southeast portion of the state. Twenty-five counties have received disaster assistance from FEMA and four of those counties qualify for individual assistance for residents and business owners. This is great news for recovery and rebuilding efforts after many homes and buildings were destroyed.

In the aftermath of the flood, I joined Senators John Thune and Mike Rounds in sending a letter to support Governor Noem's disaster declaration request. I'm glad the President approved this request.

## BIG Idea

Project labor agreements (PLA) are a contract between the federal government and construction companies about how workers will be handled on the job site. Recently, President Biden published an executive order that federal construction projects worth more than \$35 million use a project labor agreement. These require a union to be involved, which proves difficult in South Dakota because most of the contractors in the state aren't unionized.

Requiring unionized contractors would mean construction workers at Ellsworth Air Force Base or other projects in South Dakota have to find workers from out of state. This will cost taxpayers more, hurt our state's economy, and hurt the readiness of our base.

I'm opposed to this rule and have been working to prohibit requiring these project labor agreements on federal construction projects. To learn more, watch KOTA's story about the roundtable here.

## Former food critic tells all

When Wini Moranville waited tables at the tender age of 15, little did she know she would become a dining critic known worldwide, traveling the globe in search of the perfect restaurant experience.

Former food critic for the Des Moines Register where she wrote a weekly column, *Datebook Diner*, and later for *dsm* magazine, Moranville moved on to write for major publications, one with 15 million readers.

It's that early server experience, though, that gave her an insider's view of what it takes to create a truly rewarding dining experience. After all, who knows more about good service than a person who has provided it.

So, what's the secret?

Well, the secret is in the title of her book, *Love is My Favorite Flavor*. While one may be served the most delicious and meticulously plated meal in the world, if that meal isn't complemented by excellent service, a diner might see that meal as a tragedy.

After her travels to dining venues throughout Europe, Moranville had a different take on Iowa dining.

"I honestly believe that high-end dining in America can be every bit as extraordinary as high-end dining in France," Moranville writes. "I'd remember that this was Iowa, and that these types of restaurateurs were simply giving their clients what they wanted - what else would account for the popularity of such venues? I'd simply try my best to tell people what to expect, even if I thought they demanded better."

For Moranville, it's quality, not quantity, that makes the best dining experience, but only when that quality follows through with



commensurate service that ensures the best dining experience. And after all, who would best know about quality service than a former server who knew the true meaning of farm-to-plate eating.

"I am sure this everlasting care for those who sat at my tables, and later my loyalty to those who trusted me to tell them where to find good tables, started at the source of any good food. It sprang from the soil, the black earth that surrounded our family's farm."

Iowa, Moranville maintains, with its phenomenal agricultural resources, is positioned to compete with the world's best restaurants.

Moranville tells her story with humor, experience and insight that can only come from one who grew up in the restaurant experience. Hers is a great book, and really gives you something to chew on.

# Build the Wall

"We don't complain about things - we fix them." When my dad taught me that, he was talking about cows, horses, fences, and ranch chores, not the wide-open Southern Border. But the lesson holds true.

The truth is, we could complain about President Joe Biden and Vice President (and Border Czar) Kamala Harris's failures at the Southern Border until the cows come home. Instead of complaining, South Dakota is doing our part to fix it.

We recently welcomed home our seventh detachment of South Dakota National Guard troops to the border. The last few groups have all had the mission of working with Texas to construct the border wall. We sent an engineering company - we sent builders.

South Dakota guardsmen constructed more than five miles of border wall. They fortified 20 miles-worth of wall with concertina wire. And they repaired 46 breaches in the crucial area between Del Rio and Eagle Pass, TX.

I spent a day with them helping them build the wall - it wasn't

easy work. They had to clear miles of rough ground in 100-degree heat and Texas humidity before they could get to work on barrier construction. But they were glad to do it in service to our country.

These brave soldiers were more than 1,000 miles from home. Their work was crucial to keep South Dakota - and every other state - safe. The sad reality is that due to the incompetence and mismanagement of our border, every state is now a border state.

When we control the border with physical barriers, we make it tougher for cartels to facilitate their drugs and human trafficking into our country. We funnel the traffickers towards areas where we have a stronger presence. And if anyone does try to breach the barrier, we give law enforcement and Border Patrol precious time to respond. That's just common sense - but the Biden Administration abandoned common sense when they stopped constructing the wall.

South Dakota will continue to do this work - but we shouldn't have to. President Biden and Vice President Harris are leaving the border wide

open on purpose. Texas is working with South Dakota and other states to pick up the slack.

We will continue to do our part. We have another group of South Dakota National Guard soldiers scheduled to deploy to the Southern Border on a federal activation later this Fall. And we will continue to do everything we can to mitigate the cartels' influence here at home.

I have seen such incredible patriotism and leadership from the South Dakota National Guard troops that we've deployed to the border over the years. The commander of the most recent detachments was a young female lieutenant who is working on her PhD in Animal Science at SDSU, meanwhile she is also an ROTC instructor. She's a leader. She's getting results. I wish that I could say the same about our current "leadership" in the White House.

In the meantime, we won't complain about things. We'll continue to fix them. If the Biden-Harris Administration won't build the wall, we will. We will continue to do everything we can to keep our people safe.

# Windmill Of My Mind

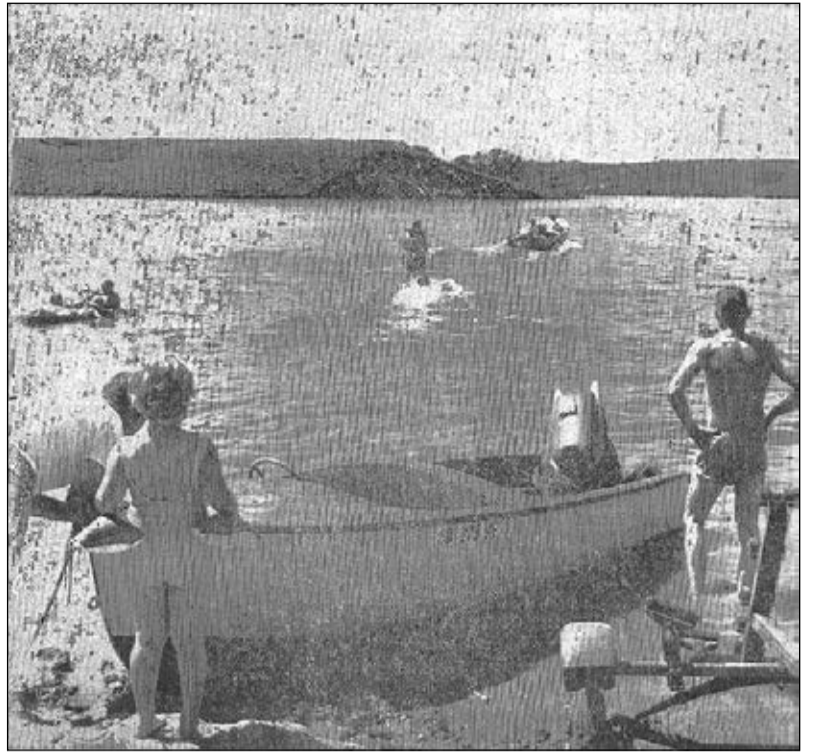

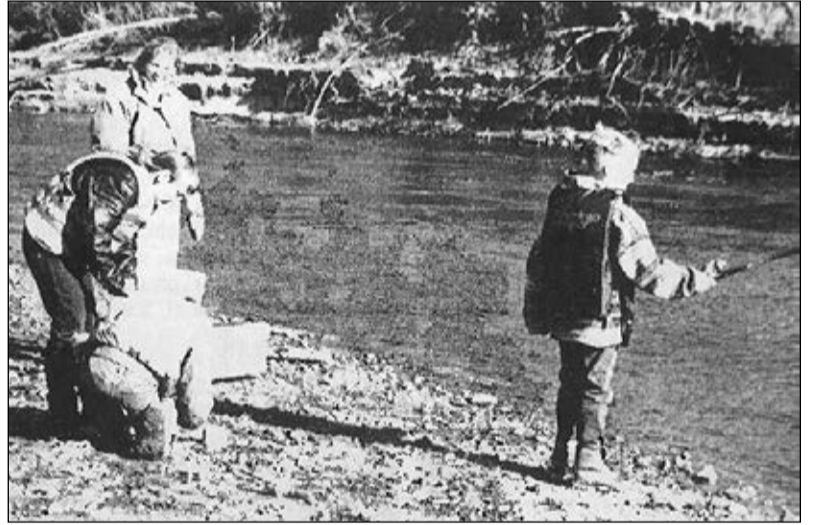

# The Biden-Harris Economy Leaves Too Many Americans

America has always been a place where if you work hard, you can get ahead. But it's gotten a lot more challenging in the Biden-Harris economy. Inflation has dealt working families a series of setbacks that have made it harder to get ahead. And it's in large part due to this administration's reckless spending.  
Three and a half years ago Vice President Harris cast her first tie-breaking votes in the U.S. Senate to advance \$1.9 trillion in spending under the guise of pandemic relief. She and Democrats in Congress had been warned that that level of spending risked setting off inflation unlike any we had seen in a generation. But they passed it anyway. And inflation began to take off almost immediately.

The White House has spent a lot of time trying to spin this economy as strong. But the American people aren't buying it. An economy where people are working harder and still struggling to get by isn't what

most Americans consider a strong economy. And it can't be America's future.  
Inflation began accelerating as a result of Democrats' reckless spending. Yet the Biden-Harris administration and congressional Democrats show no signs of backing off their reckless tax and spending agenda. In fact, it's clear they envision a lot more of the same. The administration's latest budget request is filled with burdensome new taxes and trillions in new spending. They want to see the Tax Cuts and Jobs Act expire, which would mean more tax increases on American families and businesses. And Democrats still have plenty of other tax and spending ideas they would like to implement.

## Financial Focus 529 plan can help ease college 'sticker shock'

The school year will soon be here. And if you have young children, you're one year closer to the day when they may be headed off to college. When that day arrives, will you be financially prepared?  
College isn't cheap. For the 2023-24 academic year, the average cost — including tuition, fees, housing, food, books, transportation and other expenses — was nearly \$29,000 for in-state students at four-year public colleges and universities, and about \$60,000 for private schools, according to the College Board. Most students do get some type of financial aid or scholarships, or both, but even the "net" price of college can be considerable. So, it's a good idea to begin a savings program as early as you can.  
One popular way to build money for college expenses is through a 529 education savings plan. When you invest in a 529 plan, your earnings can grow tax deferred and your withdrawals are federally tax free when used for qualified education expenses — tuition, fees, books and so on. And while you can invest in any state's 529 plan, you might be able to deduct your contributions from your state income tax or receive a state tax credit if you invest in your own state's plan.

Despite these tax benefits, some people are concerned that a 529 plan can prove costly in terms of lost financial aid. And the value of a 529 plan is looked at as an investment asset on the Free Application for Federal Student Aid (FAFSA). However, recent changes to FAFSA may mean that a 529 plan has a relatively small effect on the amount of aid you may receive.  
**A 529 plan also can be used to pay for other costs, including:**  
• **K-12 expenses**—You can use a 529 plan to pay K-12 expenses, up to \$10,000 per student per year. Not all states comply with this 529 expansion for K-12, so you might not be able to claim deductions and your withdrawals could be subject to state tax penalties.  
• **Apprenticeship programs** – A 529 plan can be used to pay for most expenses connected to apprenticeship programs registered with the U.S. Department of Labor. These programs are often available at community colleges and combine classroom education with on-the-job training.  
• **Student loans**— You can withdraw funds from a 529 plan to repay qualified federal private and student loans, up to \$10,000 for

each 529 plan beneficiary and another \$10,000 for each of the beneficiary's siblings.  
Another potential advantage of a 529 plan is its transferability. If you've named a child as a 529 plan beneficiary, and that child eventually chooses not to pursue any post-secondary education, you — as the account owner — can name another family member as beneficiary. And with the passage of the SECURE 2.0 Act, any unused 529 plan funds up to a lifetime limit of \$35,000 can be transferred to a Roth IRA for a beneficiary, free of taxes and penalties. There are certain rules governing this 529-to-Roth move — for example, you must have had your 529 plan at least 15 years — so you'll want to consult with your tax advisor before making any moves in this area.  
If you'd like to invest in your children's future education, a 529 plan can be a good choice — so study up on it soon.

# Enjoy a safe Labor Day

Labor Day provides an opportunity to enjoy one last long weekend with fun in the sun, barbecues, pool parties, and vacations. Although summer officially ends on Sunday, September 22, 2024, Labor Day typically marks the unofficial close of the summer entertaining and recreation season. As individuals and families prepare to fire up the grill or float in the pool one last time, they are reminded to heed key tips to stay safe and healthy.

- Fireworks may have been components of celebrations all summer long, but it is always best to leave fireworks displays to the professionals. Also, sparklers burn at extremely high temperatures (approximately 2,000 F) which is hot enough to melt some metals. They're are not recommended for children to handle.
- Driving while under the influence of drugs or alcohol can be a recipe for injuries or fatalities. Remember, just because it may be legal in some areas to use recreational marijuana, doesn't mean it is legal to drive under the influence of it. Individuals should leave the driving to a designated driver or a taxi or rideshare service if they plan to imbibe or use marijuana.



- Water-related injuries and deaths are highest among young children. The U.S. Consumer Product Safety Commission says drownings continue to be the leading cause of unintentional death among children ages 1 to 4. Extreme caution should be used in and around pools and other bodies of water whenever children are present. When swimming publicly, swim only where lifeguards are on duty.
- Even though summer is winding down, the risk for skin cancer remains elevated. Continue to apply sunscreen when heading outdoors for Labor Day fun.
- No one wants to leave a Labor Day barbecue with food poisoning. All party hosts should remember to keep hot foods hot and cold foods cold while entertaining and to remember to cook foods to the correct internal temperature. Even if a grilled steak looks charred on the outside, that does not necessarily mean it is well-done in the middle. Verify temperatures with a meat thermometer.
- Even the most well-behaved pets may become skittish on holidays like Labor Day, when there are many loud noises and unfamiliar sights and smells. It is best to have a pet microchipped in the event he or she gets out of the home or yard when fireworks, thunder or loud crowds scare them off. Shelters or veterinarians can scan the chip to identify the pet's owner. Labor Day closes out the summer season with a bang. It is important to continue to be safe while enjoying one last hurrah.

# Lincoln County Changes Polling Place in Harrisburg

The Lincoln County Board of Commission met Tuesday, August 13 in the Lincoln County Boardroom. With all members present, Commissioners heard agenda items including demolition assessment, polling location changes, and airport committee appointments.

Auditor, Sheri Lund joined the meeting for board discussion with possible action regarding the demolition of tax deed property in the City of Lennox. "We've got a couple options, we did get some bids to do a demolition of it, we really don't have a reason to demolish it because it has not been a nuisance. So if we do the demo, we will not be able to recoup the money in a tax deed sale," she said. Building Superintendent, John Rombough was present to give the commission an update on the structure. "The structure seems to be structurally okay as far as the framework, but inside it's very wet and it's very full of mold. The basement currently has water in it, I didn't go into the basement. Access down into the basement stairwell is too weak to probably climb down. We did move forward and have asbestos checks and I have not gotten the results of that, but I don't anticipate anything crazy showing up on that," he said. Commissioner Schmidt asked if anyone had expressed interest in the building. "I did have a couple calls regarding it because it was on the agenda earlier and they wanted to know when it was going to be sold. I told them that we were looking at other options and they said that they were in a construction business and had no worries about it because it looks sound," Lund said. Commissioner Arends suggested placing the lot on the market for a few weeks to see if it could be sold and if no interest is found, reassess and possibly knock it down. Poppins made a motion to demolish the property, with no second, the motion failed. With the motion failing, Auditor

Lund asked for a motion to declared the property as surplus, appoint an appraisal committee, and authorize the Auditor to advertise for online auction of tax deed property on September 22. Landeen made a motion to declare the property surplus, seconded by Arends. Motion passed 3-2 with Poppins and Jibben being nay votes.

Auditor Lund next requested board action to approve polling location change for Precinct 27 and Precinct 29 in the City of Harrisburg. "They will be moving it from the Harrisburg Methodist Church to the Liberty Elementary," she said. Lund explained to the commission there is more room in the commons of the school than in the church with the large populations in Ward I and Ward II. Lund will be sending notices out with the water bills each month to let residents know of the change of polling site from primaries to election day. Chairman Jibben asked for public comment and Linda Montgomery took to the podium. "I know that the VFW and their community center is an excellent place that has a lot of space. I've done meetings in there, it would be an ideal space for a voting place to be," she said. Motion approved.

Civil Deputy State's Attorney, Joe Meader joined the meeting for board action to create an Airport Consultant Selection Committee. "Every year the SDDOT and the FAA requires this board to recertify our airport consultant. There's three things that are required of this commission when we do this and one of those things is creating an airport committee to actually review these applications that we will eventually seek. The SDDOT requires a minimum three-member board to create this committee, so I'm asking for board action today to nominate members to this committee," he said. Motion approved.

Chairman Jibben opened the floor up to public comment for items

not on the agenda. (17:51) Mick Bruth?
