Liberty Sub-Division Breaking Ground Soon

The new development to the east of town will be having a groundbreaking ceremony on Wednesday, October 2nd at noon. The project passed a public hearing at the planning commission with city commissioners on April 15th of this year and the rezone became effective on May 10th. Since then, the city engineer has approved the final plans.

The name of the development will be called the "Liberty" subdivision. Street names will follow a patriotic theme such as "Freedom Trail," "Constitution Court," and "Liberty Park." The Canton Economic Development

Corporation (CEDC) in partnership with EXP Development are working together on this project. Dirt work along with the installation of water and sewer lines for the project will begin this fall, with vertical construction being started no later than mid-summer of 2025.

"The Canton Economic Development Corporation has been working on the housing department for many years. We are very excited to announce our partnership with EXP Development and the groundbreaking of Liberty Addition. We feel this will be a tremendous addition to Canton and a great

boost for Canton's economy." -Jon Frick, Housing Committee Chair

"Liberty Addition" will be made without the use of Tax Increment Financing after the CEDC applied for and received a grant through the Housing Infrastructure Financing Program, through the State of South Dakota, for \$3.72 million.

The subdivision will be made up of around fifty acres of land that is developable for housing, sixty-four acres total. Fourteen acres of non-developable land make up the required green space and water retention and detention areas to include a filtered

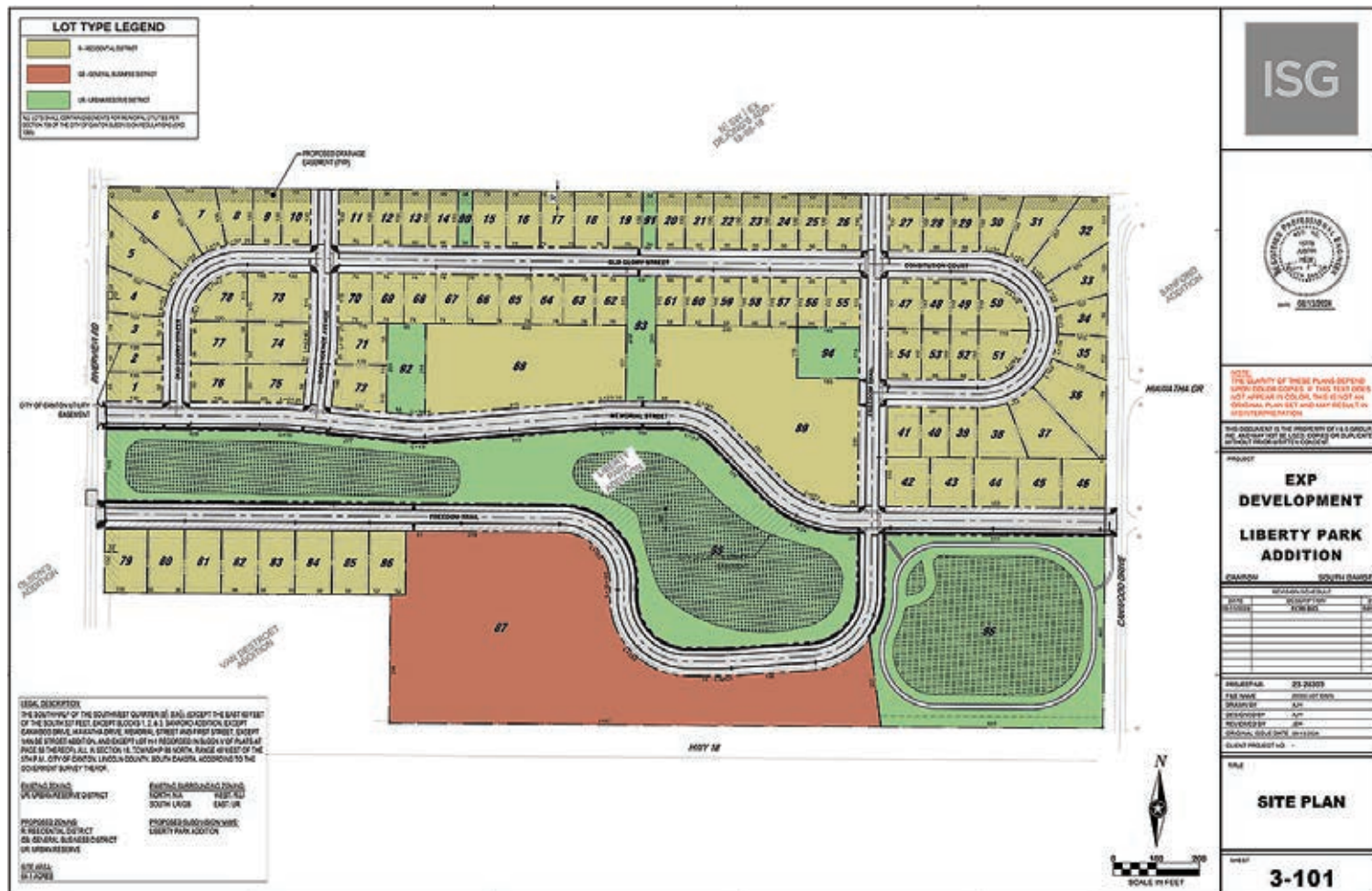
and cycled water retention area that serves as a stylistic feature. They look to develop approximately eighty-three single family residential lots, and up to two hundred multi-family/mixed use residential units. It is a four-phase plan for buildout that will be dependent on market demand. Their goal is to provide affordable workforce housing that is uniquely designed for a suburb setting. The division will eventually feature walking trails, water features, a dog park, retail, and "Grandis Pond" which will be an outdoor venue for families to have another place to gather.

Soukup Construction out of Sioux Falls will be doing the primary work for the water, dirt work, sewer, and streets. It will be \$8.3 million to complete the horizontal construction infrastructure and Soukup will likely hire a sub for the installation of water, asphalt, and sewer. The total buildout for the horizontal building will be \$10.1 million. There are several developers currently being negotiated with for the building of homes.

Charles Yi is the developer working on this project and is the owner/founder of EXP Development. He is a real-estate investor with a portfolio that spans the globe, with experience and passion ranging from the development within large cities, to developing small, rural communities. The CEDC hopes that with his help and background, he will bring more character and a value of uniqueness to the subdivision.

The multi-residential and mixed-use condominiums and townhomes represent some of the affordable products of this village community to rent or purchase. The single-level, Villa-style homes will allow seniors the ability to downsize from their homes in Canton to a more ideal situation for their current stage of life. As a result, their larger homes will be available to new, younger families looking to buy a home for their families or upgrade to a larger home. The CEDC hopes this will help address what has become a housing crisis in the Canton community.

The Folly of Formula

Farmers debate about when to plant a crop each year. If they plant too early, it could be too cold and hurt the yield. If they wait too long, it could start raining so much that they would not be able to even drive their tractor through the field. There is statistical data that shows on average what planting dates produce the highest yields. The problem is that a farmer may intend to plant during those times, but is unable to because of rain. Of course if he tried to plant into a muddy field his yield would be much lower on that date.

Best planting dates should be regarded as a general rule, not as an absolute rule without exception. The Proverbs in the Bible provide us with wisdom for living life. They are general principles of life that guide us. If we follow the wisdom of God, our lives will be much better than if we follow folly.

That however does not mean that there are not exceptions to the rule. For example, a wise man may have trials while a foolish man seems to have success. Therefore we should not look at the Word of God as a formula for avoiding problems in life, but rather as an authority to show us how God has told us to live. We should obey God regardless of the results because we recognize his authority, not because we want our lives to be

easier. Still, our lives will be easier in the long run if we do obey God.

In Ecclesiastes, Solomon makes observations about the behaviors of men. In vs 2 of ch 9 he notices that the same events happen to the righteous and the wicked. It does not seem fair to him, but he grasps that things do not always turn out like we would expect them to.

Then he comes to verse 11 where he says, "I again saw under the sun that the race is not to the swift, and the battle is not to the warriors, and neither is bread to the wise, nor wealth to the discerning, nor favor to men of ability; for time and chance overtake them all."

You expect the fast person to win the race, but he could lose if he trips. You expect the soldier to win the battle, but soldiers have been killed in battle by civilians. You expect men with ability to be respected and you expect those with good judgment to be more likely to accumulate wealth. The problem is that situations happen that make for exceptions to the general rule. He says, "time and chance overtake them."

Think of chance as statistics. The fast person may have a 99% chance of winning the race, but he could trip and lose. The verse also puts bread to the wise in that same category. We should expect that the wise will be more likely to have food, but that doesn't mean that a wise man will never face hunger.

By the time we come to verse 16, we find that wisdom is better than strength. Therefore we know that wisdom is good and valuable. As valuable as wisdom is, we should not think that having wisdom will simply solve all our problems.

Although looking to Jesus and the Bible will make our lives easier, we should not think of them as a formula for avoiding trials. Rather we should view obedience to God as the right thing to do because he said so. We should then realize that more times than not, our lives will be better because we did things his way.

On Wednesday, Sept. 17, law enforcement agents from several agencies executed search warrants or were involved in the execution of search warrants on several different locations in Canton. Two Canton businesses were searched and property was seized. Those businesses, Canton PC Repair and Canton Coffee Cup are owned by Kenneth Hunsucker of Canton. One home, the residence of Hunsucker at 711 N. Kimball, was also searched.

As of this Friday, one of the local elevators will be changing hands for the third time since Hunting Elevator was purchased by Terra in 1997. The elevator's most recent name Agro Distribution will be changed to Eastern Farmers Coop effective October 1 when the two Canton elevators become one.

Director Bud Hippe announced the new general manager for overall operations in Canton, Tea, Harrisburg, and Worthing will be former Agro Distribution Manager Kent Mulder.

After operating in a small town bank for 100 years, the Fairview Branch of First American Bank & Trust will be closing as of the close of business on December 31, 1999.

A letter announcing to Board of Directors' decision was sent out to Fairview customers on Tuesday. Customers were informed that as of the end of the year, their transactions would need to be conducted at the Canton office. Current check supplies and deposit slips may still be used and those renting safe deposit boxes will be contacted about relocating the contents to Canton.

One of Canton's own manufactured products was put to work last Thursday morning at the Dakota Villa Apartments. The machine is the Bid-Well Bridge Deck Finisher and was used to lay the new concrete parking lot for the newly constructed apartment complex located just east of Kennedy Park swimming pool. An area of concrete, 66 feet, was laid with the machine in three and one-half hours requiring six ready-mix trucks to keep the concrete supply available for the machine. Seventy yards of concrete was used to complete the project. The Bid-Well machine has a maximum capacity of 120 feet in width and a minimum of 36 feet.

The South Dakota Department of Transportation has set the evening of Wednesday, October 30 for the purpose of holding a public hearing to inform residents of this area of

the Department of Transportation plans for a portion of Highway 11. The portion of Highway 11 is that portion of the road for reconstruction is from it's junction with U.S. 18 west of Canton south fifteen miles to S.D. 46 on the Lincoln-Union County line.

HISTORY REVISITED

Since school is back in session I thought I would include a story that was written back in 1937 concerning the beginning of public schools in South Dakota. Early settlers in what was then Dakota Territory knew they had to have a place to educate their children who would someday become farmers, business owners, doctors or maybe even the governor. This story from A South Dakota Guide, published in 1938 by the Federal Writers' Project and the State of South Dakota, ends by mentioning one of Canton's must well-known figures from our past.

Speaking of former Cantonites, the Tales From the Grave: 2024 that was held on Sept. 15 did a wonderful job informing those who attended on several citizens from our very rich history. Ron Ingebrigtsen did a great job portraying "Rattlesnake Bill," a hermit who resided in Newton Hills and only came into Canton for his yearly bath and shave. We will never know for sure if he really did all the things he claimed to have done but I guess

South Dakota Education

The early settlers of South Dakota believed no community was complete until a school had been built and a teacher engaged. The first school building was erected by public subscription in Bon Homme County in 1860; the second was built at Vermillion by Company A., U.S. Cavalry, in 1862.

In the same year William Jayne, first Governor of Dakota territory, signed the original law established a school code and a common school District. In 1864 Gov. Newton Edmunds appointed James S. Foster as first superintendent of Public Instruction. It proved to be a happy choice, for this educator, grounded in the school of Horace Mann, through three successive terms laid the foundation of the present school system of the State. By 1870 there were 83 schools in the State, with approximately 1800 children in attendance.

The school district system was originally modeled after that of New England. Later the township system was introduced, with one school board having control of all schools within the township. The two systems have existed sided by side since that early day, and later legislation was enacted to permit communities to change at will from one form to the other.

The decade 1870-80 was marked by the installation of the first course of study, the enactment of much school legislation, and the raising of the qualifications for the office of county superintendent. In this time the enrollment in schools increased to more than 13,000, with 464 teachers employed.

The years 1880-90 saw a complete recodification of school laws. Courses of study were revised and United States history, temperance, physiology, and hygiene were added to the curriculum. From 1890-05 the important developments were the advent of the first grade teaching certificate, the strengthening of the compulsory education laws, and the advocacy of uniform textbooks and consolidated schools. The period from 1906-16 saw the establishment of the State Certificate, the raising of teacher requirements and the founding of consolidated schools.

The period of greatest expansion was from 1917-1929. During this time 80 percent of the rural schools of the State were built, State aid was made available for rural schools, free textbooks were provided and \$6,500 was appropriated for a State-wide educational survey. In 1919 a revision of elementary and secondary school courses was completed. In 1926 the peak of teaching salaries was reached, the high salaries attracting a better qualified class of teachers.

Since 1929 economic conditions have forced many changes, including drastic reduction in teaching salaries, amounting to more than 50 percent in many cases. The school laws were recodified in 1931. In 1933 the Legislature enacted a Gross Income Tax and assigned 50 percent of it to public education. In 1935 it replaced this measure with a Sales and Net Income Tax, apportioning 32 percent of it to the schools. This, together with the income from school lands and local taxes, forms and the present basis of school support. A present (1937) there are between 1,500 and 1,800 teachers, with more than 50,000 pupils in attendance. So much for the system of common schools; but the founders of the State felt the need of something more.

To provide further educational facilities for the youth of this new frontier, the first Territorial legislature, at its first meeting at Yankton in 1862, passed a measure to create a university of Dakota Territory. The act provided for a board of 18 regents with authority to appoint teachers, form courses of study, fix tuition, and grant degrees. The legislature was given power to determine salaries. But it was not until 20 years later that the university buildings were actually started.

As the State developed, and its agricultural, commercial, and industrial activities expanded, its school system expanded also. The interests of the State became more clearly defined, and the types of educational institutions needed became more evident. To meet these recognized needs, there are now in the State, in addition to the grade and high schools, twelve institutions of higher education, seven of them State-supported and five privately supported. W.H. H. Beadle, Superintendent of Public Instruction from 1879 to 1885, was greatly interested in the common schools of the State, and in the problem of supplying teachers for them. As a result, during the next few years normal schools were established at Madison, Spearfish, Springfield and Aberdeen.

The first institution of higher learning in South Dakota was established by Congregational Church in 1881 at Yankton. It is known as Yankton College.

The University of South Dakota was founded at Vermillion in the following year, 1882, through the aid of the people of the town and county. At present the university consists of seven colleges and schools of higher education and offers courses leading to the following degrees: Bachelor of Arts, of Science, of Science in Business Administration, of Law, of Fine Arts in Music, Dramatic Art, Painting, Public School Music and Public School Art; Master of Arts, Master of Music; and Doctor of Philosophy. There is also a university high school.

Many members of the faculty are known as the authors of textbooks and other scholarly publications, or for their contributions to scientific research. The university has granted more than 3,000 degrees. Among its more distinguished graduates is an internationally recognized scientist, Ernest O. Lawrence, who has done outstanding research in the structure of atoms.

Sinister Graves Offers In-Depth Character

Marcie R. Rendon reprises her fascinating character Cash Blackbear in Sinister Graves, third in a trilogy about a young Native woman whose special powers make her an invaluable sleuth for the local county sheriff. The trilogy follows Blackbear's exploits in North Dakota and Minnesota along the Red River region.

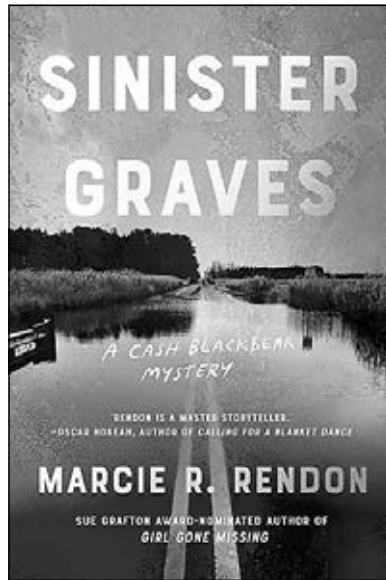
Rendon, an enrolled member of the White Earth Nation, lives in Minneapolis.

In her latest book of the trilogy, Cash is called by Sheriff Wheaton for her assistance in solving a murder. At first glance, Cash would hardly seem an unlikely partner in solving crime. Product of an abusive foster system, Cash shatters the stereotype of a helpless female. A pool shark approaching the professional level, she has a take-him-or-leave-him approach to men, bouncing from her on-again off-again married lover Jim to Al, a Vietnam vet – not that Cash is free with her affections. She has merely taken on male values in a female body.

It seems though that even Cash has met her match when she begins to investigate a fundamentalist minister and his wife. She more she gets to know them, the stranger they seem, until Cash feels herself drawn into the pastor's charismatic yet deadly charms.

The appearance of an evil apparition tied to the pastor becomes even more frightening. When Cash seeks the help of Jonesy, a Native healer woman, she begins to cope with the evil around her.

Rendon's description at the novel's opening is absolutely mesmerizing. She takes us directly to the flooded Red River Valley and the hardy souls that inhabit it. Her pacing rockets us



from incident to incident, making this the quickest read of the series.

Rendon reaches beyond the novel, though, and shows how brutal Native boarding schools once were and how the foster care system continues to be for Native children. Only with passage of the Indian Child Welfare Act of 1978 did the abuse begin to lessen.

Rendon also eloquently captures the essence of the Native spirit and humor that comes to light under the lamp of historic oppression of the Native people.

Sinister Graves goes beyond the crime genre to a rightful place in the literary genre. Rendon's understanding of Native issues and social challenges places her in the top tier of other talented Native writers such as Louise Erdrich and Sherman Alexie.

This is a great book, and impossible to put down.

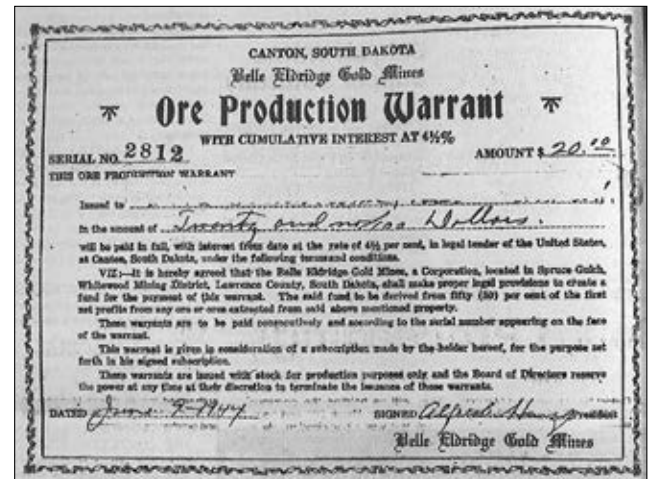
OFF The Road With Jerry



This is a copy of a Gold mine owner certificate from the Black Hills mine. This was something I showed in Sioux Valley News and I asked for a response from the public. One of the responses said they actually owned one. This was turned into a small group of owners from Canton. Some of the men in 1935 that formed this group were Alfred Haug, Ove E. Eillefson, Oscar Bregstead, who was this companies agent, Arthur I. Johnson, who was the engineer, and Curt R. Johnson who was the business manager.



This is a picture of one of the old mines. I was there a long time ago on one of many numerous trips to Black Hills. The old timbers are falling apart and sagging dangerously. This is in northern Black Hills, northwest of Deadwood in the large ghost town area of old mines. The first Belle Eldridge mine was in Spruce Gulp in Lawrence County. This mine is higher up the ridge east of Spearfish Canyon.



This was the mines Ore Production Warrant. This production Certificate was sold as a share for Twenty dollars. Around early 1900's the first Belle Ellridge mine was started by Aaron Dunn of Deadwood. It was put on record in 1877 and may have been a working mine all the way to 1960's and shutdown for good around 1974. It was always a low volume producer of gold, only ever getting a little at a time. I own a few mine shares and certificates which have no value except historic.



This animal is all over the Black Hills and they were a pest when we were camping near the ad gold mine. This porcupine was in Canton in 2007, Tom Petry, Game Warden at that time came with a shovel and drove it into a large pen cage, but the game dept only moved this animal to Newton Hills Park. They are thick in the Black Hills and some of the prairie counties around the mountains. Never go up near one because those long sharp quills are very painful.

South Dakota also has two VA medical centers, two vet centers, eight community-based outpatient clinics, numerous mental health care facilities, and 11 community mental health centers to assist veterans and their families.

Know the risks of investing – and not investing

Investing involves risk — and so does not investing. You should know how both these types of risk can affect your ability to reach your financial goals.

Let's start with the risks associated with investing. There's not a single investment risk because different types of investments carry different types of risk. Here's a look at three investment categories and some of the risks connected with them:

- Stocks – When you invest in stocks or stock-based mutual funds, you will incur the risk that the value of your investments may decline. Stock prices can fall for any number of reasons – lower-than-expected earnings, a change in management, change in consumer tastes, and so on. Although the historical trend for stocks has been positive, there will always be periods when prices are down. One way to help defend against this volatility is to hold stocks for the long term, rather than constantly buying and selling, and to own a mix of stocks from different industries and even different countries.

- Bonds – When market interest rates rise, the value of your bonds can decline because investors won't pay full price for them when they can get the newer ones that offer higher rates. Another type of risk associated with bonds is credit risk,

which essentially describes the risk that the bond issuer may default, potentially disrupting your flow of interest payments. However, you can help mitigate this risk by purchasing investment-grade bonds that receive the highest credit ratings from independent rating agencies.

- Certificates of deposit (CDs) – Although CDs are generally considered safe because their principal is guaranteed, they do carry reinvestment risk — the risk that you won't be able to reinvest the proceeds of a maturing CD at the same interest rate. To help protect against this risk, you could own CDs of varying maturities. When market rates are low, you'll still have your longer-term CDs paying higher interest, and when market rates rise, you can reinvest the money from your maturing shorter-term CDs into the new, higher-paying ones.

Now, let's turn to a completely different type of risk — the risk of not investing. And this risk is easy to understand: If you don't invest, or if you consistently invest only in the most conservative vehicles, your money may not grow enough to allow you to reach your important long-term goals, such as a comfortable retirement.

Of course, this doesn't mean you should never own conservative

investments, including CDs and some types of bonds. When you're saving for a short-term goal, such as a down payment on a house, a wedding or a long vacation, you want the money to be there when you need it, so an investment that offers protection of principal may be appropriate, even if it doesn't provide much in the way of growth.

For those long-term goals, though, you may need to build an investment portfolio that contains growth potential and that reflects your personal risk tolerance and time horizon. Over time, your risk tolerance may change. As you get closer to retirement, you may want to take a somewhat more conservative approach — but you'll always need some elements of growth.

When you invest, risk can't be eliminated, but it can be managed. Keeping this in mind, consider a long-term investment strategy that allows for risk but also offers the possibility of reward.

On National Defense, We Can't Take Our Eye Off the Ball

Every day, American servicemen and women stand ready to defend our nation. They stay vigilant to counter any threat, and they and their families make innumerable sacrifices in service to our country. And it's their dedication and courage – and that of the generations of Americans who came before them – that have secured the freedoms we enjoy as Americans.

Providing for our nation's defense is the most important thing I do in Congress. But it's not a one-and-done exercise; we shouldn't expect that a one-time buildup will provide the military with everything it needs to keep the nation safe. Technology and tactics change, threats evolve, and even the strongest reputations fade if they're not backed up with substance. So maintaining a robust national defense has to be a permanent focus, year-in and year-out. It has to be a priority.

Unfortunately, we are not where we should be when it comes to national defense. The Commission on the National Defense Strategy recently released its assessment that "the U.S. military lacks both the capabilities and the capacity required to be confident it can deter and prevail in combat." Another report from the Strategic Posture Commission reads, "Today the United States is on the cusp of having not one, but two nuclear peer adversaries, each with ambitions to

change the international status quo, by force, if necessary: a situation which the United States did not anticipate and for which it is not prepared."

While our preparedness lags, the world isn't getting any safer. We've seen an unnerving increased alignment among our adversaries. Russian and Chinese bombers flew together 200 miles off the coast of Alaska this summer. Iran and North Korea have both provided Russia with missiles to use in Ukraine. Then, there are the threats to our allies. In the South Pacific, China has grown increasingly aggressive toward Japan, the Philippines, and Taiwan. In the Middle East, our military continues to combat Iran-backed terrorists that have attacked commercial shipping and launched attacks against Israel, and Hamas still holds more than 100 hostages from its attack against Israel, including seven Americans.

There's no time to waste, yet Democrats have kept our national

defense funding on the backburner. Every one of the Biden-Harris administration defense budget requests has failed to keep pace with inflation. And Senate Democrats have shown once again that the annual defense bills are near the bottom of their priority list. A bipartisan defense authorization was passed by the Armed Services Committee months ago, but week after week the Senate's business has largely been confirming Biden nominees and political show votes on bills going nowhere.

Our adversaries haven't put their national defense on the backburner, and neither should we. Inaction sends the wrong message to our adversaries and allies, not to mention it hamstringing our own military's ability to modernize and evolve with the threat environment. Failure is not an option. We owe America's servicemembers – and the national security imperatives of our great nation – more than last-minute legislating.



Safe Streets, Smarter Policies

BIG Update
For years, Immigration and Customs Enforcement (ICE) has said that sanctuary cities create a public safety threat and are one of the biggest impediments to ICE's public safety efforts. A sanctuary city's refusal to cooperate with ICE puts local law enforcement officers in danger.

After four years of the Biden border crisis, sanctuary cities have received tens of thousands of illegal immigrants. Biden's soft-on-crime and open border policies have made these communities, and others around them, less safe.

These cities have used taxpayer dollars to solve problems their own bad policies have made. This should not be the case. I voted to pass the No Bailout for Sanctuary Cities Act to ensure no taxpayer dollars are used to fund housing, food, and healthcare costs for illegal immigrants.

BIG Idea
The South Dakota Auto Dealers Association knows how difficult

it would be to limit vehicle emissions to meet the EPA's overly burdensome rule. This rule would effectively require two-thirds of all new cars to be electric vehicles by 2032. Not only do we not have the infrastructure to support this EV adoption, but it outpaces consumer demand and severely limits your options when purchasing a vehicle. This week I voted to end this unreasonable EPA rule.

BIG News
I voted to keep our government funded and require proof of citizenship to vote in federal elections. We must ensure election integrity. Showing a photo ID is a commonsense way to do that. Recently, Oregon discovered hundreds of noncitizens were mistakenly registered to vote, compromising our election security.

Keeping the government funded and operating and safeguarding our voting process are essential tasks of my job in Congress.



Duplication of Benefits: What it Means

SIOUX FALLS, S.D. – When determining the amount of federal disaster assistance provided by FEMA to applicants affected by this summer's severe storms and flooding, part of FEMA's process is to verify there is no "duplication of benefits".

By law, FEMA cannot provide financial assistance when any other source, such as insurance, charities, or crowdfunding, has provided assistance for the same disaster-caused need or when that funding is available from another source.

Note: If the crowdfunding campaign is for general disaster recovery and not for a specific item FEMA provided, then it is not considered a duplication.

Example of a duplication of benefits: FEMA cannot pay for home repairs if a homeowner already is receiving sufficient funds from their insurance company for the same repairs.

FEMA assistance is not a substitute for insurance and cannot compensate for all losses caused by this summer's severe storms and flooding. Grants from FEMA are intended to meet

basic needs and supplement an applicant's disaster recovery needs.

Insured applicants must provide documentation to FEMA that identifies their insurance settlements or benefits before FEMA will consider their eligibility for some programs that may be covered by insurance.

FEMA may provide money to help meet an applicant's immediate needs when their insurance benefits are delayed for 30 days or more through no fault of their own.

Applicants who have received FEMA funds are urged to keep receipts of their disaster spending for three years to document that the money was used to meet disaster-related needs. If a recipient receives an insurance settlement to cover the same expenses, they must reimburse FEMA. Applicants' cases may be reviewed to confirm money was spent properly.

FEMA's mission is helping people before, during, and after disasters.

FEMA Assistance Won't Affect Other Federal Benefits

SIOUX FALLS, S.D. – If you live in Davison, Lincoln, Turner, or Union counties and you had loss or damage from the severe storms and flooding that occurred June 16 – July 8, you may be eligible for FEMA disaster assistance.

FEMA assistance is not taxable. Applying for disaster assistance will not affect other federal benefits you may receive.

Accepting FEMA funds will not affect eligibility for Social Security, Medicare, Medicaid, Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF), Low Income Energy Assistance Program (LIEAP), Child Care Assistance, or other federal or state benefit programs.

Disaster funds help survivors pay for temporary housing, essential home repairs, essential personal property replacement, and other serious disaster-related needs not covered by insurance or other sources.

The deadline to apply for FEMA assistance is October 15, 2024.

Harvesting Our Own Food Supply

Growing up on our family farm and ranch, there were two time periods that were busiest: calving season in the spring and harvest in the fall. The time has come for farmers to harvest most of their crops. It's the fruit of their labor after a long growing season.

If farmers see good rainfall and fair weather, hopefully they have a strong harvest. If not, they pray for a better year next year. Unfortunately, many estimates show that 2024 will be one of the biggest drops in farm income on record due to drought in some parts of the country, severe storms in others (including here in South Dakota), and low commodity prices. I have worked on ag policy for 30 years – but this has been a hard year.

To make matters harder, that decline in farm income comes as prices remain persistently high for the basic necessities in life, like food, gasoline, and electricity. Farmers have to take care of their own families, too. And when farmers have smaller harvests, that means that the cost of those crops goes up at the grocery store.

Now more than ever, we need to thank our farmers for the work that they do, and we need to support them. They grow our food – we would be lost without them.

For that reason, I have made taking care of our ag producers a top priority as Governor of South Dakota. We've worked on numerous new laws and other actions to preserve agriculture for our next generation. We celebrate all our family farms, especially when they reach 100 years or more of ownership in the same family.

This past year, South Dakota passed the best bill in the nation to keep the Chinese Communist Party and other Evil Foreign Governments from owning our state's precious farm land. China would never allow

us to buy land in their country – they don't even let their own people buy their land. We should not allow our enemies to become our neighbors.

I hope that other states follow our example. After all, South Dakota is just one state out of 50. Since passing that legislation, we just received our first report from my Department of Revenue, and there were no attempted purchases of ag land by Evil Foreign Governments in South Dakota. But we know that it is happening in other places. China's ownership of American ag land grew by more than 5,300% in just a 10-year period.

And this threat is taking on emerging forms. Water rights have increasingly become an issue as foreign countries have attempted to lease American farmland as a means of stealing our water. And Russia has been buying American cattle to bolster its own beef production with our superior cattle genetics. They want to be competitive with our own beef industry. If they succeed, they will make it much tougher for us to maintain control of our own food supply. As I have said many times, our enemies – especially China – are attempting to infiltrate every aspect of our way of life.

As long as America can feed itself, we control our own destiny. Food security is a matter of national security. We need a strong and diversified food supply, and we must not rely on other nations – much less nations that hate us – to provide our food.

So we need our farmers. We need them to do well, to keep their farms in business, and to continue growing and raising the food that we enjoy on our dinner tables every night. I pray that our farmers enjoy a fantastic harvest. And I will keep doing everything in my power to guarantee their ability to grow our food for years to come.

Former Canton Township Treasurer and Business Owner Behind Bars

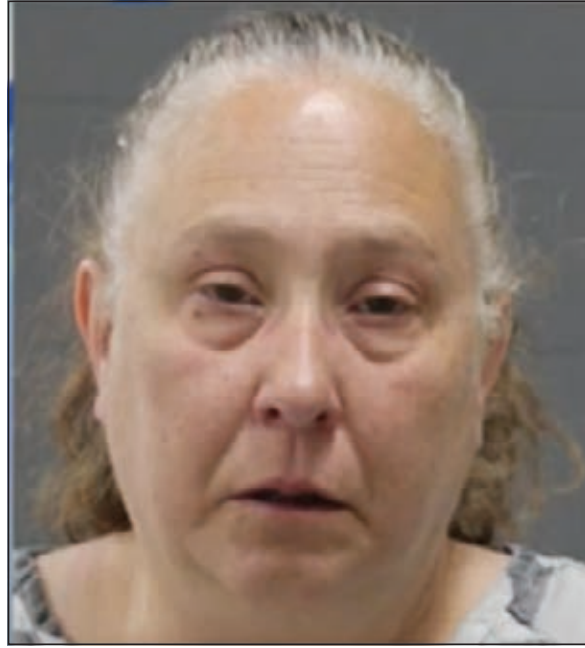
An investigation began last summer when board members of the Canton Township noticed questionable activity in the bank account. Peggy VanDeKieft served on the Township board in various positions but was elected as the treasurer in 2005. The internal audit shocked the board when approximately \$166,000 was illegally spent by VanDeKieft over the last seven years. At this point it was turned over to have a forensic audit performed. The Township learned that the value of misuse or misappropriation of the Township assets and cash exceeded \$559,000. Along with this, the Township paid \$39,000 in interest on operating loans along with over \$23,000 in forensic accounting fees/services. "Peggy VanDeKieft betrayed and stole from not just the Township, she knowingly betrayed and stole from the Township residence, which includes family members, neighbors, and friends who all pay taxes," said in a letter by township Chairman Tim DeJong, Supervisor Sam Eiesland and Supervisor Mike Knutson.

VanDeKieft also owned and operated State Line Insurance on South Broadway Street in Canton.

The initial request for warrant for VanDeKieft was filed on December 6, 2023. She was held in the Minnehaha County Jail with a cash bond of \$10,025 for crimes of Count 1: Aggravated Grand Theft- Embezzlement of Property Received in Trust, a class 2 Felony, County 2: Forgery, a class 5 Felony and County 3: Falsification of Public Records, a class 1 Misdemeanor.

Embezzlement investigation went from January 12, 2016 until June 5, 2023. Court exhibit shows that VanDeKieft paid herself over \$80,000 over that time from the Township account. Payments were also made to State Line Insurance in amount of over \$38,000. The Township account was also used to pay many Insurance group companies over \$354,000. Other items were purchased from different companies over the years of more than \$85,000.

VanDeKieft posted bond on December 27, 2023 with a trial date in March of 2024. A motion and order for delay was filed on February 9, 2024 on her behalf to



delay trial for two trial cycles. This delayed the trial date to the end of May. Another motion and order for delay was filed on April 5, 2024 to delay it again on her behalf until the middle of June.

"She pled guilty to one count of embezzlement, which is a class 3 felony in the state of South Dakota. The sentencing agreement was that the state would not ask for more than seven years in the penitentiary. Class 3 felonies have the opportunity to carry up to 15 years of penitentiary time. So the cap versus the actual allowance under state law was a little bit different," Lincoln County Deputy State's Attorney Joseph Meader said.

The judge sentenced VanDeKieft to 15 years in prison with 10 years suspended. She's also ordered to pay \$511,004.04 in restitution to the Township.

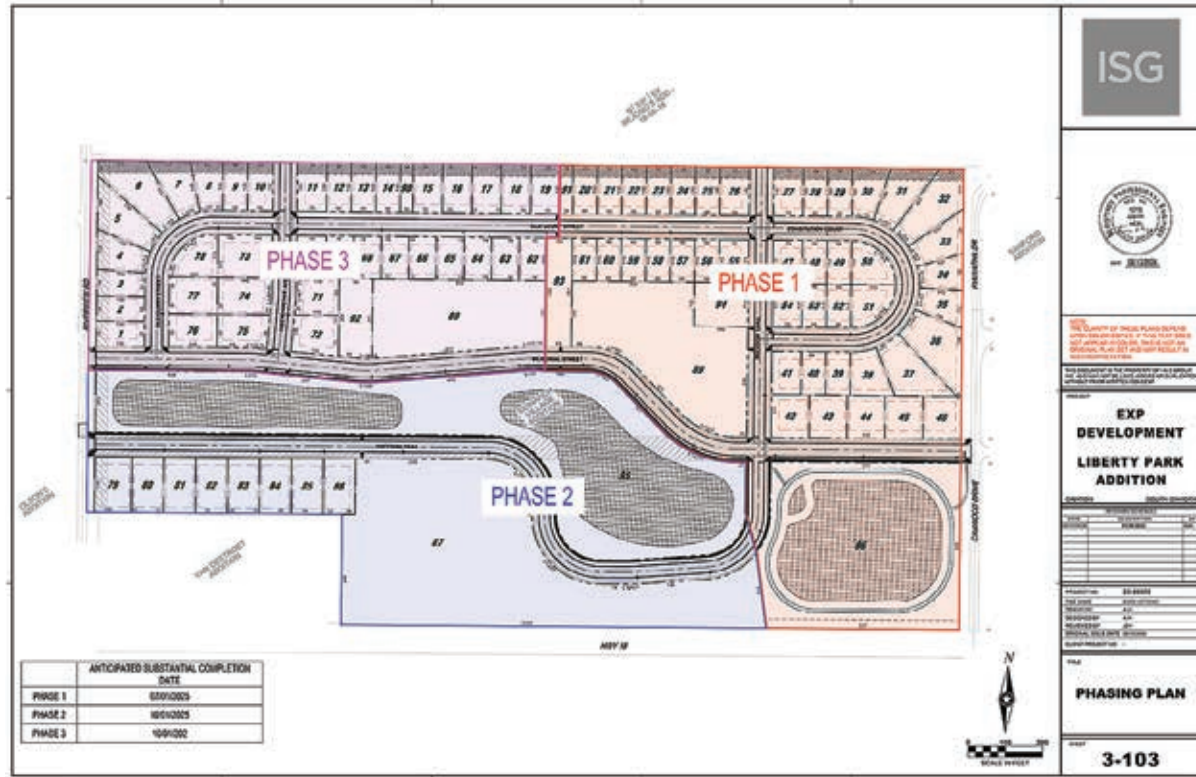

Future of City Administrator Position Uncertain

The Canton City Commission met in regular session on Monday, September 16 at 7 p.m. at the Depot. All Commissioners were present at the time of roll call.

With no Visitors to be Heard, the first item under Old Business was a Statement of Interest. The City received two Statements of Interest from Engineering Firms to assist with flood resilience and economic recovery planning. The selection committee met on Thursday, September 12 and selected ISG to complete the study. Citizen Chad Skiles took to the podium and said that it would be premature to move forward without a proposal from both firms. Skiles thanked the Commission. City Engineer Myron Adam went to the podium and explained how JSA could help the City due to the longevity and knowledge of the City. He said they would be willing to submit a proposal. Commissioner Paul Garbers noted that they did not know the costs of the project at this time, but the City is fighting a deadline with FEMA and the colder weather is coming soon. Commissioner Tyler Larson asked why both firms are not submitting a proposal for the City. Motion to approve ISG to complete the H&H Study subject to final contract and funding being secured by Garbers. Seconded by Commissioner Kris York. Larson nay. Commissioner Jackie Pigors nay. Garbers aye. York aye. Mayor Sandra Lundstrom nay. Motion fails 2-3.

Motion to ask for both Engineering Firms to submit proposals for the work the City wants done (specifically Cedar Street) by Larson. Seconded by Pigors. Unanimous approval.

Next under Old Business was the Second Reading -2025 Appropriation Ordinance. The First Reading was held on September 3. If approved, it will be published on September 26 and effective January 1, 2025. Motion to approve by Pigors. Seconded by Larson. Unanimous approval.

Next under Old Business was the Second Reading of Ordinance to Repeal & Re-enact Chapter 30: Mayor & City Commissioners. This is in conjunction with setting up for a City Administrator. The First reading was held at the September 3 City Commission meeting. Motion to approve by Pigors. Seconded by Garbers. Unanimous approval.

The final item under Old Business was the Second Reading

of the Ordinance to Repeal & Re-enact Chapter 31: Appointed Officers & Employees. This is in conjunction with setting up a City Administrator. Motion to approve by Larson. Seconded by Pigors. Unanimous approval.

The first item under New Business was the Rezone Hearing - Jason & Hope Bryant at 305 North Noid Road. Planning & Zoning has conducted their hearing on August 27 for the proposed Ordinance for Jason & Hope Bryant for a rezone from General Business District to Residential District at 305 North Noid Road and recommends approval of passage. Bryant joined via telephone to answer any questions. Mayor Lundstrom opened the hearing. With no opponents and no proponents, Mayor Lundstrom closed the hearing. Motion to hold the First Reading by Larson. No second and vote is needed for a First Reading.

Next on the agenda was the Hearing for Planning & Zoning Ordinance Relating to Accessory Buildings, Definitions & Fences. Planning & Zoning has conducted their hearing on August 27 and recommends approval of passage for an Ordinance relating to accessory buildings to not allow shipping containers or pod-type storage, their definitions and updating the wording regarding the face side of fences. Mayor Lundstrom opened the hearing. With no opponents and no proponents, Mayor Lundstrom closed the hearing. Motion to hold the First Reading by Larson.

Next on the agenda was the IM28 Resolution. IM28 (Grocery Sales Tax Repeal) will have a negative impact on the City's budget if the measure is passed by the voters. Below is the official resolution:

CITY OF CANTON, SOUTH DAKOTA WHEREAS Initiated Measure 28 was certified for the November 2024 General Election Ballot by the South Dakota Secretary of State; WHEREAS Initiated Measure 28, if passed, would remove state, municipal and tribal taxes on all items sold for human consumption except alcohol and prepared food; WHEREAS "human consumption" is undefined in South Dakota Codified Law or the South Dakota Constitution. Black's Law Dictionary defines "consumption" as "the act of destroying a thing by using it; the use of a thing in a way that exhausts it."; WHEREAS South Dakota Codified Law 34-45-1(7) defines tobacco products as "any item made of tobacco intended for human consumption, including

cigarettes, cigars, pipe tobacco, and smokeless tobacco, and vapor products as defined in § 34-46-20."; WHEREAS South Dakota Codified Law 10-52-2 allows incorporated municipalities to impose a tax on the sale, use, storage and consumption of items that conform in all respects to the state tax on such items up to two percent; WHEREAS the Attorney General's explanation of the measure states legislative or judicial clarification would be needed if the measure passes; WHEREAS The City of Canton levies a two-percent sales tax and collected \$1,520,048.00 in the 2023 fiscal year and \$1,072,594.00 year-to-date in the 2024 fiscal year;

WHEREAS The City of Canton estimates annual lost revenue of \$216,000.00 unless Initiated Measure 28 is rejected by voters in South Dakota. NOW, THEREFORE, BE IT RESOLVED, by the City Commission of Canton, that Initiated Measure 28 would negatively impact the municipal budget in our community. Dated this 16th day of September 2024.

Tickets will cost \$10 for 1 Ticket or \$50 for 6 Tickets and will be sold from November 1, 2024 until January 18, 2025. There will be 8 winners drawn. Motion to approve by York. Seconded by Garbers. Unanimous approval.

Next under New Business was the Resolution to Set Hearing Date for Special Assessment - Nuisance Abatements. As part of the nuisance abatement process, the City incurred costs for hiring contractors for mowing, yard clean-up, removing snow, and structural review. By law, those bills that remain unpaid can be assessed to the property. The special assessment process provides that the governing body: (1) set a public hearing; and (2) notify the property owners of the hearing by both sending notice and publishing the notice of the

hearing. The notice calls for the public hearing to be held on October 21, 2024. Following the public hearing, the City Commission will adopt a resolution approving the special assessment roll with any adjustments. Motion to set the hearing date for October 21, 2024 at 7 p.m. by York. Seconded by Pigors. Unanimous approval.

Banners on 5th Street for Veterans Day was next on the agenda. Citizen Paul Sogn came to the podium and explained how they have a committee that would like to hold a fundraiser to put banners of our Veterans along the highway to honor them. Sogn said they already have approval from the State for right of way. After some discussion, motion to move forward with the banner project on the aluminum light poles contingent on the Public Works Director's approval by York. Seconded by Larson. Unanimous approval.

The Beaver Creek Sanitary Sewer Repair Recommendation was the next on the agenda. Under exigent circumstances, City Engineer Adam went and received three quotes for the Beaver Creek Sanitary Sewer Repair. The quotes were opened at the meeting. Motion to award the Beaver Creek Sanitary Sewer Repair Project to H & W Contracting in the amount of \$721,237.50 by Garbers. Seconded by Pigors. Unanimous approval.

Next on the agenda was New Hire Hire - Part Time Police Officer. It is being recommended to hire Colton Laubach in the Part-Time Police Officer position at \$27.53/hr (Grade 12, Step 1). He will have a 6 month probationary period and may be eligible for a step increase after that time. Motion to approve by Larson. Seconded by Garbers. Unanimous approval.

Next under New Business was the State Water Plan with DANR. The City is looking to potentially secure funding for the Infrastructure Expansion Project with Lincoln County. Harley Ferguson from SECOG (Southeastern Council of Governments) is willing to submit the project to be listed on the State Water Plan with DANR by the deadline of October 1. Motion to approve by Garbers. Seconded by Larson.

The City Administrator Job Description was next under New

Business. Pigors stated that she had some changes she wanted to make to the description including grant preparation, communication duties, etc and showed the Commission. Garbers said he wanted the description to show that this position runs the City. City Attorney Larry Nelson came to the podium to explain to the Commissioners what South Dakota Codification allows under a City Administrator and the difference between a City Manager and City Administrator. He also recommended to the Commission that they follow State Statute to avoid any issues. Former Canton City Commissioner Moses Isais took to the podium and asked the Commission if they knew the difference between a City Administrator and City Manager. Isais noted that it is coming across that they are discussing a City Manager and that form of government (City Manager form of government) did not work in Canton. He said they need to figure out what they want under Canton's current form of government before making any decisions. Isais thanked the Commission. After approximately 45 minutes of discussion, motion to approve the job description for the City Administrator as presented and amended by Pigors. Motion dies to lack of second. No further discussion and action was taken regarding the future of the position/job description.

The final item under New Business was the Land Tillage/Hay Proposals. The City received two proposals to till and hay the acres at the City Farm Ground. Motion to advertise for bids for the City Farm Ground with the bids being due by October 10, 2024 at 3 p.m. by Garbers. Seconded by Larson. Unanimous approval.

During Commissioner Dialogue, Mayor Lundstrom thanked everyone that attended the Town Hall Meeting about the City Administrator position. With no further discussion, motion to enter executive session for legal purposes at 9 p.m. by Larson. Seconded by Pigors. Unanimous approval.

After returning into regular session, no action was taken. Motion to adjourn by Larson. Seconded by Pigors. Unanimous approval.

C-Hawks Fall to SF Christian 49-7 for Their First Loss

The Canton C-Hawk football team traveled to Sioux Falls on Friday night to play the Chargers for their homecoming game and the Hawks fell 49-7 to suffer their first loss of the season and fell to 3-1 for the season and next they travel to West Central in Hartford to face the Trojans with a 2-2 record with losses to SFC and Lennox and wins over Belle Fourche and McCook Central/Montrose. Game kick off will be 7:00pm.

APPOINTED OFFICERS
§ 31.01 APPOINTMENT OF OFFICERS

The City may appoint such officers as needed and provided for herein. Each officer shall be appointed by a majority vote of the members elected to the governing body. Such officers shall be appointed annually. All appointive officers, except the Finance Officer, shall be commissioned by warrant, under the corporate seal, signed by the Mayor and Finance Officer. The Mayor shall issue a certificate of appointment under the seal of the municipality to the Finance Officer.

§ 31.02 OATH OF OFFICE
Each appointed officer, before entering upon the discharge of the duties of the office, shall take and subscribe an oath or affirmation to support the Constitution of the United States and of the State of South Dakota, and to faithfully discharge the duties of his or her office. The officer shall file the form within ten days after the first City Commission meeting of the month following his or her appointment.

§ 31.03 QUALIFICATION AND DISCHARGE OF DUTIES OF OFFICE

Each appointive municipal officer shall begin discharging the duties of the office as soon as the officer has qualified by the filing of oath or affirmation of office. The officer shall hold office until reappointment or appointment and qualification of a successor.

§ 31.04 VACANCY OF OFFICE
The removal of any appointed municipal officer of the city or for the officer's failure, within ten days after the first meeting of the month following the appointment, to qualify and begin the duties of office, causes a vacancy in the office. Any appointed officer may be removed by a majority vote of the members of the Commission.

§ 31.05 APPOINTED OFFICES
(A) The City Commission shall appoint the following offices:

- a. Any open terms of:
 - i. Library Board of Trustees;
 - ii. Planning and Zoning Commission;
 - iii. Airport Board;
 - iv. Recreation Board; and
 - v. Celebrate Canton Board.
- b. One Member of the Tree Board.
- c. Fire Chief.
- d. Finance Officer.
- e. City Attorney.
- f. Chief Law Enforcement Officer.

(B) The City Commission may appoint the following offices:

- a. City Administrator;
- b. Engineer; and
- c. Building Inspector.

§ 31.06 MISCONDUCT; DELIVERY OF RECORDS TO SUCCESSOR
It is a Class 2 misdemeanor for any

municipal officer to commit a palpable omission of duty or to intentionally commit oppression, misconduct, or malfeasance in the discharge of the duties of office. Upon conviction of a violation of this section, the court of conviction may in its discretion enter an order removing the officer so convicted from office.

Any person having been an officer of any municipality shall, within five days after demand, deliver to his successor in office all books, property, and effects of every description in his possession belonging to the municipality or pertaining to his office. Upon refusal so to do he shall be liable for all the damages caused thereby and to such penalties as may be prescribed by ordinance.

§ 31.07 DUTIES
The duties of appointive officers of the city shall be such as are ordinarily undertaken by said officers and as provided by the ordinances of the city and by the statutes of the state. Such officers shall do and perform such duties as may be assigned to them by the City Commissioners.

MUNICIPAL EMPLOYEES
§ 31.08 MUNICIPAL EMPLOYEES
The City Commission shall hire personnel, professional and otherwise, required and necessary for municipal purposes, including but not limited to, a Chief Law Enforcement Officer. The compensation of such employees shall be set by the City Commission.
§ 31.09 EMPLOYMENT POLICIES
All policies regarding personnel regulations and benefits of the City shall be included in the Personnel Policy Manual, which shall be filed with the Finance Office. A copy shall be made available to all employees following the date of hire, following any amendment of personnel manual, or upon request by city employee.

§ 31.10 BACKGROUND CHECK REQUIRED
Each person over eighteen years of age seeking employment with the city shall submit, subject to the discretion of the city, to a state and federal criminal background investigation by means of fingerprint checks by the South Dakota Division of Criminal Investigation and the Federal Bureau of Investigation. The city may submit completed fingerprint cards to the Division of Criminal Investigation before the prospective new employee enters into service. Upon completion of the state and federal criminal background check, the Division of Criminal Investigation shall forward to the city all information obtained as a result of the check. Failure to submit or cooperate with the criminal background investigation is grounds for denial of an application.

City Attorney and City Engineer
§ 31.11 CITY ATTORNEY
The city shall contract for legal services or employ an attorney under such terms and conditions as the governing body shall deem proper. Any contract for legal services with an attorney shall be made by resolution. Such contract shall set forth the compensation to be paid and the specific services to be rendered. When required, the city attorney shall furnish an opinion upon any matter relating to the affairs of the municipality or the official duties of such officer; conduct the prosecution of all actions or proceedings arising out of the violation of any ordinance; and perform such other professional services incident to office as may be required by ordinance or directed by the governing body.

§ 31.12 CITY ENGINEER
The City shall contract with a city engineer. The city engineer shall be a licensed professional engineer under SDCL Chapter 36-18A. If the city engineer is not also licensed as a land surveyor, the city engineer shall delegate any duties for the practice of land surveying to a licensed land surveyor. The governing body shall by contract, prescribe the duties and fix the compensation of the city engineer. All surveys, profiles, plans, or estimates made by the city engineer for the city are the property of the city and shall be carefully preserved in City Hall or the office of the city engineer and are open to public inspection.

§ 31.13 APPOINTMENT
The Finance Officer of the City shall be appointed by a majority vote of the governing body, and shall be appointed annually or at intervals determined by the governing body.
§ 31.14 QUALIFICATION AND DISCHARGE OF DUTIES
The municipal Finance Officer shall begin discharging the duties of the office as soon as the officer has qualified by filing an oath or affirmation of office, and shall file the form within ten days after the first meeting of the month following the appointment. The municipal Finance Officer shall hold office until the appointment and qualification of a successor.

§ 31.15 AMOUNT OF FINANCE OFFICER'S BOND
The amount of the bond of the

municipal finance officer shall be annually established by the governing board in an amount equal to the maximum monetary total estimated to be on hand at any one time, but the amount of such bond required may not exceed one-hundred fifty thousand dollars. In lieu thereof, the governing body may purchase a blanket bond, blanket crime coverage, an insurance policy, or an individual bond, issued to the political subdivision as the insured, covering the faithful performance of each officer, member, and employee.

§ 31.16 VACANCY OF OFFICE
The removal of the municipal finance officer, or the officer's failure, within ten days after the first meeting of the month following the election or appointment, to qualify and begin the duties of office, causes a vacancy in the office. The Finance Officer may be removed by a majority vote of the members the governing board.

§ 31.17 RECORDS MAINTAINED BY FINANCE OFFICER

The municipal finance officer shall keep an office at a place directed by the governing body. The finance officer shall keep the corporate seal, all papers and records of the municipality, and a record of the proceedings of the governing body, whose meetings the finance officer shall attend. The finance officer shall draw and countersign all warrants on the treasury in pursuance of orders or resolutions of the governing body and keep a full and accurate account of all such warrants in books provided for that purpose. The finance officer shall make or cause to be made estimates of the expenses of any work to be done by the municipality and countersign all contracts made on its behalf and certificates of work authorized by any committee of the governing body or by any municipal officer. However, the finance officer may destroy any record which the records destruction board, acting pursuant to SDCL § 1-27-19, declares to have no further administrative, legal, fiscal, research, or historical value.

§ 31.18 BOOKS OF ACCOUNT MAINTAINED BY FINANCE OFFICER; RECORD OF CERTIFICATES

The municipal finance officer shall keep regular books of account in which shall be entered all indebtedness of the municipality, and which shall at all times show the financial condition of the municipality, the amount of bonds, warrants, certificates, or other evidences of indebtedness issued by the governing body, and the amounts of all bonds, warrants, certificates, or other evidences of indebtedness which have been redeemed and the amount of each outstanding. The finance officer shall countersign all bonds, warrants, or other evidences of indebtedness of the municipality and keep accurate accounts of each, stating to whom and for what purpose issued and the amount of the bond, warrant, or other evidence of indebtedness of the municipality. The finance officer shall keep an account with all receiving and disbursing officers of the municipality, showing the amount received from the different sources of revenue and the amount which was disbursed under the direction of the governing body. However, the finance officer may destroy any record which the records destruction board, acting pursuant to SDCL § 1-27-19, declares to have no further administrative, legal, fiscal, research, or historical value. The municipal finance officer shall keep a list of all certificates issued for work or any other purpose. Before the levy by the governing body of any special tax, the finance officer shall, unless that duty is performed by the engineer, report to the governing body a schedule of all lots that are subject to the proposed special tax or assessment and the amount of the special tax or assessment. The schedule shall be verified by the finance officer's affidavit.

§ 31.19 SUPERVISION OF MUNICIPAL ACCOUNTING SYSTEM; EXAMINATION OF REPORTS AND ACCOUNTS

The municipal finance officer shall supervise the accounting system for all departments and offices of the municipality in accordance with the recommendations of the Department of Legislative Audit.

The municipal finance officer shall examine all reports, books, papers, vouchers, and accounts; audit and adjust all claims and demands against the municipality before they are allowed by the governing body; and keep a record of the finance officer's acts and doings. The finance officer shall keep a book in which the finance officer shall enter all contracts. The book shall include an index to the contracts and shall be open to the inspection of all parties interested. The finance officer shall perform such other duties as may be required by ordinance, resolution, or direction of the governing body. However, the finance officer may destroy any record which the Records Destruction

Board, acting pursuant to SDCL § 1-27-19, declares to have no further administrative, legal, fiscal, research, or historical value.

§ 31.20 ELECTIONS

(A) Voter registration shall be conducted by the and municipal finance officer.

(B) The finance officer shall prepare and furnish, at the expense of the municipality, all official ballots. The quantity of ballots provided shall be at least ten percent more than the number of voters at the last comparable election. The ballots shall be prescribed by the State Board of Elections, of good quality of print paper, printed in black ink, and in the English language only.

The ballots for municipal elections shall be available for absentee voting no later than fifteen days prior to election day. If the ballots are for a runoff election, the ballots shall be available no later than seven days prior to the runoff election day. Absentee voting shall be conducted pursuant to SDCL Chapter 12-19. The names of the candidates for each office to be voted for in the precinct shall be arranged without any other designation than that of the office for which they are candidates. If more than one member of the governing body is to be elected, the ballot shall contain instructions as to how many candidates for the governing body are to be voted for. The finance officer shall determine, by lot, each candidate's position on the ballot. Each candidate may be present or represented when the position on the ballot is being determined. No candidate's name may be printed upon the official ballot unless the candidate has been nominated as provided in SDCL Chapter 9-13.

(C) Upon receiving an application for absentee ballots, the finance officer, shall, within forty-eight hours, or if ballots are not then on hand, then within forty-eight hours after receipt of the ballots, after confirming from the master registration file that the applicant is registered as a voter pursuant to SDCL Chapter 12-4, enclose one of each of the official ballots, a set of instructions on absentee balloting, and an unsealed return envelope. All of the enclosures shall be sealed in an envelope addressed to the applicant at the place stated in the application. If a registration form is received simultaneous with an absentee ballot request and prior to the registration deadline, the absentee ballot provided shall be based on the submitted registration form.

(D) The election returns shall be reported as soon as possible to the finance officer, and within seven days of the election, the governing body shall canvass the election returns, declare the result, and enter the result on its journal.

City Administrator
§ 31.21 CREATION OF OFFICE
The office of City Administrator is hereby created. The City Administrator shall be the Chief Administrative Officer of the city and shall assist the governing body in the administration of the affairs of the city.

§ 31.22 APPOINTMENT
The City Administrator of the City shall be appointed by a majority vote of the governing body, and shall be appointed annually or at intervals determined by the governing body.

§ 31.23 QUALIFICATION AND DISCHARGE OF DUTIES

The City Administrator shall begin discharging the duties of the office as soon as the officer has qualified by filing an oath or affirmation of office, and shall file the form within ten days after the first meeting of the month following the appointment. The City Administrator shall hold office until the appointment and qualification of a successor.

§ 31.24 VACANCY OF OFFICE
The removal of the City Administrator, or the officer's failure, within ten days after the first meeting of the month following the election or appointment, to qualify and begin the duties of office, causes a vacancy in the office. The City Administrator may be removed by a majority vote of the members the governing board.

§ 31.25 POWERS AND DUTIES OF CITY ADMINISTRATOR

The City Administrator shall perform all duties listed herein and have all powers as provided by law and by resolution or motion of the City Commission in compliance with State Law.

(1) The duties of the City Administrator are as follows:

(a) Recommend to the Mayor, individual Commissioners, and governing body the appointment, and the removal of department heads. Upon the recommendation of the department head the removal any other employee;

(b) Assist the municipal Finance Office in preparation of the budget annually to be submitted to the governing body, together with a message describing the important features and be responsible for

assisting in its administration after adoption;

(c) Assist the municipal Finance Office in submission to the governing body at the end of the fiscal year, a complete report on the finances and administrative activities of the city for the preceding year;

(d) Assist with, and in consultation with the municipal Finance Officer, keep the governing body advised of the financial condition and future needs of the city and make recommendations as may be deemed advisable;

(e) Assist with, and in consultation with the municipal Finance Officer, recommend to the governing body a standard schedule of pay for each appointed office and position in the service of the city;

(f) Recommend to the governing body (from time to time), adoption of measures as may be deemed necessary or expedient for the health and improvement of administrative services;

(g) Consolidate or combine offices, positions, departments or units under his or her jurisdiction, with approval of the governing body. The City Administrator may be the head of one or more departments with approval of the governing body pursuant to SDCL Chapter 9-9 and State Law;

(h) Attend all meetings of the governing body unless excused therefrom and take part in the discussion of all matters coming before the governing body. The City Administrator shall be entitled to notice of all regular and special meetings of the governing body;

(i) Assist the Mayor and each Commissioner in the performance of their assigned powers and duties, assist with the supervision of the purchase of all materials, supplies and equipment for which funds are provided in the budget. No purchase shall be made, contract, let or obligation of service incurred for any item which exceeds the current budget appropriation by the governing body. No contract in excess of the amount established by state law shall be let except by the governing body. The Administrator may suggest the adoption of rules governing purchasing procedures within the administrative organization, as the governing body shall approve;

(j) Assist the Commission in seeing that all laws and ordinances are duly enforced;

(k) Review the affairs of the city or any department or division thereof. Review all complaints in relation to matters concerning the administration of the government of the city, and in regard to service maintained by the public utilities in the city, and see that all franchises, permits and privileges granted by the city are faithfully observed;

(l) Perform other duties as may be required by the governing body, not inconsistent with the laws or ordinances of the municipality or state.

(2) The City Administrator will be required to perform:

(a) Attend meetings of the City Commission and meetings between the City Commission and other governmental officials, business and private citizens, act as an official representative of the city at public and organization meetings;

(b) Draft correspondence including letters, proclamations, prepare reports and research on special projects as directed;

(c) Maintain liaison relationships and coordinate with executive, legislative and administrative officials at the federal, state and local government levels and assist with review of departmental applications for federal and state aid;

(d) In compliance with SDCL Chapter 9-9, assist and advise the governing body and individual Commissioners, in directing and advising department heads concerning activities and plans for various departments. Transmit requests and recommendations from the City Commission and the Mayor to the various department heads; and

(e) Other duties and functions as are necessary or incidental to the proper performance of the position of City Administrator.

§ 31.26 COMPENSATION.

The City Administrator shall receive compensation as the City Commission shall fix by resolution.

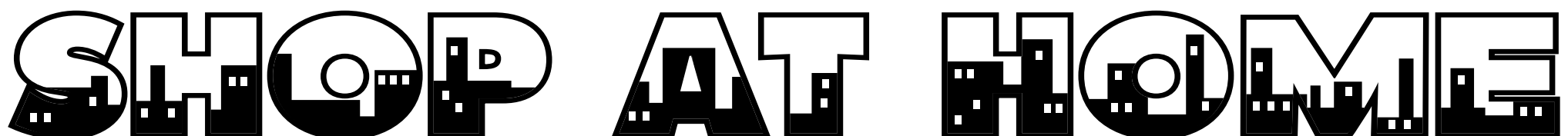

GENERAL PROVISIONS § 30.01 COMPOSITION AND QUALIFICATIONS OF CITY COMMISSIONERS

The board of commissioners shall consist of the mayor and two or four commissioners elected at large. All persons nominated, elected, or appointed as a mayor or as a commissioner must be a citizen of the United States and voter and resident of the municipality.

No person may hold any elected municipal office who has not resided therein at least three months next preceding his election or appointment. No person may hold any municipal office who is a defaulter to the municipality. No mayor or commissioner may hold any other office under the municipality while an incumbent of such office. The term "office" does not include membership on any municipality board, if the ordinance or resolution establishing the board specifically includes the mayor or a commissioner in the membership of the board.

§ 30.02 TERMS OF OFFICE; COMPENSATION

- (1) Terms of Office (A) The election for mayor and the election for commissioner shall be held on the second Tuesday of April in the applicable year. (B) The term of office for the mayor shall be for five years. A mayor shall be elected for a term of five years in the 2023 election, and for the same term every five years thereafter. (C) The term of office for each commissioner elected at-large to office shall be for five years commencing with the commissioner election in 2019. (1) A commissioner at-large shall be elected for a five year term in 2019 and for the same term every five years thereafter. (2) A commissioner at-large shall be elected for a five year term in 2020 and for the same term every five years thereafter.

(3) A commissioner at-large shall be elected for a five year term in 2021 and for the same term every five years thereafter.

(4) A commissioner at-large shall be elected for a five year term in 2022 and for the same term every five years thereafter.

A Mayor or Commissioner shall begin discharging the duties of the office as soon as the officer has qualified by filing an oath or affirmation of office with the Finance Officer. The officer shall file the form with the Finance Officer within ten days after the first Commission meeting of the month following the election. Except as otherwise provided, each officer, if elected for a full term, shall begin discharging the duties of the office on the first meeting of the month next succeeding the election or as soon thereafter as the officer has qualified.

(2) The City shall fix and determine by resolution the amount of salaries and compensation of all municipal officers and the times at which the same shall be paid.

(3) The provisions of § 30.01 do not prohibit any mayor or commissioner from serving in any other volunteer, unsalaried municipal position or providing any service for a municipality if the compensation for such service does not exceed five thousand dollars per calendar year.

§ 30.03 OATH OF OFFICE

Before entering upon the discharge of his or her duties the Mayor and each City Commissioner shall take and file an oath or affirmation to support the Constitution of the United States and Constitution of the State of South Dakota, and to faithfully discharge the duties of his or her office.

§ 30.04 BOND

Before entering upon the discharge of his or her duties, the Mayor and each City Commissioner shall execute a bond payable to the city in the sum as required by statute. Such bond shall be given and executed by a surety company authorized by law to transact business in this state and filed in and remain a permanent record of the office of the Finance Officer. Such bond shall be conditioned that the principal thereof shall account for and pay over and deliver to his or her successor in office and to the city any and all money or property belonging to it or which shall come into his or her hands by reason of his or her office and well and faithfully perform the duties of his or her office according to the laws of the state and the ordinances of the city. In lieu thereof, the governing body may purchase a blanket bond, blanket crime coverage, an insurance policy, or an individual bond, issued to the political subdivision as the insured, covering the faithful performance of each officer, member, and employee.

§ 30.05 RESIGNATION OF MAYOR OR COMMISSIONER

If the mayor or a commissioner resigns, the resignation shall be submitted in writing to the board. If the mayor or a commissioner moves his or her permanent residence outside the corporate limits of the municipality, the office is immediately vacated. If there is a vacancy in the office of mayor, the vacancy shall be filled by appointment pursuant to § 30.07 until the position is filled by election at the next annual municipal election.

§ 30.06 MAYOR

The mayor shall be president of the commission and shall have a vote upon all questions but shall not have the right of veto.

§ 30.07 ABSENCE OR SICKNESS OF MAYOR

If the mayor is unable to perform the duties of office by reason of absence or sickness, the Commission shall appoint by a majority vote one of its members to act as mayor. The appointed commissioner's official designation shall be acting president of the board of commissioners. The acting president is invested with all the powers and shall perform all the duties of the mayor during the mayor's absence or sickness. The acting president has only one vote as a commissioner and is not entitled to vote as acting president.

If the office of mayor is vacated, the board of commissioners shall appoint by a majority vote one of its commissioners as acting mayor. The acting mayor is invested with all the powers and shall perform all the

duties of the mayor, until the election of a mayor. The acting mayor has only one vote as a commissioner and is not entitled to vote as acting mayor.

§ 30.08 COMMISSION CONTROL OF DEPARTMENTS

The commission controls all departments of the municipality and may make and enforce rules and regulations for the organization, management, and operation of the departments of the municipality and any agency that may be created for the administration of the commission's affairs.

§ 30.09 CITY COMMISSION COMPELLING ATTENDANCE OF WITNESSES AND PRODUCTION OF EVIDENCE; EXECUTION AND SERVICE OF PROCESS

The commission has the authority to summon and compel the attendance of witnesses and the production of books and papers if it is necessary for the effective discharge of the commission's duties. Any process necessary to enforce the powers conferred by this section and § 30.08 shall be signed by the mayor and attested by the finance officer, and shall be served by a municipal law enforcement officer or by the sheriff of the county.

§ 30.10 MEETINGS OF THE CITY COMMISSIONERS AND ORDER OF BUSINESS

(A) The City Commission shall hold meetings at such day, time, and place as designated by the City Commission. Unless otherwise designated by the City Commission, the meeting shall be held on the first and third Mondays of the month in the evening at 7:00 p.m. at the Canton Depot. A regular meeting may be adjourned from day to day until all of the business of the city to be transacted at such meeting has been transacted and an adjournment of such regular meeting without definite date shall be an adjournment to the next regular meeting.

(B) Special meetings may be called by the Mayor or by any two City Commissioners at any time, to consider only the matter mentioned in the call for special meeting. A notice of special meeting shall be given pursuant to SDCL § 1-25-1.1 and shall be provided to each commissioner.

(C) At all regular meetings after the same have been called to order, the business of the meeting shall be considered in the following order:

- (1) Calling the roll;
(2) Consent calendar;
(a) Approve minutes;
(b) Set hearings;
(c) Month end reports;
(d) Warrants; and
(e) Other routine business.
(3) Old business;
(4) New business;
(5) Other business; and
(6) Executive session.
(D) Any member of the City Commission may request at the opening of the meeting that an item on the consent calendar be moved to the regular agenda.

§ 30.11 CITY COMMISSION MEETINGS OPEN TO PUBLIC; JOURNAL OF PROCEEDINGS

Each meeting of the commission is open to the public and the commission shall keep a journal of its proceedings. Executive session or closed meetings shall be held in accordance with SDCL § 1-25-2.

§ 30.12 QUORUM OF CITY COMMISSIONER; MAJORITY VOTE REQUIRED FOR ACTION

A majority of the commission constitutes a quorum to do business. If a seat on the commission is vacant due to removal, resignation, death, or by operation of law, the quorum consists of the majority of the remaining commissioners who are qualified to serve by election or appointment. The board may compel the attendance of any absentee under penalties as prescribed by ordinance. No action of the board is effective unless upon a vote of a majority of the board.

§ 30.13 RECORDING OF VOTES OF CITY COMMISSIONERS

The yeas and nays shall be taken upon the passage of each ordinance and for any proposal to expend or appropriate money and in any other case at the request of any commissioner. Each vote shall be entered on the journal of the commission's proceedings.

§ 30.14 MAJORITY VOTE REQUIRED FOR PASSAGE OF

MEASURES; TWO-THIRDS VOTE FOR SALE OF REAL PROPERTY

The concurrence of a majority of all the members of the commission shall be necessary to the passage of any ordinance or proposal. A two-thirds vote of the commission is required to sell any municipal real property.

§ 30.15 MAYOR'S AREA OF RESPONSIBILITY

The mayor may exercise all the powers and perform all the duties provided by the laws of this state or the ordinances of the municipality not in conflict with the laws of the state. The mayor is the chief executive officer of the municipality, presides at all meetings of the board, and has general supervision over all departments and officers. In the absence or inability of a commissioner, the mayor shall temporarily take charge of the department of that commissioner. The mayor shall enforce all the laws of the municipality and require that the conditions of the grant of any franchise or privilege are faithfully complied with and performed. The mayor shall grant all licenses or permits, except as are required by ordinance to be granted by the board or by some other department or officer. The mayor shall supervise each public building of the municipality and each city park except in any municipality that has a park board, and the lighting of the streets, alleys, and public buildings of the municipality. The mayor shall annually and from time to time give the board information relative to the affairs of the municipality and shall recommend for the board's consideration any measure the mayor deems expedient.

§ 30.16 COMMISSIONER OF PUBLIC SAFETY

The commissioner of public safety shall supervise the police and fire departments and the departments' officers and employees. The commissioner of public safety is also in charge of animal control within the municipality, including animal impoundments and shelter. In addition, the commissioner shall supervise any other department assigned or apportioned by resolution of the governing board, adopted by a majority vote at the first meeting of the board in the month following the election year. The commissioner of public safety is in charge of the apparatus, personnel, and personal property used by departments under the commissioner of public safety's supervision.

§ 30.17 COMMISSIONER OF PUBLIC WORKS

The commissioner of public works shall supervise the streets, alleys, public grounds, and municipal improvements, and all public property, except as otherwise specially provided. The commissioner shall maintain the property in a clean and sanitary condition and enforce all contracts, rules, and regulations necessary. In addition, the commissioner of public works shall supervise any other department assigned or apportioned by resolution of the governing board, adopted by a majority vote at the first meeting of the board in the month following the election year. The commissioner of public works is in charge of the apparatus, personnel, and personal property used by departments under the commissioner of public works' supervision.

§ 30.18 COMMISSIONER OF UTILITIES

The commissioner of utilities shall supervise the construction, maintenance, and operation of the waterworks, sewerage, and any other utility departments of the municipality. The commissioner of utilities shall enforce all regulations with respect to that department and its revenue. In addition, the commissioner of utilities shall supervise any other department assigned or apportioned by resolution of the governing board, adopted by a majority vote at the first meeting of the board in the month following the election year. The commissioner of utilities is in charge of the apparatus, personnel, and personal property used by departments under the commissioner of utilities supervision.

§ 30.19 COMMISSIONER OF FINANCE AND REVENUE

The commissioner of finance and revenue shall enforce all laws for the assessment and collection of taxes of every kind and collection of all revenues belonging to the municipality from whatever source derived. The finance and revenue commissioner shall examine into and keep the board informed on the finances of the municipality and its assets and property. In addition, the commissioner of finance and revenue shall supervise any other department assigned or apportioned by resolution of the governing board, adopted by a majority vote at the first meeting of the board in the month following the election year. The commissioner of finance and revenue is in charge of the apparatus, personnel, and personal property used by departments under the commissioner of finance and revenue's supervision.

§ 30.20 RULES OF PROCEDURE; ATTENDANCE REQUIREMENTS

The commission shall determine the commission's rules of procedure and may punish a Commissioner for disorderly conduct. The commission may, by resolution, establish requirements for attendance at regular meetings and provide for the expulsion of a commissioner in violation of the attendance requirements.

§ 30.21 MISCONDUCT

It is a Class 2 misdemeanor for any member of the governing body to commit a palpable omission of duty or to intentionally commit oppression, misconduct, or malfeasance in the discharge of the duties of his office. Upon conviction of a violation of this section, the court in which such conviction is had may in its discretion enter an order removing the member of the governing body or other officer so convicted from his office.

ORDINANCES AND RESOLUTIONS § 30.22 DEFINITIONS

"ORDINANCE" means a permanent legislative act of the City Commission within the limits of its powers. "RESOLUTION" means any determination, decision, or direction of the City Commission of a special or temporary character for the purpose of

initiating, effecting, or carrying out its administrative duties and functions under the laws and ordinances governing the municipality.

§ 30.23 AMENDMENTS

No ordinance shall be introduced providing for the amendment of any existing ordinance or section thereof unless the ordinance introduced shall contain the full text of the ordinance or section as proposed by the amendment.

§ 30.24 STYLE OF ORDINANCE; SUBJECT

(A) The style of all ordinances shall be as follows:

- (1) An ordinance (inserting the title);
(2) Be it ordained by the City of Canton. The substance of the ordinance follows.

(B) An ordinance must embrace only one subject which shall be expressed in its title.

§ 30.25 READINGS, PASSAGE, AND PUBLICATION

(A) All ordinances shall be read twice with at least five days intervening between the first and second reading. The ordinance shall be signed by the mayor or President of the Board of Commissioners and filed with the Finance Officer (B) All ordinances must be published once in the official newspaper of the City of Canton. (C) An ordinance incorporating and adopting comprehensive regulations or a code promulgated, approved, and published by a recognized and established national organization prescribing building, electrical, plumbing, safety, fire, or health regulations need not be published in a newspaper, but upon adoption of such an ordinance the Finance Officer shall publish a notice of the fact of adoption once a week for two successive weeks in the official newspaper, and twenty days after the completed publication of such notice, unless the referendum shall have been invoked, such ordinance shall become effective.

(D) If any amendment presented and approved by the commission at the second reading of an ordinance substantially alters the substance of the ordinance from the first reading, the proposed ordinance as amended may not be considered for final adoption until at least five days after a duly noticed public meeting of the governing body

(E) The vote upon all ordinances upon the second reading and to pass the same over any veto shall be taken by yeas and nays and entered upon the minutes of the meeting.

(F) If the mayor fails to sign any ordinance or resolution or file written objections thereto within ten days after its passage, the ordinance or resolution shall be published and become a law without the mayor's signature.

§ 30.26 EFFECTIVE DATE OF ORDINANCES AND RESOLUTIONS

(A) Except such resolutions or ordinances as may be necessary for the immediate preservation of the public peace, health, or safety, or support of the municipal government and its existing public institutions, or which provide for an election or for hearing on an improvement or assessment or which call for bids, which take effect upon the passage and publication thereof, every resolution or ordinance passed by the governing body shall take effect on the twentieth day after its publication unless suspended by operation of a referendum. (B) Any resolution may be passed after one reading and shall be recorded at length in the minutes of the meeting at which it is passed, with a statement of the number of votes for and against it. Such resolution shall be published in full either as part of the minutes or separately. (C) After an ordinance takes effect, the Finance Officer shall record the same together with a certificate of the date of its publication in a book to be known as the "Ordinance Book," and file the affidavit of publication with the original ordinance.

§ 30.27 COMPILATION OF ORDINANCES

(A) The municipality shall have the power to revise the ordinances. The governing body, once every five years, may appoint a committee of one or more competent persons to prepare and submit for its consideration an ordinance in revision of the ordinances of the municipality. (B) Upon the adoption of an ordinance which revises the ordinances of the municipality by the governing body, the Finance Officer shall publish a notice of the adoption of the revised ordinances once in the official newspaper. Twenty days after the completed publication of the notice, unless the referendum is invoked, the ordinance shall become effective without publication in a newspaper. (C) The governing body may publish the revised ordinances in book form. The Finance Officer shall furnish a free copy of the book or the revised ordinances to the circuit clerk of court and the county law library. (D) If the municipality posts the ordinance book or any part of the book on the municipality's official website, the municipality shall ensure the most current version of the ordinance book or any part of the book is posted.

§ 30.28 CONTINUATION IN FORCE OF ORDINANCES

(A) All ordinances and resolutions of this city in force which are not inconsistent with provisions of State Law shall continue in force and effect until repealed or amended as provided by law. (B) If the city shall change its form of government, all ordinances and resolutions of this city shall continue in force and effect the same as though no change of government has occurred.
