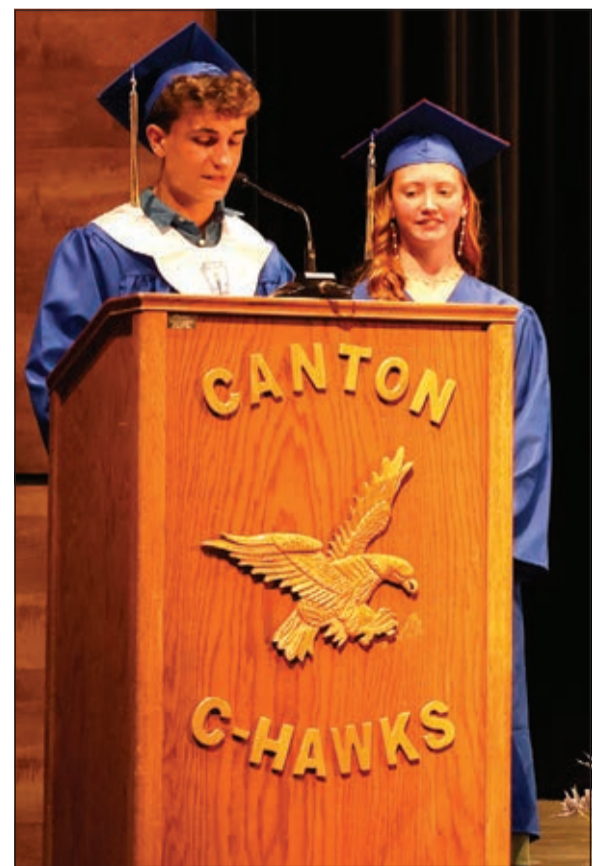

## DANR and DOH Announce Air Quality Alert for South Dakota

PIERRE, S.D. - The South Dakota Department of Agriculture and Natural Resources (DANR) issued an air quality alert for areas of South Dakota where smoke from wildfires in Canada is forecasted to settle. The smoke may cause low visibility and increased fine particulate matter (PM2.5) pollution. The South Dakota Department of Health (DOH) advises that these levels may be a concern to public health and provides additional resources to make an informed decision on personal healthcare choices.

The alert is in effect through Tuesday, May 14, 2024, or until conditions improve.

Elderly citizens, young children, and individuals with respiratory problems are the most susceptible to the smoke. All people should avoid excessive physical exertion and minimize outdoor activities during periods of low visibility caused by the wildfire smoke. People are also encouraged to keep indoor air clean by closing windows and doors.

Air pollution can aggravate heart and cardiovascular disease as well as lung diseases like asthma and COPD.

When the air quality is unhealthy, people with these conditions may experience symptoms like chest pain, shortness of breath, wheezing, coughing, or fatigue. Anyone concerned about health effects related to poor air quality should contact their health care provider.

DANR provides air quality data on the department's website for several locations in South Dakota. Hourly PM2.5 values greater than 35 microgram per cubic meter (ug/m3) are a concern to public health.

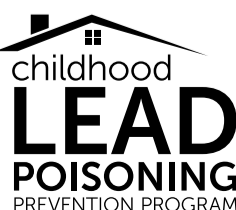

# HISTORY REVISITED

I'm sure there are some of the older members of the Canton United Methodist Church who have a copy of Ninety Years of Canton Methodism in their possession. Published in 1959 "To Remember the Past and Challenge the Future" it is a fascinating read and provides an inside look at how this church came into existence, weathered the many decades and still serves Canton and the surrounding area as a place of worship sixty-five years after this booklet was first published.

The fifteen people who worked on this project did an incredible job and they even included 4 pages of old photographs with one dating back to 1903. As Pastor Walter N. Pilgrim said back in 1959. "When Congress created South Dakota as the 39th State in 1889, our Methodist Church had reached the mature age of 20 years."

### Excerpt from Ninety Years of Canton Methodism

Some of the members in our church and Sunday school today are the 4th and 5th generations. Among the 5th generations are: the Stearns children, the descendants of George Cosper who joined in 1879, and the Bong children, whose great-great grandmother Mrs. H.H. DeLong joined in 1877. The 4th generation include: Mrs. Lloyd Dammeier, descendent of Mrs. Johanna Straw, who is credited with being the first member, having joined in 1869; Helen Comford, John Cederstrom and Lyle Schwartz, descendants of Martin Abbott who joined in 1901; Douglas Tuttle, who has the distinction of being the fourth generation on both sides of his father's family, Mrs. E.S. Tuttle having joined at the beginning of the outpost known as the slack class and Jacob Kehm who joined in 1895; and the Baird children who are the fourth generation of Ingvald Sletten who joined in 1906.

To Mrs. Mary Payne, who joined in 1893, goes the honor of the longest continuous membership- 66 years to date. Now 92 years old, Mrs. Payne still lives in Canton.

Canton Methodists owe a great deal to the Wendt family. Through the years after E. Wendt moved to Beloit (1875) and then to Canton (the first advertisement for his stone appears in the Sioux Valley News in June, 1876) the Wendts were teachers, leaders, musicians, financial and moral backers for Methodism. No other family did so much E. Wendt was one of the Trustees when the church was built and he served in that capacity for many years. He and his wife celebrated their fiftieth wedding anniversary in 1916. Another couple, grandpa and grandma Morris, great spiritual leaders during their lives, celebrated their sixtieth anniversary the same year, 1916.

On January 1, 1868, every white inhabitant of Lincoln County met at the home of F.Q. Fitzgerald on West 5th Street for a wild turkey dinner. There were 32 people present.

On January 27, 1877, the first wedding performed by a Methodist Minister (Rev. A.J. Benjamin) in the Canton area was that of D.J. Carpenter and Miss Tillitson at Beloit.

The first funeral held in the Methodist Church was Reuben DeLong's on March 11, 1883.

On June 13 and 14, 1890, Susan B. Anthony and May Seymore Howell held an equal suffrage convention in Canton.

In September, 1894, Rev. Carhart was sent by the conference to organize a group in Fairview and to build a church. It was finished and dedicated the following June by Presiding Elder Jordan. Before Rev. Carhart became a minister the family lived on a farm near Canton for a few years and were members of the church from 1885 to 1889.

In the early 1900's Mrs. C.B. Kennedy and Mrs. T.T. Smith decided the church needed a piano. They entered a contest put on by the Argus Leader and won a piano which they presented to the church. It is still in use there.

Here is the menu which was served at the public dinner held in the home of Mrs. E.J. Straw shortly before the church parlors were completed. For the munificent sum of 25¢ you could have meatloaf, creamed potatoes, perfection salad, rolls, jelly, relishes, coffee, pumpkin pie with whipped cream, cheese and doughnuts.

### \*\*Bonus Material\*\*

Tucked inside the booklet that I use for this column was a story taken from the Sioux Valley News concerning the 90th anniversary of the Methodist Church. On the other side of this page was a story about all the new 1960 Ford Falcon that had just arrived at Deinema Ford. It has nothing to do with Methodism but I thought some of you might find this interesting:

Deinema Ford Sales will show the 1960 models of Fords are the all new Ford Falcon on Friday. According to Jim Deinema, much interest is expected to be centered around the Falcon- Ford's entry into the small economy car field. "The Falcon will have both economy of operation and maintenance," says Deinema.

The Falcon has a front mounted six-cylinder engine which will require 50 percent less anti-freeze in the winter than a full size car. The Falcon is a full six passenger car despite being 27 inches shorter than the overall length of the 1959 Fairlane. Falcon styling is simple and functional with decorative trim and chrome at a minimum.

I will be using excerpts from "Items of Interest" that appear at the very end of this twenty page church history. In future columns I plan to use more stories from this booklet because Canton and it's places of worship go hand in hand in forming the kind of community we have today.

Happy reading as the 2023-2024 school year comes to an end on Friday. Congrats to all the graduates and now it's time to spread your wings and follow your dreams. Local history may not be that important to you right now but I can almost guarantee that the older you get the more you'll look back at your time growing up here and wonder about certain things, places and people and want to know more about your old home town of Canton.

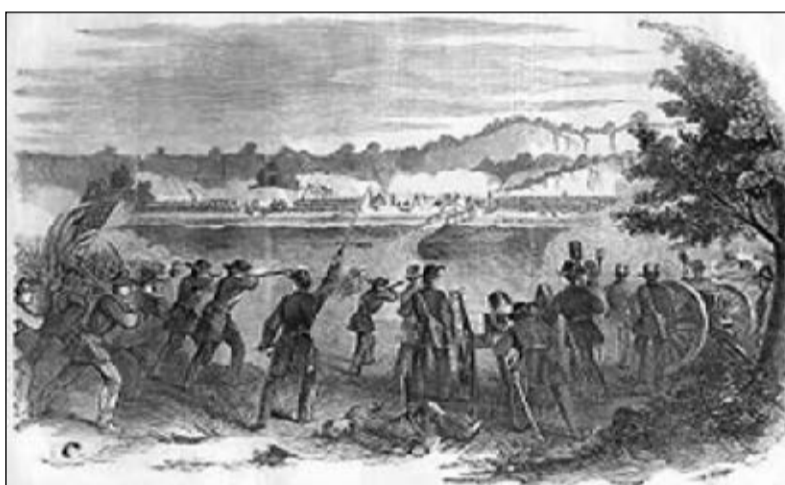

### Secretary of State Provides Information Regarding Absentee Voting and Trusted Sources for Election Information

(Pierre, S.D.) – Ahead of South Dakota’s Primary Election which will be held on Tuesday, June 4, 2024, Secretary Monae L Johnson urges voters to confirm the sources of election information they are receiving. The secretary’s office is encouraging South Dakotans to look to the South Dakota Secretary of State’s office and county auditors for trusted election information.

Absentee voting is already taking place in county auditor’s offices across the state. For those who intend to vote absentee, the deadline to request a ballot is 5:00 pm local time on Monday, June 3, 2024. You may also drop off your absentee ballot in-person at your county auditor’s office.

All absentee ballots must be delivered to the county auditors by the time that polls close on election day in order to be counted. Remember to allow for adequate mail processing time when returning your absentee ballot to your county auditor’s office by mail. If an absentee ballot is received after that time, it may not be opened or counted, regardless of when it was mailed.

Voters may verify their voter registration information, polling place location, whether they have already requested an absentee ballot, and check the status of their absentee ballot by contacting their county auditor or searching the Voter Information Portal (VIP) on the Secretary of State’s website: <https://vip.sdsos.gov/VIPLogin.aspx>. More information on absentee voting can be found at <https://sdsos.gov/elections-voting/voting/absentee-voting.aspx>.

Secretary Johnson and the county auditors stand united in ensuring that elections are conducted transparently and securely in South Dakota. South Dakotans can be assured elections in the state are some of the safest and most secure in the country. The South Dakota Secretary of State’s Office, along with local election officials, are continuously working to inform Americans about the elections process, including voter registration, state election laws, polling place locations, post-election processes and much more.

hundreds of thousands of dollars on environmental strictures on their land. Now he’s pushing a tailpipe emissions rule that is an effective mandate for more expensive electric vehicles. And new requirements on certain federally connected homes will add an estimated \$7,000 to the cost of construction.

The Biden regulatory regime also extends the heavy hand of government to job creators. Take for example the new overtime rule, which imposes a 65 percent hike in the overtime exemption threshold. Small businesses are likely to face the difficult choice of raising prices, reducing the number positions, or lowering workers’ pay. I don’t see any of those as good for workers, customers, or business owners.

Unsurprisingly, a number of regulations coming out of Washington demonstrate a lack of understanding about life in places like South Dakota. WOTUS was simply unworkable and unreasonable for farmers and ranchers. South Dakotans aren’t eager to switch to electric vehicles, especially with our harsh winters and the

demands we put on our cars and trucks. And last year, the Biden administration tried to prevent hunting and archery education programs from receiving federal funding. Thanks to congressional action, that regulation was stopped, but the fact that it was proposed at all is emblematic of Washington bureaucrats’ overreach and their lack of understanding of our way life.

The Biden administration has not been shy about using its regulatory power. The sticker shock of \$1.47 trillion in regulatory costs is a lot, but it’s even worse when you consider that President Trump had actually reduced regulatory costs at this point in his administration. Even compared to President Obama, President Biden’s regulations cost almost five times as much. I shudder to consider how many more costly regulations the Biden administration is dreaming up for the future.



Dave Siegenthaler will be retiring this year after many years as a custodian.

# Commissioner Jerry Chaon Recognized for Service; Jackie Pigors Sworn In as New Commissioner

The Canton City Commission met in regular session on Monday, May 6 at 7 p.m. at the Depot. All Commissioners were present at the time of roll call.

Under Visitors to be Heard, Citizen Paul Nordlie spoke about the following issues:

1. Street, Curb and Gutter issues on North Cedar Street.
2. Noise from "competition stereos" and the non-enforcement of the loud noise caused by the stereos.
3. The Neighbor's ducks and how they are not causing any harm.
4. The constant barking from the same dogs.
5. Free Range Chickens.
6. The removal of political signs after the elections. Nordlie thanked the Commission.

Next under Visitors to be Heard, Citizen Amy Bergren spoke about a warning she received in regards to mowing. She was concerned about the waste of resources by using the police officer's for these nuisance issues. Bergren mentioned that she called five other communities in the area and none of them use their local police department to enforce these issues. Bergren said that the City needs to make better decisions regarding the resources of our police department. Bergren thanked the Commission.

With no more Visitors to be Heard, the only item under Old Business was the Second Reading - Rezone Ordinance for Monarch Village Subdivision. The hearing and First Reading was conducted on April 15 for an Ordinance to rezone Parcel 200.50.58.001 for the Monarch Village Subdivision. Motion to approve by Commissioner Jerry Chaon. Second by Commissioner Tyler Larson. Unanimous approval.

The only item under Special Business was the Swearing in of Commissioner Jackie Pigors. Before swearing in Pigors, Mayor Sandra Lundstrom presented outgoing Commissioner Jerry Chaon with a plaque recognizing his years of dedicated service on the Commission for the City of Canton. Applause occurred from all those in attendance.

Following the presentation, Assistant City Attorney Sam Nelson proceeded to swear in Jackie Pigors as Commissioner for a five-year term. Applause occurred from all those in attendance.

The first item under New Business was to Appoint Commissioner Departments. Commissioners are to be appointed to one of the following departments:

Mayor's area of responsibility in five-commissioner municipality. If any municipality is governed by a board consisting of five commissioners, the mayor may exercise all the powers and perform all the duties provided by the laws of this state or the ordinances of the municipality not in conflict with the laws of the state. The mayor is the chief executive officer of the municipality, presides at all meetings of the board, and has general supervision over all departments and officers. In the absence or inability of a commissioner, the mayor shall temporarily take charge of the department of that commissioner. The mayor shall enforce all the laws of the municipality and require that the conditions of the grant of any franchise or privilege are faithfully complied with and performed. The mayor shall grant all licenses or permits, except as are required by ordinance to be granted by the board or by some other department or officer. The mayor shall supervise each public building of the municipality and each city park except in any municipality that has a park board, and the lighting of the streets, alleys, and public buildings of the municipality. The mayor shall annually and from time to time give the board information relative to the affairs of the municipality and shall recommend for the board's consideration any measure the mayor deems expedient.

Commissioner of public safety in five-commissioner municipality. If any municipality is governed by a board consisting of five commissioners, the commissioner of public safety shall supervise the police and fire departments and the departments' officers and employees. The commissioner of public safety is also in charge of animal control within the municipality, including animal impoundments and shelter.

Commissioner of public works in five-commissioner municipality. If a municipality is governed by a board consisting of five commissioners, the commissioner of public works shall supervise the streets, alleys, public grounds, and municipal improvements, and all public property, except as otherwise specially provided. The commissioner shall maintain the property in a clean and sanitary condition and enforce all contracts, rules, and regulations necessary.

Commissioner of utilities in five-commissioner municipality. If a municipality is governed by a board consisting of five commissioners, the commissioner of utilities shall supervise the construction, maintenance, and operation of the waterworks, sewerage, and any other utility departments of the municipality. The commissioner of utilities shall enforce all regulations with respect to that department and its revenue.

Commissioner of finance and revenue in five-commissioner municipality. If a municipality is governed by a board consisting of five commissioners, the commissioner of finance and revenue shall enforce all laws for the assessment and collection of taxes of every kind and collection of all revenues belonging to the municipality from whatever source derived. The finance and revenue commissioner shall examine into and keep the board informed on the finances of the municipality and its assets and property.

Commissioner Public Safety - Jackie Pigors

Commissioner of Public Works - Paul Garbers

Commissioner of Utilities - Kris York

Commissioner of Finance and Revenue - Tyler Larson

Motion to approve the appointments by Commissioner Paul Garbers. Seconded by Larson. Unanimous approval.

Next under New Business was the Liquor License Hearing. Orange City Supermarket Inc, doing business as Sunshine Foods has submitted a Package (Off-Sale) Liquor License application. A hearing is required for a new license. The fee for the license is \$1,200 and has been paid. Sunshine currently has an off-sale wine and off-sale malt beverage license. An Off-Sale package liquor license is available and property taxes are current. Per Ordinance 112.03, Off-Sale package liquor licenses allow for sale from 7 a.m. to 2 a.m. everyday. The license will be active through December 31, 2024. Mayor Lundstrom opened the hearing. Manager Darrin Hill was available for any questions. With no proponents and no opponents, Mayor Lundstrom closed the hearing at 7:21 p.m. Motion to approve by Larson. Seconded by Commissioner Kris York. Unanimous approval.

Next on the agenda was the Operating Agreement for Sunshine Liquor License/Sunshine Foods

has submitted a Package (Off-Sale) Liquor License application and if approved, they are required per State law to have an operating agreement with the City to operate under the liquor license. Per paragraph 11 in the Operating Agreement, Sunshine Foods is required to have liability insurance naming the Licensee and the City as insureds. Per paragraph 15, Sunshine Foods is required to obtain a surety bond for guarantee payment of alcoholic beverages purchased through the City. We have a copy of their liability insurance on file and, if approved for the license, they would need to increase their bond from \$10,000 to \$50,000 for the wine license they currently hold per the operating agreement. Motion to approve by Garbers. Seconded by Larson. Unanimous approval.

The Malt Beverage Renewals were next under New Business. State law stipulates that each year the City shall renew the Malt Beverage On-Off Sale & SD Farm Wine (RB) licenses. The paperwork is due back to the State by May 20. The City does not have any new Malt Beverage Licenses this year. Motion to approve by Larson. Seconded by Pigors. Unanimous approval.

Next under New Business was the Malt Beverage Purchase Agreements. State Law stipulates that each year the City shall renew Malt Beverage Licenses. Thus, individual purchase agreements are also necessary. Motion to approve the purchase agreements for July 1, 2024 - June 30, 2025 by Larson. Seconded by York. Unanimous approval.

The Sidewalk Variance Request - Robert Moulton-Ely/Amagansett Four LLC was next on the agenda. A sidewalk variance application from Robert Moulton-Ely (Amagansett Four LLC) has been submitted for the property to be addressed 1222 North Grant Street (Parcel 200.98.00.100). He will be having a house/garage built there and his request is as follows: "no sidewalk is desired since the neighbors on the east & west side of North Grant Street from North Park Lane down to Poplar do not have a sidewalk & would ruin the rural visual character of the lot".
