**Why Did You Doubt?**

A childhood friend of mine was recently killed in a grain bin accident. Grain bins can be quite dangerous. Many people have lost their lives as they were quickly engulfed by the grain. Such events are a reminder of how fragile life is.

The Apostle Peter had a similar close call. Instead of being engulfed in grain, he nearly drowned in a stormy sea. As I think of both my childhood friend and of Peter, I cannot imagine the terror that they must have faced. Regardless, I have had nightmares about such events.

Peter survived his ordeal and Matthew wrote about it. As the wind was blowing the disciples of Jesus were in a boat and Jesus walked on water to come to them. Once Jesus identified himself, Peter said, "Lord, if it is you, command me to come to you on the water." Jesus said, "come," so Peter did. Peter was actually able to walk on the water for a time, but then he saw the waves, got scared, and began to sink.

Peter must have felt completely helpless. He was already afraid while he was still walking on the water and now he finds himself sinking. He cried out, "Lord save me." Thankfully for Peter, Jesus did save him.

If Peter ever wrote about his experience walking on the water and then sinking, those words never made it into the pages of the Bible. Peter did however write two letters that are part of the New Testament scriptures. In both of those letters he writes about Noah and the flood where people drowned. I cannot help but wonder if what happened to Peter on the sea that night caused him to think a lot more about drowning.

Regardless, Peter learned an important lesson that night that he wanted others to understand. In order to be saved we need Jesus. In his first letter Peter talks about how Noah and his family were brought safely through the water. In his second letter he talks about how

God brought a flood upon the world of the ungodly.

Both Peter and Noah had found grace from God. Genesis 6:8-9 says, "But Noah found grace in the eyes of the LORD. These are the generations of Noah: Noah was a just man and perfect in his generations, and Noah walked with God." Notice as well that both Noah and Peter walked with God. Peter literally walked on water with Jesus. Jesus is God.

Thankfully God has promised not to ever send another worldwide flood. That does not mean that drowning is not still a danger though. It also does not mean that sin will not still be judged. Romans 6:23a says, "For the wages of sin is death." Then the last part of that verse says, "but the free gift of God is eternal life in Christ Jesus our Lord."

Before your life comes to an end, use the words of Peter and cry out, "Lord save me." Jesus promised in John 6:37, "All that the Father gives Me shall come to Me, and the one who comes to Me I will certainly not cast out." That means that if you believe on him as your Lord and savior, he will save you.

Being saved from sin and hell does not mean that you will never drown or have an accident. What it does mean is that if tragedy strikes you- like it did with my friend- then you will be with Jesus when your life ends.

Look at what happened as Peter cried out to Jesus as he was sinking, "And immediately Jesus stretched out His hand and took hold of him, and \*said to him, "O you of little faith, why did you doubt?" (Matthew 14:31) As our lives come to an end, we might have some doubts about where we will go, but if we have trusted Christ, then once we breath our last breath, we will be able to look forward to hearing the same answer from the Lord that Peter heard. Steve Sershen with Dakota Power Community Wind said recently Dakota Power Wind has received the preliminary results of its testing from the MET Tower (meteorological tower) just north of Beresford, where wind speeds came in above expectations, but also above the chart. Dakota Power is proposing to construct wind turbines in Lincoln County to produce 1,000 megawatts of energy to be supplied to the Rock Island Clean Line, a 500-mile direct current line designed to transfer up to 3,500 MW of electricity to metropolitan Chicago and eastern states by 2017.

Storms over the weekend left Canton with 4-6 inches of rain and even more in some rural areas. The rain caused several basements to leak and flood. To the north, other towns had significant rainfall and damaging winds.

A group of area farmers and landowners have joined together and formed a group dedicated to stopping the further progress of a proposed wind farm between Canton and Beresford. Plans for the wind farm were announced earlier this year, with the estimate of 500 wind turbines in the area.

The concerns of the landowners center around a few major concerns that affect health, land values and noise levels.

## Farmers Elevator Company 1905-1966

The Farmers Elevator Company was operated as a stock company from 1905 to 1920. It changed to a co-operative system in 1929. A steel and concrete elevator for grain storage purposes, also on the co-operative plan was built in 1950. The first manager was Charles Moulton.

In the 1920 the Farmers Elevator Company decided to go into the lumber business. They purchased the lumber yard owned by the Schoeneman Brothers, including the building and grounds, stock of lumber and other materials at the yard. Ole Hoel was hired as first manager.

The following officers and managers have served the Farmers Elevator Company Grain Department and Lumber Department from 1905 to 1966:

Treasurers: P.A. Overseth, Knute E. Jacobson, H.E. Iverson, Paul Lommen. Managers of Grain Department: Charles Moulton, Chris Sandvig, Merlyn McCall, Gilbert Wattnem, Les Albertsen.

Managers of Lumber Department: Ole Hoel, Ivar Skyberg, Robert Sundvold, Paul Blaser.

## South Dakota State Announces Spring 2024 Dean's List

BROOKINGS, S.D. (06/10/2024)- More than 3,300 students were recognized for their outstanding academic performance over the spring 2024 semester at South Dakota State University by being named to the dean's list.

To earn dean's list distinctions in SDSU's colleges, students must have completed a minimum of 12 credits and must have earned at least a 3.5 GPA on a 4.0 scale. Students with F, I, U, RI or RU grades are not eligible regardless of system term GPA attained. Note that this report includes courses that were taken at other South Dakota institutions this term. A minimum of 12 credits within the 100-699 course range must be taken. A student who passes pregeneral education courses may still qualify, if the student has 12 other credits that do fall within the 100-699 range.

Overall, 3,378 students from 40 states and 37 foreign nations are on the list. More than 1,400 students received a 4.0 GPA, and those are indicated with an asterisk.

One of the young people who saw this came up with my favorite quote or question of the day when they asked if Harold and Myva were the ones that had invented chalk. Of course they hadn't and this got me thinking just where did chalk originate and what is it actually. Well, after a little digging, I discovered it's white, gray or yellowish limestone that is soft and easily pulverized. It is composed mainly of minute sea shells and was invented in Europe in the late 16th century. Colored chalk came to be in 1814 in Scotland. When limestone is crystallized by heat and pressure it becomes marble. So, keep chalking it up Canton. We may be onto something here.

### How It Pays To Spend Time In Nature

Few things can be as distracting as a beautiful day. When the weather outside is welcoming, it can be hard to focus on indoor activities, including work and tasks around the house. Though it's not advisable to ignore responsibilities at work and at home when the weather outside beckons, it can be beneficial to spend ample time in nature when circumstances allow.

People tend to flock to the great outdoors in spring, summer and fall, and some are even so devoted that they bundle up and head outside throughout winter. Whether they know it or not, people who love to spend time in nature are doing their mental and physical health a lot of good by embracing the great outdoors.

#### Mental health benefits

According to the MHF, research shows that people who are connected with nature are more likely to report their lives are worthwhile than those with no such connectedness. In addition, the MHF notes time in nature has been shown to generate positive emotions, including calmness and joy, and promote greater creativity.

When seeking to capitalize on the mental health benefits of time in nature, people should know that where they spend time outdoors matters. As the Stanford study indicated, time outside in high-traffic urban settings may not produce as profound an effect as time spent in natural settings, like forests, that tend to be more serene. People who live in cities or other densely populated areas can still benefit from time outdoors, but they might experience even greater health gains if they make consistent efforts to spend time in more natural settings.

#### Physical health benefits

The physical health benefits of time in nature are equally notable. Perhaps the most obvious physical benefit is related to physical activity. People tend to embrace physical activity when spending time in nature. Hiking, jogging, walking, nature-based recreational activities like kayaking, and playing sports like basketball or pickleball all involve physical activity, which can help people avoid the consequences of a sedentary lifestyle, such as an increased risk for chronic diseases. More specifically, the New York State Department of Environmental Conservation notes the physical health benefits of spending time outside include:

- A stronger immune system
- Lower blood pressure
- Increased energy levels
- Improved sleep

Each of those benefits contributes to greater overall health, making time outdoors among the more beneficial behaviors a person can embrace.

There's no shortage of benefits to spending time in nature. That's something to keep in mind the next time welcoming weather beckons you to get some fresh air.

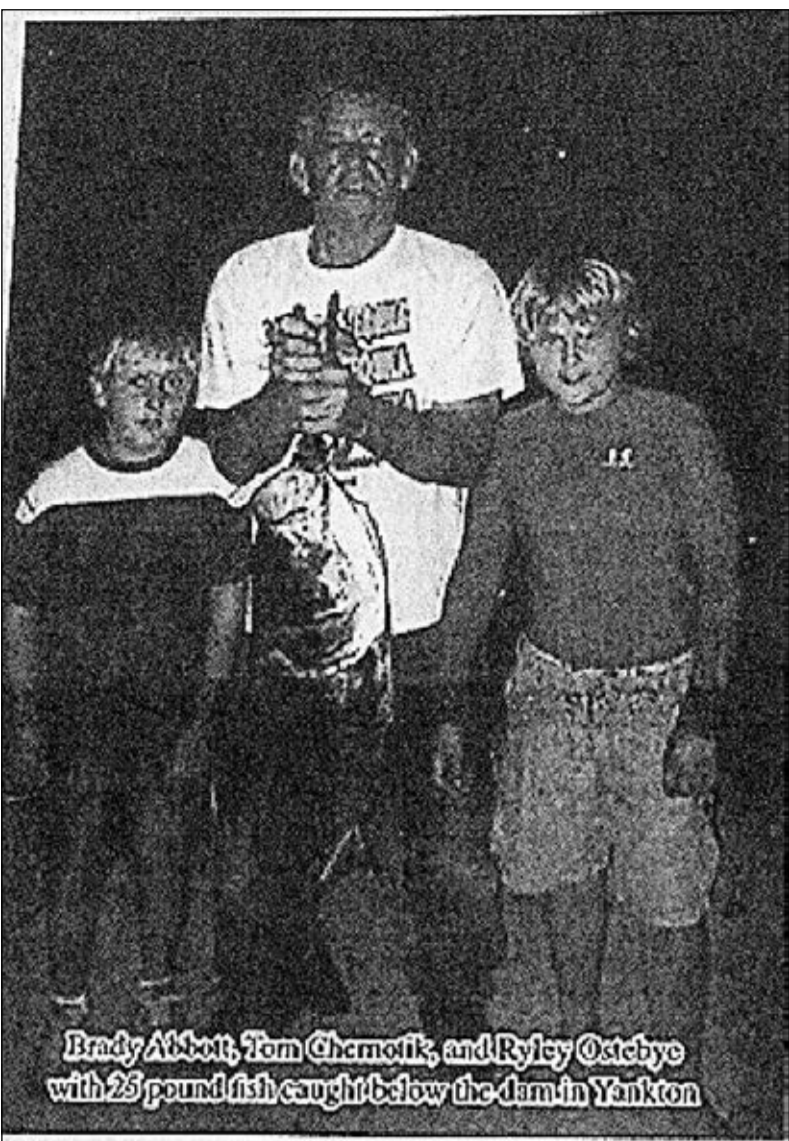
For starters, don't rush into any major decisions. If you're still in the grieving process, you are unlikely to be in the best shape to make significant choices affecting your finances and your life.

## New Laws Impacting Veterans

The 2024 Legislative Session is a wrap! There were 550 bills, commemorations, and resolutions introduced this year.

As an advocate for veterans, it is the responsibility of the South Dakota Department of Veterans Affairs to review all bills that will impact veterans. This year, the department introduced two bills and monitored 29 pieces of proposed legislation.

Here's a look at veteran related legislation that was approved and will become law July 1:

- State tuition assistance benefit for the airmen and soldiers of the South Dakota National Guard was expanded to allow them to utilize this benefit at an in-state private, nonprofit post-secondary university;
- March 25 has been designated as a state Medal of Honor Recognition Day;
- Veterans that are eligible for a disabled veteran plate and the benefits that accompany the issuance of the plate, but do not wish to have to have the designation of being disabled, now have the option to receive the same fee schedule for regular plates on their vehicle;
- The exempt value of property tax relief for disabled veterans and surviving spouses was increased to \$200,000. This will apply for the 2025 assessment for taxes payable

in 2026;

- A special motor vehicle license plate is now available for recipients of the Legion of Merit award;
- Residency requirements for admission to the State Veterans Home were removed; and,
- Counties and tribes who encounter prolonged veterans service officer vacancies can contract with the South Dakota Department of Veterans Affairs to provide those services.

As always, we encourage all veterans to visit their county or tribal veterans service officers (CTVSO's) to learn more about all benefits. These men and women have worn the boots, walked the trenches, conducted maneuvers, commanded troops, sustained missions, and protected our freedoms. Who better to have on your team? 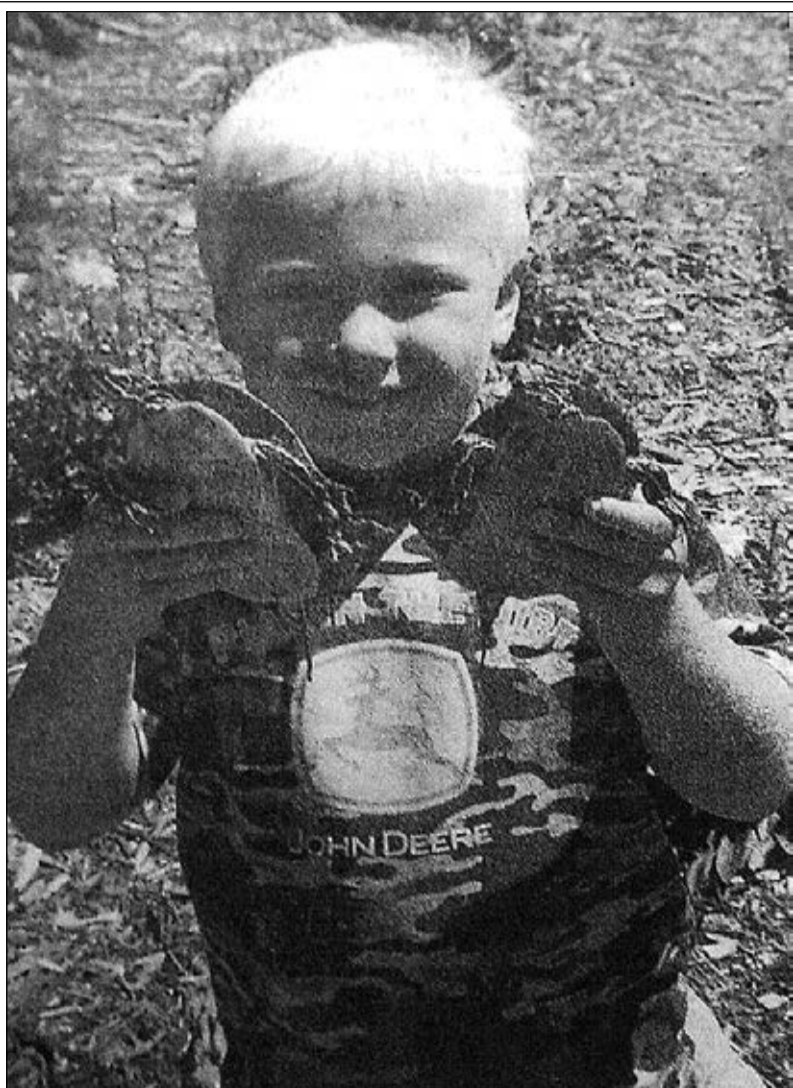

## More Farm in the Farm Bill

Agriculture is the lifeblood of South Dakota. Our state's farmers and ranchers rise before dawn and put in the hard work necessary to feed America. As a member of the Senate Agriculture Committee, I have the opportunity to advocate for South Dakota producers, and the farm bills that Congress takes up every few years are among my top priorities as a senator.

I've had a hand in crafting four farm bills during my time in Congress, and my number one goal is always to ensure each bill reflects the needs and priorities of the men and women on the ground: farmers and ranchers, their families, and everyone else who helps strengthen our state's agriculture community. As I travel around the state, I always take special note of my conversations with agriculture producers, and many of the bills I introduce for inclusion in the farm bill are based on these conversations.

The current farm bill will expire later this year, which is why Congress needs to focus on advancing the next farm bill. Not only are deadlines approaching, but updates are needed to a number of farm programs, and this work is all the more critical given the headwinds farmers and ranchers are currently facing.

Sen. John Boozman (R-Ark.), the lead Republican on the Senate Agriculture Committee, recently released a farm bill framework to get this process moving. It builds off of House Republicans' farm bill, which advanced out of the House Agriculture Committee with bipartisan support. Unfortunately, progress in the Senate has been hamstrung by my Democrat colleagues' insistence on prioritizing things like climate over the needs of farmers and ranchers. I hope that

this new framework and the action in the House will refocus efforts on farmers and ranchers – instead of Democrats' climate obsession – and move deliberations along.

In preparation for this next farm bill, I introduced a number of pieces of legislation that I hope to get included in the final bill. As I mentioned, they are based on the conversations I've had with farmers and ranchers as I travel throughout South Dakota, as well as events I've held to hear from producers about their priorities for the farm bill.

Importantly, this framework would make improvements to the Agriculture Risk Coverage and Price Loss Coverage programs, which are essential elements of the farm safety net. I'm pleased that the Senate framework also contains measures from a number of the bills I introduced. It includes elements of my Conservation Reserve Program (CRP) Improvement Act, which would make CRP a more effective option for producers. It also includes my CRP Flexibility Act, which would provide additional drought flexibilities for CRP contract holders. And it includes legislation I introduced to make crop insurance more affordable for young farmers, plus elements of another bill I introduced to increase processing options for livestock producers and expand smaller meatpackers' capacity are incorporated into the framework.

This framework is an important step forward in producing a farm bill that delivers for farmers and ranchers. Again, I hope that my Democrat colleagues will approach pursuing a bipartisan farm bill with a new seriousness about helping farmers and ranchers, not advancing their climate agenda. There needs to be more farm in the farm bill, and farmers and ranchers can't afford any more unnecessary delays.

## Changes likely for All-State Band Auditions

PIERRE — The South Dakota High School Activities Association is looking for some direction from the state's high school band directors about how to change the procedures for conducting auditions for All-State Band.

After a lengthy discussion at its meeting Wednesday, June 12, SDHSAA board members voted to convene a meeting of SDHSAA staff and high school band directors to find some common ground.

The current procedure calls for the association to use the state airplane to fly judges to audition locations across the state for two weekends in January. The judges are driven to the audition site on the third weekend. If inclement weather grounds the plane or forces a school hosting auditions to close, students record their auditions.

Recorded auditions are traditionally used when students try out for All-State Jazz Band. Some high school band directors have been hesitant about using recorded auditions for All-State Band because they believe it's best for have students perform live for the judges.

Kimberly Carda, the band director for Roncalli High School in Aberdeen, told the board that live auditions give the students a "real world, life experience."

According to SDHSAA Executive Director Dan Swartos, inclement weather has played havoc with auditions the past two years. Two years ago, after two weekends of live auditions, bad weather caused students on the third weekend to send in recorded auditions. This year weather was bad on the first weekend, so all students sent in recorded auditions.

"It's not a good situation," Swartos said. "To get three straight weekends of good weather in South Dakota is a crap shoot."

SDHSAA Assistant Executive Director Brooks Bowman, who handles fine arts activities for the association, said the main concerns are keeping students safe during inclement weather, missed class time for students and band directors and the inequity of holding auditions over three weekends, essentially giving some students one or two more weeks of practice before their auditions.

Bowman offered the board two options to consider. One option was video-recording all auditions. All auditions would need to be turned in to the association office by Jan. 25, 2025. Band directors would ensure that students met all the audition requirements. SDHSAA would

develop and distribute guidelines for making recordings.

According to the report Bowman gave the board, that option handles concerns about safety and inclement weather, lost class time and the inequity of some students having longer to prepare for their auditions. His report does note the concern that not all schools may have adequate recording equipment and that the option would create more work for some band directors.

Currently audition judges are paid a flat fee of \$1,500. Bowman suggested changing that fee to \$10 per audition. With approximately 650 auditions that cost would be \$6,500 annually.

The second option Bowman gave the board was for live recordings of all auditions on Jan. 25, 2025. The chairs of the eight music regions would be tasked with selecting host sites, scheduling audition times and hiring proctors to do the recordings.

In the second option, Bowman proposed purchasing video recorders for each region as well as two SD cards for each recording device. This would result in one-time costs to the association of \$9,500 for recorders and \$1,520 for SD cards. Bowman estimates that hiring proctors would cost \$4,600 per year as well as the \$6,500 cost for hiring judges. Region chairs would be paid \$200 each.

While weather could still play a factor, Bowman's report said the second option addresses the equity of having all students make their recordings on the same day. There could be concerns about mechanical or technical issues with the recorders.

Swartos said that the association is more concerned with safety and equity than it is with costs. Currently the association budgets \$25,000 for All-State Band auditions. Because of the inclement weather this January, the association spent about \$7,000 on the auditions. Bowman said about \$1,000 of that amount came from hotel rooms that he could not cancel.

Asked by the board which option he preferred, Bowman chose the first. "If we do recorded auditions, we don't have to worry about kids traveling in bad weather," Bowman said.

A vote to accept the first option resulted in a 4-4 tie with one board member missing. Four band directors were in the audience. When asked to pick their favorite option, that vote resulted in a 2-2 tie.

On a 7-1 vote, the board decided to have SDHSAA staff and high school band directors meet to work out a solution. The board will make a decision about how to conduct All-State Band auditions at a special meeting in late August or early September.

## Strengthening Service

### BIG Update

Only 32% of current military families would recommend that a family member or friend join the military. Unfortunately, our servicemembers' quality of life has declined, causing low morale and stress. The annual defense bill also strengthens our national security by deterring China, defending Israel, and securing our southern border. It also included two of my policies to crack down on China and safeguard our supply chains. One provision would investigate China's unfair pricing in global shipping markets and the other works to counter China's monopoly of shipping container production.

A fair and functioning supply chain is necessary to ensure our national defense, both within our country and globally. These provisions will strengthen America on the world stage and stifle China's agenda.

### BIG Idea

When you think of public transit, you typically think of trains or buses in bigger cities. However, the services that rural transit providers offer are used heavily by older or disabled individuals, helping folks get to and from medical appointments and errands. I spoke with a panel of transportation leaders on what challenges rural providers face and how to ensure rural South Dakotans have access to these necessary services.

### BIG News

The aviation industry is flying towards a more sustainable future. From sustainable aviation fuel to Advanced Air Mobility and hydrogen aviation, there are a lot of new technologies emerging that will improve air travel. I launched the Congressional Sustainable Aviation Caucus with Representative Sharice Davids to facilitate conversations between members and industry leaders regarding fuel supply resiliency, new innovations, and national security.

## 100 Years Ago This Month

The month of June has been home to many historical events over the years. Here's a look at some that helped to shape the world in June 1924.

- Austrian Chancellor Ignaz Seipel is shot by a disgruntled worker on June 1. Seipel survives after a bullet is extracted from his lung.

- The Chicago radio station WDAP is rechristened "WGN" on June 1 after it is purchased by the Chicago Tribune. The station's new moniker refers to the newspaper's slogan, "World's Greatest Newspaper." Both the WGN station and a television station of the same name continue to be operated out of

Chicago today.

- The Indian Citizenship Act is signed into law on June 2 in the United States. The law recognizes all Native Americans who had been born in the United States or its territories as U.S. citizens.

- Influential novelist Franz Kafka dies in Austria on June 3. Kafka, only 40 at the time of his death, suffered from laryngeal tuberculosis and died from starvation after eating became too painful. Kafka, now considered a literary giant of the twentieth century, was a relative unknown at the time of his death.

- The German Reichstag approves the Dawes Plan on June 6. The

plan staggers German reparations payments that were mandated in the aftermath of World War I.

- The United States enacts the Clarke-McNary Act on June 7. The act facilitates the purchase of land to expand the country's National Forest System.

- Geologist and mountaineer Noel Odell watches British mountain climbers George Mallory and Andrew Irvine ascend from their base camp at Mount Everest on June 8. Mallory and Irvine are never again seen alive, and no trace of either man is discovered until 1999, when Mallory's body is discovered at an altitude of more than 26,000 feet.

- Ecuador extends the right to vote to women on June 9, becoming the first country in South America to do so.

- The Newton Gang carries out the largest train robbery in American history on June 12. The gang makes off with more than \$3 million (the equivalent of roughly \$54 million in 2024) after stopping mail train number 57 near Rondout, Illinois.

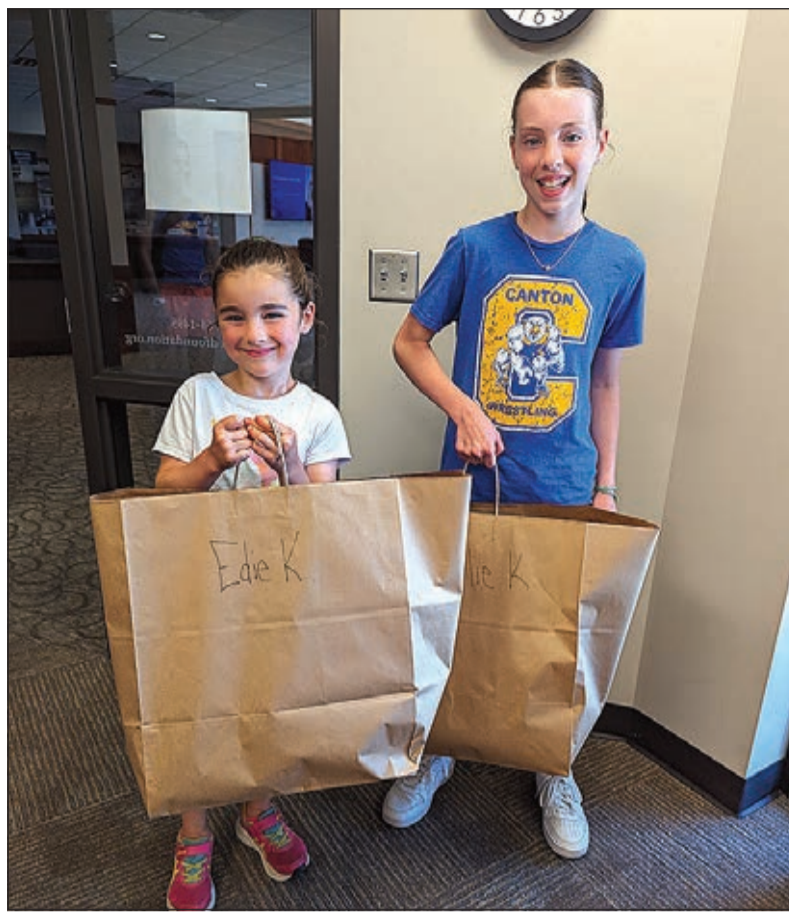

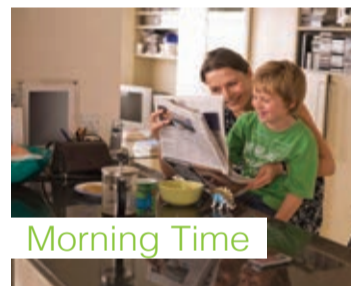
